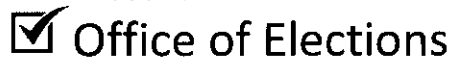

## Meeting of the Clarke County Electoral Board Wednesday, November 9, 2022

The meeting was called to order at 10:30 AM by Chairman Daryl Glenney in 2<sup>nd</sup> floor conference room at 101 Chalmers Court, Berryville Virginia,.

- Other members present: Kelly Johnson, Vice Chair, Carol Westervelt, Secretary, and Barbara Bosserman, General Registrar.
- Mary Ivey was also present as an observer.

The purpose of the meeting was to conduct the canvas of the November 8, 2022 General and Special Election.

- Provisional ballots were reviewed and set aside for processing on Monday, November 14, 2022 after the deadline to receive absentee ballots. Most of them dealt with Same Day Registration.

- Mary Ivey was also present as an observer.

The Statement of Results for Post Election Absentee Ballots was reviewed and accepted.

Fifty provisional ballots were cast. Six were rejected either because of an incomplete application or wrong precinct. There was one ballot in which the oval was not filled in but was "checked." It was clear which candidate the voter wanted to vote for. In lieu of having to hand count that one ballot, the board unanimously approved of filling in the oval and scan the ballot through the machine.
