Date: February 8, 2023

Real Estate:

1st Half Billing: 2023 Real Estate Book value-we have the preliminary book net value, \$2.51 billion (there are a couple adjustments being made right now which will increase this number some)

2nd Half Billing: We are estimating the 2024 Real Estate Book value increase of \$10 million over 2023 (this is low but we can discuss)

Nancy will have her updated model to go through at the meeting.

<u>Public Service Corporation Real Property Tax: 61 cents per \$100</u>: Assessed by state, includes electric, phone, gas, railroad-numbers provided by SCC except for railroad. We used FY 23 actual because historically full amount is received in first half of the year.

<u>Personal Property: \$4.496 per \$100</u>: We have requested updated NADA book values, we hope to have those numbers by the end of this week or early next week. The new Avenity tax software system will provide us real time assessment data going forward (starting next year) so we will no longer have to send our data to NADA and wait for it to be returned. Localities are reporting mixed numbers about used vehicle values.

<u>Machine and Tools</u>, \$1.25 per \$100 value: Forms are due February 15th, using FY 23 projection at this point but may be able to update this number next week.

<u>Penalties & Interest-All Property Taxes</u>: Penalties and interest collected on past due taxes, Treasurer has noted many outstanding balances will be resolved in FY 23 so we don't expect FY 24 to be as high.

Admin Costs Deling Taxes: Same as above.

DMV Stops: We use this to pay DMV stops, money in, money out.

<u>Credit Card Fees: Mostly money in, money out, but we do keep a small percentage.</u>

<u>State Sales Tax</u>: This revenue continues to grow. It is a percentage of sales so it has increased as the price of goods has increased. We projected a lower number for FY 24 versus our expectation for FY 23, in case the economy slows or the price of goods drops.

<u>Consumption Utility Tax Elect and Gas</u>: As would be expected, the winter months result in higher collections. We used the FY 22 actual to be safe.

<u>Consumption Tax</u>: Also electric, also lags and also will get bigger because of cold, used FY 22 actual.

<u>Business License</u>: \$30, collected in beginning of the year, due date pushed back in order to follow state code.

<u>Motor Vehicle License</u>: Decal fee \$25, only collected in June. Projected a little less than FY 22 actual to be safe.

<u>Recordation Tax</u>: Percentage of real estate closings, prices up but real estate closings slowed dramatically in the fall when interest rates increased. We have dramatically scaled back our FY 23 projection and used the same number for FY 24. Hopefully a strong spring real estate market will outperform our projections.

<u>Tax on Wills</u>: Projection and Actual for FY 23 is up, slightly increased the FY 22 Actual.

<u>Transient Occupancy Tax</u>: Increased rate from 3.5% to 5% on January 1, 2023 so numbers have been adjusted to reflect full year of new tax rate but no growth.

<u>Cigarette</u>: Tax increased from 20 cents per pack to 40 cents per pack on January 1, 2023, projections assume no growth but reflect full year of new tax rate.

<u>Meals</u>: Tax increased from 2% to 4% on January 1, 2023, projections assume no growth but reflect full year of new tax rate.

<u>Animal Licenses/Shelter Fees/Dangerous Dog</u>: Looked at FY 22 Actual and FY 23 Projections.

Land Use Application Penalty: \$100 per parcel if miss November 1st deadline to file

Land Use Application Fee: Pay \$25 every six years, FY 23 was a renewal year

Zoning Fees: Difficult to predict, a fair amount of activity in FY 23 but used FY 22 actual

<u>Building Permits</u>: Permits in FY 23 have slowed dramatically compared to FY 22, we have reduced FY 23 projection and used much lower number for FY 24 compared to FY 22 actual.

Weapon Permits: FY 23 looks stronger than FY 22 but projection is closer to FY 22 Actual.

New Dwelling Address Fee: \$100, using FY 23 budget which is lower than FY 22 Actual.

<u>Court Fines & Forfeitures</u>: FY 23 looking stronger than FY 22, additional staffing in Sheriff's Office should be making an impact soon.

<u>Parking Fines</u>: Used FY 23 budget number.

Courthouse Maintenance Fee: Increased from \$10 to \$20 in July 2020, related to previous item

<u>Interest on Bank Deposits</u>: Interest rates have significantly improved.

Rental of General Property: Dunn and Historical Association, depreciation funded by state for social services building ends in January of 2024.

Wireless E-911: FY 23 Projections tracking lower than FY 22 Actual

<u>Ambulance and Rescue Services</u>: FY 24 projection is lower than FY 22 Actual and FY 23 projection so feel pretty safe with number.

Humane Foundation Contribution: Adding \$5k per recent discussions.

Recycling Rebate: Our portion of regional landfill recycling sales

Recreation (Pool, Programs, Facility Rentals) Fees: Input from Lisa

Payment in Lieu of Taxes: Hecate and Georgetown per schedules

<u>Econ Development Misc Revenue</u>: Agreement with town does not specify an amount for FY 24, MOU Committee suggested a \$1k increase, not sure what Town will do.
