5) VDOT Update

Residency Administrator Ed Carter provided the following update on VDOT maintenance activities this month:

- Completed brush cutting and brush removal on Shepherds Mill Road and Wrights Road.
- Continuing additional trimming and brush removal on various roads.
- Continuing to fill potholes on various routes.
- Mobilized for two weather events.
- Will perform ditching operations on Good Shepherd Road.
- Continuing shoulder repairs on Route 7.

Ed Carter provided the following update on Board issues:

- Draft report on the traffic study is ready to present to the Board and citizens of Millwood; would like to schedule a community meeting before the end of January.
- Traffic Engineering is starting a new evaluation of signal warrants at Route 340/723 in Boyce.
- Working through the permit process with the railroad for drainage pipe repairs in Boyce.
- Contractor is working on repairs at Morgan Mill Road.
- Traffic Engineering is evaluating signal timing at Route 7 and Crums Church Road, as the Board requested.

Supervisor McKay

- Shared citizen complaints that steady truck traffic is tearing up the shoulders on Gun Barrel Lane and asked if there was anything to be done about the excessive dust.
 - Ed Carter advised that Wayne Tapscott will examine the area and that he has contacted land use and permitting to see if a commercial entrance permit will be required for that location.
- Further shared that the same thing is happening in White Post and that addressing the many truckloads of fill dirt being brought in from other counties is one of the Board's current legislative priorities.

Vice Chair Catlett

- Advised that citizens report a lot of debris from the ice storm remaining on Route 601.
 - Ed Carter replied that it would be addressed.

Chairman Weiss

Requested a general synopsis of the Millwood traffic report.

 Ed Carter responded that he has not had enough time to absorb the material yet. One of the biggest issues is pedestrian access and the only thing VDOT is able to do about that is to protect the existing crosswalks.

AGREEMENT BETWEEN THE VIRGINIA DEPARTMENT OF HEALTH AND THE CLARKE COUNTY BOARD OF SUPERVISORS FOR FUNDING AND SERVICES OF THE CLARKE COUNTY HEALTH DEPARTMENT

This agreement ("Agreement") for the services to be provided by the Clarke County Health Department and the funding therefore is by and between the Virginia Department of Health ("VDH") and Clarke County Board of Supervisors (collectively "the Parties").

The Agreement is created in satisfaction of the requirements of § 32.1-31 of the Code of Virginia (1950), as amended, in order to operate the Clarke County Health Department under the terms of this Agreement.

NOW, THEREFORE, in consideration of the covenants and agreements in this Agreement, the sufficiency of which is acknowledged, the Parties agree as follows.

§ 1. VDH, over the course of one fiscal year, will pay an amount not to exceed \$374,576.00, from the state general fund to support the cooperative budget in accordance with, and dependent upon, appropriations by the General Assembly, and in like time frame, the Board of Supervisors of Clarke County will provide by appropriation and in equal quarterly payments a sum of \$188,642.00 local matching funds and \$5,000.00 one-hundred percent local funds for a total of \$193,642.00 local funds for this fiscal year.

In addition, the Board of Supervisors has approved the Clarke County Health Department to carry forward \$96,293.00 in local matching funds for a total of \$284,935.00 matching funds and an additional \$43,716.80 in one-hundred percent local funds from the prior fiscal year closing locality balance.

These joint funds will be distributed in timely installments, as services are rendered in the operation of the Clarke County Health Department, which shall perform public health services in Clarke County as indicated in Attachment A(1.), and will perform services required by local ordinances as indicated in Attachment A(2.). Payments from the local government are due on the third Monday of each fiscal quarter.

- § 2. The term of the agreement begins July 1,2023. This Agreement will be automatically extended on a state fiscal year to year renewal basis under the existing terms and conditions of the Agreement unless timely written notice of termination is provided by either party. Such written notice shall be given at least 60 days prior to the beginning of the fiscal year in which the termination is to be effective.
- § 3. The Commonwealth of Virginia ("Commonwealth") and VDH shall be responsible for providing liability insurance coverage and will provide legal defense for state employees of the local health department for acts or occurrences arising from performance of activities conducted pursuant to state statutes and regulations.
 - A. The responsibility of the Commonwealth and VDH to provide liability insurance coverage shall be limited to and governed by the Commonwealth of Virginia Public Liability Risk Management Plan, established under § 2.2-1837 of the Code of Virginia (1950), as amended. Such insurance coverage shall extend to the services specified in Attachments A(1.) and A(2.), unless the locality has opted to provide coverage for the employee under the Public Officials Liability Self-Insurance Plan, established under § 2.2-1839 of the Code of Virginia (1950), as amended, or under a policy procured by the locality.
 - B. The Commonwealth and VDH will be responsible for providing legal defense for those acts or occurrences arising from the performance of those services listed in Attachment A(1.), conducted in the performance of this contract, as provided for under the Code of Virginia and as provided for under the terms and conditions of the Commonwealth of Virginia Public Liability Risk Management Plan.

- C. Services listed in Attachment A(2.), any services performed pursuant to a local ordinance, and any services authorized solely by Title 15.2 of the Code of Virginia (1950), as amended, when performed by a state employee, are herewith expressly exempted from any requirements of legal defense or representation by the Attorney General or the Commonwealth. For purposes of assuring the eligibility of a state employee performing such services for liability coverage under the Commonwealth of Virginia Public Liability Risk Management Plan, the Attorney General has approved, pursuant to § 2.2-507 of the Code of Virginia (1950), as amended, and the Commonwealth of Virginia Public Liability Risk Management Plan, the legal representation of said employee by the city or county attorney, and, the Board of Supervisors of Clarke County hereby expressly agrees to provide the legal defense or representation at its sole expense in such cases by its local attorney.
- In no event shall the Commonwealth or VDH be responsible for providing legal defense or insurance coverage for local government employees.
- § 4. Title to equipment purchased with funds appropriated by the local government and transferred to the Commonwealth, either as match for state dollars or as a purchase under appropriated funds expressly allocated to support the activities of the local health department, will be retained by the Commonwealth and will be entered into the Virginia Fixed Asset Accounting and Control System. Local appropriations for equipment to be locally owned and controlled should not be remitted to the Commonwealth, and the local government's procurement procedures shall apply in the purchase. The locality assumes the responsibility to maintain the equipment and all records thereon.
- § 5. This Agreement may only be amended or otherwise modified by an instrument in writing signed by the Parties.

Local health department staff is also responsible for issuing, denying and revoking construction and operation permits for conventional and alternative onsite sewage systems. Local health department staff are responsible for assuring that onsite sewage systems are inspected at time of construction for compliance with the Sewage Handling and Disposal Regulations (12VAC5-610-20 et seq.; "SHDR") and the Alternative Onsite Sewage System Regulations (12VAC5-613-10 et seq.; "AOSS Regulations"); local health department staff may perform such inspections as required. Local health department staff is also responsible for assuring the performance, operation, and maintenance of onsite sewage systems are in compliance with the SHDR and AOSS Regulations. 

- The County was notified this month that another opioid manufacturer has settled with the Commonwealth. We haven't received any expected payment information but the first payment could be made before the end of the month. I have heard there are some other manufacturers getting close to also settling. We had an initial conversation with Northwestern Community Services and Social Services on these funds. We also need to engage other localities to look at regional opportunities.
- Thanks to Jeff Feaga for working to get Clarke County \$4,815 from the Virginia Department of Forestry Forest Sustainability Grant program. We have some ideas we will present to the Finance Committee in February on the expenditure of these funds. These funds are to be used for public education or for projects related to outdoor recreation or forest conservation. Mr. Feaga provided his resignation notice today, he will be taking a job which allows him to be home with his kids more. He has done a great job and we will miss him.
- As a reminder, the budget process is in full swing. The Finance Committee met with the School Finance Committee last week, department budgets were due this past Friday, and staff will begin pulling revenue information in the next couple weeks. Most of the heavy lifting for the Finance Committee occurs in February and the full board is scheduled to authorize public hearing at your March 21st meeting.
- I would like to thank Indea Ford for doing a great job getting the Board packet put together while Catherine was out last week and to Cathy Kuehner for all of her work on the Berryville 225th anniversary programming.
- The pedestrian bridge study over Route 7 is close to being completed. We will provide it to the Board as soon as we receive it and the Board can decide whether they want the information presented at a future work session. The storm water repair work on Jack Enders Blvd could start as soon as January 23rd. Paving will be scheduled this spring following the storm water repairs.

- Are trying to collect on delinquent taxes.
- Also working on pipe under railroad and waiting for the new signal warrants study.
- Sanitary Authority
 - Nominated and elected Rod DeArment as Chairman, Wayne Armbrust as Vice Chair, Tom Bauhan as Treasurer, and Brenda Bennett as Assistant Treasurer.
 - Provided the Board the following update on challenges with Locke Store in Millwood:
 - Issues date back to 2021, when materials were found to be getting into the wet well and resulted in the Authority having to replace six grinder pumps.
 - In early 2022, grease levels began exceeding the Sanitary Authority standards, which are 100mg per liter. At one point, Locke Store's grease levels were 173 times the allowable limit.
 - They have failed to provide inspection reports as requested and have backed out from attending Sanitary Authority meetings at the last minute.
 - In accordance with Sanitary Authority regulations, fines have been imposed for the repeated violations. A payment schedule was developed to allow them to make payments over a number of months.
 - The first scheduled \$8,000 payment was due in October and the check was returned for insufficient funds. The same happened

with the payment due in November. The Authority did finally receive payment for October and November.

- The December payment was due on 12/15 and was not paid until January. The January payment is due 1/17 and has not been paid. The total fines are \$48,000.
- The fine money received is being set aside to cover any necessary repairs to the Sanitary Authority system downstream. The amount of time staff and Sanitary Authority board members have spent on this issues has been tremendous.
- Grease coats the wet well and the main sewer line going to the plant, making it harder to pump effluent through the line and jeopardizing the entire system.
- The Sanitary Authority urged the business owner to close the store until a new grease interceptor system was installed and issues resolved, but he chose not to do so.
- The Authority made the business owner aware that if the store failed another grease test, the \$16,000 fine would double to \$32,000. The business owner elected to keep the store open and subsequently failed the grease test again.

- Sub-area B is the 65 acres along Route 340 that is currently owned by the Virginia Port Authority and designated by the Virginia General Assembly for economic development purposes.
- Sub-area C is the balance of the former Camp 7 property containing three parcels owned by VDOT, the Department of Corrections, and the Virginia Department of Military Affairs.
- The two new sub-areas (B & C) would contain recommendations by which potential re-zoning to Highway Commercial would be acceptable.
- The Planning Commission held a public hearing on this plan at the end of last year and no citizens appeared to speak for or against the plan.
