# 1) Call to Order

Chairman Weiss called the meeting to order at 1:02 pm.

# 2) Adoption of Agenda

Switch Item 3 and Item 5, due to a VDOT scheduling conflict.

# Supervisor Lawrence moved to adopt the agenda as amended. The motion carried by the following vote:

Supervisor McKay entered the meeting at 1:03 pm.

# 3) VDOT Update

Residency Administrator Ed Carter provided the following update on VDOT maintenance activities this month:

- Began brush-cutting operations on Bishop Meade Road and will continue on various other routes.
- Performed shoulder repairs on Route 7 and will continue.
- Cleaned pipes on Morgan Mill and Ebenezer Roads.
- Conducted litter pick-up on primary routes.
- Will conduct ditching operations on Good Shepherd Road.
- Continuing debris pickup from previous storms, mostly along Route 601 where there is a tremendous amount to clean up.
- Repaired potholes as they have been reported and will continue.
- Mobilized for several weather events.

Ed Carter provided the following update on Board issues:

- Met with the citizens in the Millwood community to discuss traffic concerns and present a draft report. Citizens could submit written comments until February 10; Traffic Engineering is evaluating those comments.
- Traffic Engineering has completed collecting new data for re-evaluating signal warrants at the intersection of Route 340 & Route 723. A report is expected in the next thirty days. The District Traffic Engineer will meet with Boyce Town Council on February 28.
- The contractor has completed repairs on Morgan Mill Road. There is still more work to do, but the biggest concern has been addressed.
- Still awaiting a permit from the railroad to excavate the broken pipe in Boyce.
- Traffic Engineering is working to adjust signal timings at Route 7 and Crums Church Road.

# Vice Chair Catlett

Thanked Mr. Carter and VDOT for presenting the study results in Millwood.

#### Supervisor Lawrence

 Suggested that the underground piping on Old Charlestown Road between Longmarsh and the West Virginia line be dug up and replaced prior to repaving. The current piping is too small to prevent flooding during rain events.

# **Chairman Weiss**

- Inquired about line painting at the intersection of Route 340 and Fairfax Street.
  - Ed Carter replied that painting can begin after VDOT is done treating the roads with salt for the season. The Berryville and Boyce areas will be the first to be done as soon as the weather permits.
- Further advised that the historical marker at Bristow has still not been moved.

# 4) Citizen's Comment Period

# **Candy Means**

I am not here to make a complaint, I am asking for a point of information. Considering the train derailment in Ohio, what emergency plans do we have here in Berryville? Not for the issue that they stop and block traffic forever; but should we have a spill, is there a plan? If there is one, I think it should be made public so that the public can be aware of what that plan is and feel comfortable that there is one.

In an even bigger picture—and this really isn't your job, but—I think the whole issue of trains anywhere carrying these kinds of poisons need to be prevented. They need

to find something else that can replace them instead of carrying all of these hazardous things around the country.

# **Chairman Weiss**

Thanked Ms. Means for her comments and invited the County Administrator, Chris Boies, to comment briefly in response.

#### **Chris Boies**

Advised that the county has a broad emergency operations plan, which would address any natural or man-made disaster. There are also specific plans for railroads. Immediately, we would contact the railroad to stop all traffic and start helping those who are injured. In the event of a spill, we would likely bring in state resources. There are hazmat teams at Mount Weather and in Frederick County who would assist. Additionally, the Virginia Department of Emergency Management would come with their folks. They have vendors for cleanup that have already been procured and would be able to respond promptly.

# **Brian Legge**

Thank you for hearing me. I built a garage at my house that I am sure everyone here knows about. I am asking, because of my health and the financial burden it has created, because I am fighting stage three stomach cancer that has moved to my prostate.

I am asking for more time on my garage, to get it resolved. That is all I came down here for.

#### **Chairman Weiss**

Thanked Mr. Legge for providing comment and stated that, as the matter is within the courts, the Board does not have any leeway at this time.

# 5) Introduction of New Clarke County Sheriff Deputies

Chief Deputy Travis Sumption shared that the Sheriff's Office (CCSO) has faced a lot of turnover in the past year, but is pleased to introduce four employees hired over the past year:

Deputy Justin Calhoun was hired in July and just completed the FTO process.
 Before coming to CCSO, Deputy Calhoun served four years in the Marine Corps.

- Deputy Francis Horner was also hired in July and previously worked as a correctional officer in Fayette County, Kentucky, and spent a summer working on an Alaskan fishing vessel.
- Deputy Joseph Unger is unable to attend today, but was hired in January 2022.
   Deputy Unger is an Eagle Scout, has a four-year degree from Bridgewater College, and was part of the Virginia State Police Junior Law Cadet Program in high school.
- Deputy LaJuan Curry is a graduate of Clarke County High School, where she
  was a star basketball player. Deputy Curry has a four-year degree from
  Shepherd University and previously worked for Clarke County Public Schools.
  She was hired in January 2022 and will take over as School Resource Officer at
  the high school in the fall.
- Ms. Savannah Bryant joined the Sheriff's Office in February 2023 as a Communications Specialist and has studied at Laurel Ridge Community College.

# Chairman Weiss

Shared the Board's appreciation and added that it is good to see new employees hired, given that there are pressures to go elsewhere for higher pay and other issues. The Sheriff and Chief Deputy have created a good department, and Clarke County is a unique and special place.

# 6) Department of Social Services Update

Clarke County Department of Social Services Director Jennifer Parker presented the following:

- The public health emergency is unwinding and will effect DSS operations over the next year.
- SNAP benefits, formerly known as food stamps, were changed temporarily due to Covid-19 in March of 2020. Emergency allotments raised existing monthly benefits for SNAP households to the maximum allowable based on household size rather than income limits.
- The enhanced SNAP emergency allotment benefit was available through the public health emergency and required staff to request an extension of emergency allotment issuance on a month-to-month basis.
- The Consolidated Appropriations Act 2023 recently passed by Congress ends the emergency allotments after the February 2023 issuance. On February 16, the last emergency allotment was issued.
- This will be a huge impact on food money: elderly families who have typically received \$281 per month will now receive \$23 per month. Staff is most

concerned for seniors, as this cut will put them in the position of having to choose between medication and food.

- A household of four making minimum wage will go from receiving \$939 per month to receiving \$490 per month. This is a huge concern, especially given inflation and the cost of food.
- Staff has been working with food partners to keep them updated and ensure that food pantries are prepared for this shift in food assistance.
- DSS continues to be available at Christ Church Pantry on the first Friday of each month, as well as working with FISH at their mobile sites on the fourth Saturday. Starting in April, FISH will also be going to the Good Shepherd Church in Pine Grove on the first Saturday of every month. DSS is also available at FISH in Berryville every Wednesday.
- For Medicaid, staff expects about 20% of the current caseload to lose eligibility. These people will be eligible for the Medicaid appeals process and staff will try connecting them with other resources for medical coverage.
- Sinclair Health Clinic has been working to establish a presence in Clarke County and eliminate the transportation barrier for citizens to access free or reducedcost medical care. Dr. Bishop has been very kind in working with staff on this project and has offered temporary space at Upper Cooley while Sinclair continues to look for permanent space.
- It remains very unclear what resources the state may offer to local staff for support during this unwinding.
- There are discussions of financial support for overtime so staff can process reviews. There are currently 1,329 Medicaid recipients that require full eligibility determinations and need to be reviewed. In addition to regular caseload, staff will need to process one-ninth of those reviews every month, starting in April.

# **Chairman Weiss**

- Asked if advance notice was given to clients regarding the unwinding.
  - O Jennifer Parker replied that, for SNAP benefits, the state intended to give less than thirty days notice, but staff started to work with food partners in January to try to prepare. For two years, staff has been warning clients that the emergency allotment would be ending but did not have a firm cutoff date, which diluted the message over time.

#### Vice Chair Catlett

- Inquired how people could help.
  - Jennifer Parker responded that they could contact Anne Cushman, who directs the food program at FISH, or to Bette Marchese at Christ Church to volunteer. Donations of food and/or cash are always welcome.


# **Supervisor Lawrence**

- Stated that Sinclair Health currently only has one office in Winchester.
  - O Jennifer Parker affirmed and added that offering services in Clarke County will depend on Sinclair's ability to fund the necessary staffing. A large part of their success in the last three years has been the Medicaid dollars they have been able to take in, so the Medicaid reduction will negatively affect their efforts as well.

# Chairman Weiss

- Observed that Clarke County is fortunate to have a good network of private assistance, but this unwinding will tax that considerably.
- 7) Dolly Parton's Imagination Library Presentation

  Andy Gail, Executive Director of Literacy Volunteers Winchester Area presented the following:



- Across the Commonwealth, 17% of adults suffer from a literacy issue.
- About 24.7% in Winchester and 18% in Frederick and Clarke experience literacy difficulty, which could be complete illiteracy or being uncomfortable reading, writing, or using technology. Literacy Volunteers was founded 38 years ago to address that issue for adults.

WHEREAS, the opioid epidemic that has cost thousands of human lives across the country also impacts the Commonwealth of Virginia and its counties and cities, including the County of Clarke, by adversely impacting the delivery of emergency medical, law enforcement, criminal justice, mental health and substance abuse services, and other services by Clarke County's various departments and agencies; and

WHEREAS, the Commonwealth of Virginia and its counties and cities, including Clarke, have been required and will continue to be required to allocate substantial taxpayer dollars, resources, staff energy and time to address the damage the opioid epidemic has caused and continues to cause the citizens of the Commonwealth and Clarke County; and

WHEREAS, settlement proposals have been negotiated that will cause Teva, Allergan, Walmart, Walgreens, and CVS to pay billions of dollars nationwide to resolve opioid-related claims against them; and

WHEREAS, the County has approved and adopted the Virginia Opioid Abatement Fund and Settlement Allocation Memorandum of Understanding (the "Virginia MOU"), and affirms that these pending settlements with Teva, Allergan, Walmart, CVS, and Walgreens shall be considered "Settlements" that are subject to the Virginia MOU, and shall be administered and allocated in the same manner as the opioid settlements entered into previously with opioid distributors McKesson, Cardinal Health, and AmerisourceBergen, and opioid manufacturer Janssen Pharmaceuticals; and

**WHEREAS**, the County Attorney has reviewed the available information about the proposed settlements and has recommended that the County participate in the settlements in order to recover its share of the funds that the settlement would provide;

10) Board of Supervisors Personnel Committee Items from February 13, 2023

# A. Expiration of Term for Appointments Expiring through April 2023

2023-02-13 Summary: Following review, the Personnel Committee took no action.

2023-02-21 Action: Chris Boies reviewed the above summary.

# B. Proposed Pay Scale Adjustment

2023-02-13 Summary: Following review, the Personnel Committee recommends that the minimum, midpoint, and maximum salaries for each grade on the Clarke County General Government Classification Listing be increased by ten percent, effective July 1, 2023.

2023-02-21 Action: Chris Boies reviewed the above summary.

- In 2014, an extensive salary study was done for all county positions. The resulting salary scale was adopted and it has not been changed since then.
- Because the minimum pay has not increased at all, starting pay for employees is not as competitive as the county would like. Two specific areas of concern are Sheriff Deputies and Communications staff.

- If the county gave a 5% raise in the upcoming fiscal year, only 11 employees would require salary increases to meet the proposed new minimums. That salary cost is about \$22,000.
- If the Board endorses this salary scale adjustment, it would become a budget request and need to be adopted as part of the budget.

# **Supervisor Bass**

 Stated that turnover in the Sheriff's Office is a big issue and opined that this adjustment would allow the county to offer more competitive salaries and could result in less turnover and more consistency.

# Supervisor Lawrence

- Asked if increases to the salary scale were discussed when it was originally adopted.
  - Chairman Weiss answered that overall adjustments were not discussed. However, the Board has historically given raises based on the midpoint, which provided a boost to employees who were lower on the scale.

# Vice Chair Catlett

- Inquired about the cost of re-doing the salary scale entirely.
  - Chris Boies responded it would depend on the scope, but would likely cost at least \$50,000.

# Supervisor McKay

- Questioned if the county was able to recoup the cost of sending a deputy through the academy if that deputy leaves shortly after.
  - Chief Deputy Sumption replied that the Sheriff's Office has recently implemented this change. Deputies who leave within two years must pay a pro-rated amount.

# **Chairman Weiss**

 Clarified that this is not a ten percent raise for employees, this is only raises the stated salary scale amounts.





2023-02-13 Summary: At 9:58 am, Chairman Weiss called the meeting to order.

A. Online RME Presentation/Septic Providers Outreach: Alison Teetor presented the Board a status update on the septic information database project, discussed the data entry requirements, and gave a demonstration.







- Goal 1, Objective 1 Strategy a: Implement regular maintenance, monitoring, and reporting of all septic system components.
- Included in the maintenance is a regular pump-out schedule as recommended by the Virginia Department of Health (VDH).
- Utilize VDH staffing resources to ensure annual operation and maintenance inspections of alternative septic systems and identification of substandard systems. Provide County funding if necessary to ensure VDH resources remain available and capable to manage this program.

# **Background**

- October 21, 2021 Board of Supervisors worksession
  - staff presented results of an initiative to encourage voluntary septic pumpout (maintenance).
  - Results identified the need to develop an accurate, accessible database
    - Currently septic data is available from the Health Department as needed
    - all file records through 2018 have been scanned (pdf's) and can be requested by tax map#.
    - data cannot be searched
    - No statistics on type of system, maintenance or any other information
    - HD has no plans to provide public access
  - onlineRME database was selected as the best platform for County septic data
  - RME stands for Responsible Management Entity
  - RME has to be populated by hand as there is no way to import from VDH
  - Board approved funding for part-time staff to populate RME database from existing Health Department scanned records

# **OnlineRME**

- Loudoun County uses this to track system components, maintenance, pumpouts, and all other aspects of septic systems in Loudoun.
- This program is accessible to the public, Health Department, and anyone wanting to know about the septic system on a particular property. They have also linked the data to their online GIS.
- A database such as this is critical in order to effectively manage and understand onsite septic systems in the County.
- This will be particularly important for regulating AirBNB's.
- Effective tool as properties change hands particularly with alternative systems
- Non-proprietary but charge \$3.30/inspection or pumpout record entered
- A demonstration of the Loudoun and Clarke systems follows this summary




- The Board approved 400 hours for FY23 to begin data entry.
- Transferred all CAMA data to onlineRME to establish parcel records
- Established online access to Health Department scanned records.
- Met with Loudoun County personnel to get a demonstration of their system.
- Working with the HD personnel, it was agreed they would enter the alternative system data, Ms. Teetor will enter conventional system permits.
- Data entry initiated in mid-July.
- Data entry manually populating the onlineRME database with the septic size, components, date when the system was installed and uploading permit records from the Health Department scanned records.


# Estimated # of systems

- Estimated number of septic systems 5,000
  - Based on number of addressed structures not on public sewer
  - Roughly 350 or 7% are alternative systems, these include some but potentially not all, Low Pressure Distribution Systems (LPDs) based on Health Department data.
  - Use of LPDs was discontinued in 2011.


# Data entry summary July 1, 2022 – December 31, 2022

B. <u>CEA Policy: Building Envelopes/Impervious Surfaces/Large Agricultural Building</u>: Alison Teetor presented the proposed building envelope policy recommended by the Conservation Easement Authority.



# **Current policy**

- Building envelopes not required by the CEA, but have been required on all NRCS funded easements, voluntarily as requested by the landowner, or in some cases requested by the Authority
- ▶ Impervious surface limits policy adopted in 2016 places limits based on acreage increments somewhat arbitrary and range from about 2.3% on properties less than 15 acres to 1% impervious surface on properties 55 acres and greater

# **Current Policy - Deed Restrictions**

- Large structures in general, any new structure over 4,500 sq ft requires approval from the Authority approval shall be limited to consideration of the impact of the size, height, and siting
- The collective footprint of all buildings and structures on the Property, including paved parking areas but excluding roads, shall not exceed 1% of the total area of the Property without approval of the Authority

# Why is a new policy being considered?

- To better protect the conservation and open-space values of the easement
- ➤ The IRS may not approve tax credits for easement donations without building envelopes and impervious surface limitations written into the deed of easement because:
  - building envelopes prevent the random placement of structures throughout an eased property which could impact conservation values.
  - limits to impervious surfaces prevent excess runoff during storm events and retain open space.
- Mr. Mitchell provided an opinion stating that he finds the requirement of building envelopes on all conservation easements to be advisable because of the IRS requirements

# Why is a new policy being considered? (Continued)


- ▶ Not new impervious surface limitations are in every recorded deed, building envelopes have been required on all Federally funded easements (NRCS- ALE, FRPP)
- ▶ Most if not all Land Trusts require building envelopes and impervious surface limitations

# **Overview of New Policy**

- An updated policy has been proposed to:
  - inform landowners considering placing their property in an easement with the CFA
  - describe the types of resources the CEA strives to protect
  - describe the potential restrictions considered necessary to protect these resources
- ▶ Each property will be considered on a case-by-case basis
- ▶ Staff will use these guidelines to work with landowners in developing building envelope size(s) and location(s)

#### Definition

- "Building Envelope(s)" areas depicted on a map, attached to the deed
  of easement which contains new structures for residential or agricultural
  use.
- "Structures permitted outside of building envelopes" Run in sheds, loafing sheds, open sided hay sheds, and other similar small structures utilized for agriculture may be located outside the Building Envelope provided that:
  - each singular Structure shall not exceed a footprint of 500 square feet and is not a dwelling;
  - (ii) the Structures and their location shall not materially and adversely affect the Conservation Purposes and Conservation Attributes;
  - (iii) structures shall not be located in any setback area or defined viewshed easement, and
  - (iv) the Structures shall be consistent with the allowances and limitations of deed template

# **Envelope Acreage Example Calculation:**

A landowner wants to put a 220 acre parcel into an easement. The size of the parcel allows for 3 envelopes. How many acres are permitted in total (to be distributed among the 3 envelopes)?

permitted acreage = 0.05 x 220 acres + 2.5 acres =



# **Policy Application**


- Individual envelope size is ideally ≤ 5 acres
- Landowners will be encouraged to have smaller envelopes where possible
- When needed, an individual envelope can be larger than 5 acres
- Allow for multiple envelopes and not use all of them rather than to move envelopes after the easement is written.
- Case-by-Case basis the number of building envelopes may need to be increased to match the number of DURs retained on the eased property.


# Impervious surface



43,560 sq . ft. = 1 acre

- Landowners will be encouraged to write easement terms that voluntarily limit
  the amount of impervious surface below these limits.
- The CEA will consider requests to exceed these limits on a case-by-case basis.
- This policy takes into account that the potential number of structures needed for a small farming operation may be similar to those on larger parcels.





includes measurements to envelope boundaries, property lines, well(s) and septic system(s). This site plan may be prepared by the landowner and does not need to be surveyed or engineered.

This week REC started installing trees and many more plants will be added over the next couple of months. This will be a pollinator garden and REC is interested in collaborating with the schools to promote the educational component of this project. A ribbon-cutting type of event will occur in the spring with the Board invited.

# Vice Chair Catlett

 Thanked REC and shared that a citizen has already contacted her to compliment the garden.

#### Chris Boies continued the update:

- Thanks to Jennifer Parker with Social Services and all of the non-profits that participated in the Citizen's Academy session on Friday. The public may not be aware that the Clarke County Community Service Council exists. This group is comprised of different non-profits in the county who meet every other month to better communicate and coordinate their efforts in serving the community. - Some work has been completed on the Jack Enders Boulevard storm water piping; we hope to get an update from the contractor this week on the remaining work.
- I would like to thank Mickey Powell and Cathy Kuehner for the recent coverage concerning our new animal shelter manager.
- I also want to thank our entire county team. We have a number of employees dealing with family members who are ill and everyone has stepped up to help while these folks are where they should be during this time, caring for their family. I am proud to work with such great employees.



## Vice Chair Catlett

- Asked what citizens should expect to see as the project continues.
  - Kyle Rosner responded that there will be a lot of activity in the county over the next three years. A lot of the work will involve utilities, so residents should expect to see utility crews and the like.

## Supervisor Bass

- Shared that other internet providers in the county are mounting aggressive marketing campaigns and questioned why residents should wait for All Points rather than using a company who claims to be able to connect more quickly.
  - O Kyle Rosner answered that the majority of people in the area have no access to broadband service, so using another broadband provider is not an option for them. Using an incumbent provider instead is a choice left to individual households, so it will be on All Points to convince them. All Points will be competitively priced and offers fiber to the home, which is a more robust connection than cable.

## **Chairman Weiss**

- Asked how privately owned utility poles, such as those that carry electric service to a farm tenant house, would be handled.
  - Kyle Rosner answered that these poles could be used, but would be treated as service poles and the installation fee would apply to bring the connection to the nearest terminal.

## **Supervisor Lawrence**

- Requested a definition for "substantial completion".
  - Kyle Rosner responded that substantial completion would mean that all the necessary fiber miles would be constructed and the opportunity to receive service is available.

# <u>Unknown Female Speaker</u>

- Inquired if there was any element of the VATI grant requiring All Points
   Broadband to employ a specific percentage of Virginia citizens.
  - Mr. Rosner replied that there is no requirement, but the vast majority of All Points employees are Virginia residents and the company is headquartered in Virginia.
- Further questioned if All Points would offer any on-the-job training to allow local people to be employed.
  - Kyle Rosner advised that All Points offers significant on-the-job training, especially for fiber technicians.


