FY2023 Year-to-Date Check Log

- The only expenditures have been Director's fees.
- Insurance is up for renewal soon and will be another expenditure.

FY2023 YTD Budget/Investments Summary

- There are market fluctuations, but any losses and gains are staying consistent with the overall investment philosophy.
- The budget includes a \$15,000 placeholder, which is carried forward.
- Budgeted expenditures are limited to Director's fees, audit and insurance costs, and an annual civic contribution. There have been no legal or advertising costs to date.
- Revenue will continue to shrink as bond balances decrease, making it difficult to maintain a balanced budget unless another bond opportunity comes up.

6. New Business

Felicia Hart announced that scheduled presenter Shaine Coleman was unable to attend this meeting and will present at the April 27 meeting instead. Mr. Coleman is the Transition Coordinator for Special Education and the Work-based Learning Coordinator at Clarke County High School who

arranges job shadowing, direct hiring with local businesses and is working on a new trade school agreement with Blue Ridge Community College.

Economic Development & Tourism Update

Felicia Hart, Director of Economic Development and Tourism, presented the following:

- The recent USDA training was well attended, and an additional 10-15 people followed up afterwards.
- Regarding the possible commercial kitchen opportunity, some of the rules have changed but staff is working directly with a USDA representative. Updates will be provided as they become available.
- Six Clarke County businesses have signed up for one-on-one services with the Laurel Ridge Small Business Development Center. A regional GOVirginia grant will enable these business owners to receive services from preferred providers. This is the second year of this program and it is at capacity.
- Staff will continue to update the citizens on the VATI grant; All Points Broadband will be presenting to the Board of Supervisors in February.
- The LGV Group is building two 60,000 square foot warehouses near the industrial park. The business designs and produces glass for high-rise buildings.
- Weekly meetings continue with Frederick County and the City of Winchester, who are
 also working with the Small Business Development Center and the Top of Virginia
 Regional Chamber. The region is working closely together on projects such as the
 Employer Expo and the talent website.
- The Employer Expo will be held again this year, last year six Clarke County businesses participated.
- Staff recently hosted a get-together for local realtors to discuss Clarke County's needs and properties that are coming available.
- Staff is planning to host field trips for the Virginia Economic Development Partnership (VDEP) to enlighten them as to our local resources.

Director Waite

- Asked if there was any local growth activity associated with Berryville Graphics.
 - o Felicia Hart responded that staff has worked with them on some trainings and connecting them with different employment agencies. Their parent company is located in Germany; they are starting to replace older machinery and invest in their employees.
 - o Chris Boies added that their Berryville location is really a central hub for their operation and they are working to enhance that.

Felicia Hart continued her update:

- Staff continues to make introductions and connections for local companies with immediate hiring needs.
- The Berryville Main Street just elected an entirely new board and staff is working with them on some potential partnership opportunities.
- The Groundhog Day celebration will be held at the Ruritan Fairgrounds on February 2, in partnership with Valley Wildlife Care, Blue Ridge Wildlife Center, and the radio station Shenandoah Country Q102.

- A portion of the ARPA funds will be used on a Love Local campaign: a logo was
 developed and a sticker and other marketing materials will be created. This sticker can
 be placed on any goods that are produced locally.
- Staff is still organizing a Restaurant Week, but a date has not been set at this time.
- ARPA funds will also be used to produce a two-sided map, to aid in giving directions to visitors.
- A workforce-training group was recently hosted at Laurel Ridge. Among EDAs regionally, there are a lot of overlapping projects. There are many opportunities to collaborate with other IDAs/EDAs, if the Board is interested in pursuing them.

Director Waite

 Advised, and Director Preston concurred, that he would be willing to participate with other local EDAs/IDAs, but would like to have goals and objectives clearly articulated before committing.
