# Full-time Deputy Registrar

Staff is requesting the Electoral Board set the number of Full Time Deputy Registrars as "one" to begin July 1, 2023 with the salary equivalent to a Deputy Treasurer as outlined in the most recent Clarke County Government Classification Listing.
