## 1) Call to Order

Chairman Weiss called the meeting to order at 1:02 pm.

Chairman Weiss shared that the entire Board is standing for reelection in November, is proud of what it has accomplished in the last four years, and hopes to garner support from the citizens.

## 3) Citizen's Comment Period

#### <u>Jean Lee</u>

I am here today to speak on behalf of the Millwood Community Association. I am president of the association.

Last August, members of the association began making statements about our concerns regarding the amount of traffic coming through Millwood and the speed of the traffic. By way of context, the MCA was formed 44 years ago in 1979 and one of the first goals was to reduce speeding through the village.

Our current concerns were heard and VDOT was asked to come to a meeting with Millwood residents in October. As a result of that meeting, VDOT agreed to conduct a thorough study of the traffic situation through the village. They published their draft report in January 2023 and held a well-attended community meeting on January 13 where they listened to the comments of the residents. A second meeting, after the release of the final report, was held on April 26, 2023.

The MCA wishes to express our appreciation to the Board of Supervisors for hearing our traffic concerns and advocating for the Millwood community with VDOT. We very

much appreciate the amount of time and skills expended by VDOT on assessing the traffic and pedestrian safety situation in Millwood.

The VDOT reports recommended a few changes to the signage. They recommended considering a rectangular rapid flashing beacon to alert motorists to the crosswalks as well as enlarging the stop sign on 255 southbound and equipping it with flashing lights. The engineers also recommend moving one crosswalk and removing one other.

While we appreciate VDOT's expertise, we are not convinced that these recommendations will provide greater pedestrian safety nor enhance the charm of Millwood. We are asking therefore that these recommendations be deferred before implementation while we work with VDOT and outside consultants to find a solution that best addresses the needs of the village.

We sincerely appreciate the time and attention our concerns have received but we believe that further work needs to be done to meet the overall goals of the village in an effort to truly make it a safer place and at the same time preserve its historical rural charm.

## **Shane Boswell**

I am the parent of a relatively new driver and two elementary school kids that get on the bus at Hawthorne and Route 7. I am here to lodge a two-part protest in regards to VDOT's plan to realign Shepherds Mill to 7 eastbound with a U-turn at Hawthorne.

The first part is that I want to protest Mr. Carter's rejoinder that there will be negative feedback because nobody wants to be inconvenienced in the name of safety. That is flippant and dismissive and a little much. People do not mind being inconvenienced in the name of safety, as long as it is not a half measure. If we are going to take a measure, we need to take a measure. There are a couple different options that VDOT could be exploring.

I recognize that the state and Board have an obligation to spend highway funds in a manner that enhances constituent safety. However, a no left turn off Shepherds only addresses one symptom and merely shifts it farther down the road. Commuters use Shepherds as a cut-through because their phone GPS (Waze, apple maps, google maps) indicates a faster route than going 340. Addressing throughput and average speeds over Shepherds would increase accessibility to a scenic, narrow route, reduce wear and maintenance cost, and improve safety at multiple hot spots, not just Route 7. This could be addressed via traffic calming and additional enforcement on Shepherds.

Barring that common sense approach, creating a U-turn at Hawthorne is an incomplete and dangerous solution. There is less than 750 feet of sight line into eastbound traffic. At 65-70 miles per hour, that is less than six seconds to get pulled

out, across two lanes, get into the right lane and not get rear-ended. We have inclement weather just like everybody else. It is hazardous in the mornings.

Additionally, having Sheriff vehicles sitting in the median incredibly tightens up that crossover there. We love having them there. It asks people to slow down, but they have to park on that asphalt crossover, otherwise their exhaust will set a brush fire in the median. This cuts the 45-foot deep crossover down by the length of the vehicle. This makes it incredibly difficult for cross traffic pulling into Hawthorne. If we add that eastbound U-turn, it will conflict that even further.

My recommendation, if we cannot address traffic on Shepherds, would be to look into shifting that U-turn down to the crossover at Chilly Hollow. Chilly Hollow has a few more homes on it than Hawthorne has on it. Chilly Hollow is also a county road, which is capable of being maintained properly, if additional measures like crossovers and widening of lanes need to be put there. We cannot do that at Hawthorne, because it is a private road. We could look into it. We could work with VDOT and come up with a solution that works for everybody. Chilly Hollow is a wider crossover, it is a deeper crossover, and there are longer eastbound sightlines. There is not a bus stop there where kids are standing at 6:45 and 7:00am.

## Tim Lettie

I would like to echo support for Mr. Boswell's comments and add some of my own. I have been the President of Blue Ridge Estates, the area that would be impacted by the traffic pattern change, for seven or eight years now. We have a community bulletin board where we share ideas and concerns. I have not seen our bulletin board as active as I have in the last five or six weeks, since it has been known about this pattern change.

I don't think anyone is concerned about inconvenience. It is not an inconvenience issue, it is a safety issue. There are 1900 feet between what we used to call "JJ's Corner" and the intersection with 612 and Route 7. That 1900 feet now has to accommodate someone pulling out in a very fast moving environment, moving over a lane and then moving over another very short turn lane to make a U-turn where there are already people pulling out of a neighborhood that is not publicly maintained.

To see it in the Winchester Star—we're sorry that we don't get the news or get a complete story of the discussions that take place here, that's on us—but there is a lot of concern about the safety related to this.

I would like to also point out the radar set up by police. That is a fairly active place to do speed checks. I have had concerns that having radar set up there now is a safety issue, because they block access. But they are doing their job and they are doing a good one because they're trying to slow traffic down. How are they going to do that now in that position when people are fighting in that small space to make a U-turn, to

make a left turn, to come out of the neighborhood and to jockey with the fast cars on Route 7?

I cannot speak for all; we have not had a discussion to have a collaborative, final solution. But, as a neighborhood, the suggestions would be no U-turn in front of our neighborhood. Move it down to Chilly Hollow. Find some way to calm traffic. Prevent someone from using us and a "kicking the can down the road" approach to problem solving. We all acknowledge that it is a dangerous intersection. There has been no pushback that has been dysfunctional. To kick the safety can 300 or 400 yards down the road to us does not seem proper.

<u>John H. Enders Fire Company & Rescue Squad</u> (letter from President Sam Miller read aloud by Chris Boies)

On behalf of the John H. Enders Fire & Rescue Company, we would like to thank the County of Clarke for its financial support in our endeavors to provide the residents of Clarke County with Fire and Rescue services.

We are currently working on several major capital improvements within the fire company, including the purchase of new fire apparatus, a new ambulance, and extensive building upgrades and expansion. In addition, there is also the continuous need to replace outdated equipment, as well as investing in life saving technology.

Coupled with the funds received from the County, in addition to our numerous fundraising events, we are able to achieve the goals necessary in providing the citizens of Clarke County with the finest Fire and Rescue services.

In closing the officers and members of the John H. Enders Fire and Rescue Company would like to thank you for your continuous support.

## 4) Employee of the Quarter Award – 1<sup>st</sup> Quarter 2023

Chairman Weiss presented the award to Nancy Warcyzglowa and read aloud the following statement:

Nancy's knowledge, job skills, and positive attitude have quickly made her a huge asset to the Joint Administrative Services Department. Nancy continually goes above and beyond her normal duties, filling in wherever she is needed and always doing so with a smile on her face. Her positive attitude and willingness to teach and help others is constant.

Nancy works with many other county and school employees across several departments and is truly a team player. She brings new ideas and perspective to many

aspects of her job. She is always looking to improve processes and give her best efforts to other employees and citizens of Clarke County.

Nancy has also done a great job filling in for the Director of JAS at various budget meetings this spring. The Board very much appreciates Nancy's participation in the budget process because she brings great financial models and explanations to meetings. She does an outstanding job and is a tribute to everyone that works here.

## 5) VDOT Update

Residency Administrator Ed Carter provided the following update on VDOT maintenance activities this month:

- Completed pipe cleaning/flushing on various routes in the county.
- Completed ditching operations on Featherbed Road.
- Started placing replacement stone on all stabilized roads in the County and will complete this month.
- Performed shoulder repairs on Route 7 business and Senseny Road.
- Began patching operations on Wickliffe Road in preparation for the surface treatment schedule this summer.
- Will continue patching operations on Springsbury Road.
- Will trim trees on Cannon Ball Road this month.
- A contractor collected 1104 bags of trash in the county; over 6500 bags collected in all four counties not including state forces or the interstate.
- The contractor started and completed paving operations on Crums Church and Quarry roads.
- Surface treatment schedule will begin this month on Allen, Lewisville, Clifton, and Wickliffe roads.

Ed Carter provided the following update on Board issues:

- Tentatively scheduled installation of stop signs, pedestrian signs, and markings at the Route 723/340 intersection for June 1, then to remove the flashing lights on June 8.
- Met with the Millwood Community on April 26 to present final traffic study results.

## **Supervisor Lawrence**

 Shared constituent requests to address shoulder erosion at the S-curve on Westwood Road and to replace the rumble strips on Lewisville Road before it intersects with Clifton.  Further advised that the white stop sign stripes are painted so far back that line of sight is ruined at the intersection of Routes 255 & 624 at Route 50 and requested that curve warning signs be placed on Sugar Hill Road near the railroad tracks.

## Vice Chair Catlett

- Requested that the tree-trimming crews trim around the pedestrian signs in Millwood.
  - Ed Carter replied that it is already being addressed and the sign is due to be enlarged.

## Supervisor McKay

Reported that pine tree limbs obstructs the line of sight to the left at the Route
 624 intersection near Long Branch.

## Supervisor Bass

- Shared additional constituent concerns about large truck traffic on Westwood Road.
  - Ed Carter advised that the issue has been submitted to Traffic Engineering, who will run a full review. GPS plays a large part in the issue, so the chances of reducing the truck traffic by restriction is small. Effectiveness of signage depends on the individual truck driver, whether they are paying attention, and if they are able to decipher what the sign is saying.
- Added that, to the extent that perception is reality for constituents who are seeing a lot of large trucks on Westwood Road, a sign may go a long way to assuage concerns.
  - Mr. Carter responded that Traffic Engineering will perform a study and present recommendations but that there is likely not one cure-all solution.

## <u>Chairman Weiss</u>

- Thanked VDOT for completing the painting at Route 340 and Fairfax Street.
  - Ed Carter replied that the eastbound ramp onto Buckmarsh is next on the schedule.
- Requested that the edges of Wickliffe be graveled after surface treatment more expeditiously than the last time it was completed and added that there is also a large dead tree that needs to be taken care of.
  - o Mr. Carter responded that both will be addressed.

#### Chairman Weiss

- Asked what the next step is for Millwood, as far as VDOT is concerned.
  - Ed Carter answered that VDOT has told the Board what is in VDOT's toolbox, now the Board has to tell VDOT which tools to use.

## Supervisor McKay

Suggested deferring action as requested by the Millwood Community.

## **Chairman Weiss**

 Stated that the Millwood Community Association is actively pursuing other options and will need to coordinate with VDOT. The Board encourages both groups to work together and bring forward options at a later date.

## By consensus, the Board decided to defer action on the recommendations made by VDOT in the Millwood traffic study.

Ed Carter introduced Regional Traffic Engineer David Morris, to further discuss the proposed improvements at the intersection of Route 7 and Shepherds Mill Road. Mr. Morris presented the following:

- VDOT has previously made some changes to signage and markings and is now looking at what infrastructure improvements can be made.
- One of the biggest problems is the sight distance, but improving that aspect is a sizable capital project.
- All of the crashes that happen at that intersection happen as vehicles in the crossover at Shepherds Mill road interact with either westbound or eastbound traffic on Route 7.
- From a crash standpoint, the latest data indicates that the intersection of Route 612 and Route 7 is the number 2 intersection in the county in terms of looking at for potential safety improvements. The signalized intersection at Routes 340 and 50 is number one.
- Federal and state safety money presents an opportunity to restrict turns from Shepherds Mill road to go east on Route 7 and instead making those vehicles head west and make a U-turn, in order to reduce the number of crashes at Route 612. Along with that project, the left turn and acceleration lanes at Hawthorne would be extended to facilitate that movement.
- VDOT looked at the traffic volumes over several years. Eastbound traffic on Route 7 and southbound traffic on Route 612 is heavy in the morning, and then it flips in the evening.
- There have been no crashes at the Hawthorne lane intersection in the last 10 years, which indicates that there is good visibility to get across westbound traffic at that location. The data indicates that the intersection at Hawthorne is safer than the intersection at Route 612. The improvement suggestions were made in an effort to fulfill the goals from the 2019 safety study.

## Supervisor Lawrence

- Observed that the Hawthorne lane crossover only gets a small fraction of the crossover traffic that the Shepherds Mill Road crossover gets.
  - David Morris agreed that the crash data needs to be viewed relative to the traffic volume. The space is narrow and there is an elevation

difference between westbound and eastbound lanes, which reduces the options available.

## Chairman Weiss

- Summarized that citizens are concerned that VDOT is asking people to learn new traffic patterns in a high-speed environment and that the deceleration lane will queue up quickly. Eastbound traffic is heavy and is accordion-like by design.
  - David Morris replied that, as an estimate, anywhere from 60 to 90 vehicles an hour would be attempting that maneuver, which amounts to about a car and a half per minute using the crossover.
- Reiterated that, as proposed, vehicles trying to get onto eastbound 7 will be stacked in the left turn lane before the crossover, waiting to make a U-turn. When the crossover and lane fill up, there will still be vehicles coming off Shepherds Mill road who are then unable to get into the crossover. Currently, it is a dangerous situation as vehicles queue up on Shepherds Mill and take their chances to get across. The people who drive it every day cannot compute how these proposed changes will actually improve the safety.
  - Mr. Morris responded that the goal is to reduce the number of crashes at Route 612 and Route 7. This is one concept that scored well in terms of the cost and benefit.

## **Chairman Weiss**

- Questioned if a light could be installed at that intersection.
  - David Morris answered that Route 7 is a major corridor and the intent is to have freely flowing traffic on major corridors. VDOT would have to do a signal warrant analysis and to explore alternative intersection types before putting a signal in.
  - Ed Carter added that it would be hard to meet the warrant requirements for stopping 25,000 cars a day in order to let 1,200 out. At 65 miles per hour or during inclement weather, it would result in a significant amount of rear-end crashes.

## Supervisor Lawrence

- Opined that a traffic signal would create a benefit downstream because it would create periodic gaps in traffic.
  - o Ed Carter advised that, in the future, there will be more alternative intersections and less lights.

#### **Chairman Weiss**

- Suggested moving the U-turn down to Chilly Hollow Road.
  - David Morris answered that it is possible, if it is a better U-turn and can attract vehicles to make a U-turn there rather than at Hawthorne.
     VDOT is willing to work with citizens and maybe do some improvements at Chilly Hollow to facilitate.

 Further observed that vehicles sitting on Route 612 at the intersection sit at a slight incline and, in the winter, drainage issues make that area icy and more dangerous.

## Vice Chair Catlett

- Asked if VDOT was working to change the sight distance.
  - Ed Carter replied that they are, but that will not eliminate all of the problems. VDOT is currently taking measurements of the area to see how much sight distance could be gained. More data is necessary; they need to know actual counts and average speeds of vehicles attempting to make those maneuvers, as well as data for the crossover at Chilly Hollow.
  - Mr. Morris agreed, adding that the safety study laid out a plan to improve the safety in the long-term, but those projects are quite expensive. These current suggestions are more immediate and align better with current budgets.

## **Supervisor Bass**

 Recommended, and Chairman Weiss agreed, holding a roundtable discussion between the citizens and VDOT when more data is available.

## 6) Litter Committee Update & Citizen Award

Chair of the Clarke County Litter Committee, Ashley Harrison, who presented the following:

- The mission of the committee is to educate, inspire, and empower the community to improve the environment through beautification and litter prevention.
- The committee is honored to give the first annual Environmental Advocate Award to Christi McMullen, a citizen whose selfless adventure and continued efforts in glass recycling have fundamentally impacted this wonderful county.

On behalf of the Clarke County Litter Committee, Ms. Harrison presented Ms. McMullen with a framed award.

## **Supervisor Bass**

 Added that Ms. McMullen is very deserving of this recognition, as the volume of glass she has been able to recycle in the county is truly astounding.

#### **Chairman Weiss**

Shared the Board's congratulations and appreciation.


8) Set Public Hearing: Carter Hall Estate LLC Special Use Permit & Site Development Plan




THE REQUEST



#### THE REQUEST

- The Applications (Site Development Plan and Special Use Permit) are a request to operate a Country Inn at Carter Hall pursuant to Section 5.2C of the Clarke County Zoning Ordinance.
- 5.2C of the Clarke County Zoning Ordinance allows Country Inns in the AOC District with approval of a Special Use Permit by the Board of Supervisors after review by the Planning Commission and consideration of several review criteria as listed under Section 6.3.1 of the Clarke County Zoning Ordinance. A site development plan is required for all special uses.
- The Country Inn is proposed to have 12 rooms within existing buildings on the property.
- Improvements to the site include upgrades to the VDOT entrance, as well as minor parking and internal access improvements.
- The existing nonconforming use would remain on the property. (nonprofit Carter Hall Center for Conservation)

## **Supervisor McKay**


- Asked how the nonprofit company (the nonconforming use) would integrate with the Country Inn.
  - Jeremy Camp answered that the nonprofit and the Country Inn are separate uses, each having independent operations and using different buildings on the estate. The Main House is the only building that both entities would use, so some additional terms and conditions were developed to address that.
  - Mr. Camp added that the Country Inn would offer lodging in the buildings marked in green above, the numbers in parentheses indicate the number of rooms for each building.

#### PLANNING COMMISSION REVIEW


The applications submitted by the Applicant underwent a thorough review process by the Planning Commission with multiple public hearings and review by numerous departments and agencies.

There was a large showing of people at the public hearings held by the Planning Commission. Both support and opposition to the applications were received. Noise and compatibility were key issues as they related to the proposed events for the Country Inn. Support was generally in regards to the job creation and tax revenue the use may bring.


The Applicant revised the applications during the review process, thereby eliminating events from the proposed Country Inn use. This generally resolved the major issues and the Planning Commission ultimately issued a recommendation of approval on May 5, 2023 with 17 conditions.





- The nonconforming use (nonprofit company) would not be able to hold events outdoors, and would only be able to hold indoor events in the buildings indicated in condition #5.
- The nonprofit company (nonconforming use) would be allowed to hold events in the Main House, but would be limited to a maximum of 60 people in the building, including staff and guests of the Country Inn.
- The applicant requested to remove condition #8, a prohibition on special events as defined in the Code of Clarke County Chapter 57. The Planning Commission felt it was an important condition to keep, due to concerns heard from the public.

#### STAFF RECOMMENDATION

Staff recommends that the Board of Supervisors <u>schedule a public hearing</u> on these applications at their next available meeting.

The purpose of the initial meeting on May 16th is for the Board to receive and overview of the applications and to schedule a public hearing.

## Supervisor McKay

- Asked how many people would be allowed to stay overnight in the Carriage House.
  - Jeremy Camp responded that the number had not been determined yet, because it will be dictated by the drain field and the Health Department. Lodging in the Carriage House (Building D) is only for the nonprofit company and is not a part of the Country Inn, because they are two separate uses.
- Questioned what the total number of people for both uses would be and how that could impact traffic in Millwood.
  - Mr. Camp replied that, as proposed, the site plan indicates 257 trips per day and currently there are 1900 trips per day on Bishop Meade Road.

## Vice Chair Catlett

- Inquired if the nonconforming use applied to multiple nonprofit organizations.
  - Jeremy Camp answered that one nonprofit has already been approved (Carter Hall Center for Conservation) and it would be the only one allowed to operate. Currently, they can use the existing lodging with no restrictions.

## **Chairman Weiss**

- Requested clarification on the 60-person maximum at the Main House.
  - Jeremy Camp advised that, under normal conditions, the Country Inn would have four rooms with two guests each in the Main House, plus staff. If the nonprofit company (nonconforming use) holds an event in the Main House, the maximum number of people allowed, including staff and guests, would be 60.

Staff introduced the applicants' representative, David Frank of Pennoni Associates, Inc. Mr. Frank presented the following:

- This has been a long process and there have been many amendments to the plans since the original application.
- There have been a variety of opinions on both sides. The applicant has listened to the stakeholders and is pleased with the Planning Commission's outcome.

 One of the goals of the current property owners is to reintegrate Carter Hall into the village of Millwood, and the applicants are very sensitive to traffic concerns.

The traffic issues in Millwood are a result of through traffic and people using it as a cut-through. The amount of traffic generated by the removal of a series of structures from the nonprofit and making them into a Country Inn is not going to generate any more traffic than there was for Project Hope.

## Supervisor McKay

- Opined that the traffic problems in Millwood are generated by weekend activities downtown, where there are a lot of people parked and pedestrians crossing the road.
- Stated that the application (meeting packet page 75) lists "Events Space (Including conferences, meetings, trainings, parties, weddings, galas, music and theater)" as a proposed use.
  - David Frank advised that the Country Inn was originally proposed to hold events and weddings, but that use has been removed. As currently proposed, the Main House would contain a small bar, a place for dining, and a place to gather. All of these uses would be for Country Inn guests only.
  - Jeremy Camp confirmed that the table on page 75 was from the original application and is outdated. The Planning Commission recommended conditions that would prohibit special events or weddings and would prohibit the nonprofit company from holding any events that are not related to the nonprofit.
- Further inquired how many people would be permitted if the nonprofit company hosted a conference in the Administrative Building.
  - O Mr. Frank answered that he does not have that direct information. During its operation, the previous nonprofit (Project Hope) had use of the entire property. As proposed, the Country Inn removes multiple facilities from the nonprofit, thereby reducing the intensity of its use. The applicants believe that the special use permit is critical and is vital for the preservation of Carter Hall in the long term.

#### Chairman Weiss

- Clarified that the nonprofit is a nonconforming use. It existed on the property under rules from before, which are being respected now. While some limitations (as recommended by the Planning Commission) can be added, the Board cannot change the rules that were set previously.
  - O Jeremy Camp affirmed and added that the nonprofit (Carter Hall Center for Conservation) uses the existing facilities to hold events. This use will continue, with the understanding that events must be related to the nonprofit. It will not be a civic center or venue for private events.

## Supervisor McKay

- Reiterated that, if the nonprofit/nonconforming use has unlimited conference capabilities, adding the Country Inn use as well would cause more traffic issues and upset people immensely.
  - Mr. Frank added that the proposed special use permit would not increase traffic volume in Millwood any more than Project Hope did when it was located at the same property.

## **Chairman Weiss**

- Summarized that the proposed conditions would limit events in the Main House to 60 people, would prohibit outdoor events, and would only allow the nonprofit to hold events related to the nonprofit itself. Additionally, the Country Inn use would remove a number of buildings from the nonconforming use.
- Requested that staff and/or the applicants provide an estimate as to the number of people that would be using the nonprofit facilities at any given time, and cautioned the Board that this number can be used to inform decisions but, due to the nonconforming use, cannot be limited.

## Vice Chair Catlett

 Added that because the nonprofit can only hold indoor events, they are limited by the building occupancy, as determined by the drain field and the building code.

#### Supervisor Lawrence

- Asked how many country inns there are in Clarke County and if their kitchens are open to the public.
  - Jeremy Camp answered there is one country inn and their specific special use permit allows a restaurant as well. A second country inn was approved but never constructed.

## Supervisor Bass

- Inquired about the rationale for condition 13, which prohibits amplified sound outside of any buildings.
  - Mr. Camp responded that the Planning Commission felt that the existing noise ordinance did not adequately protect the adjacent properties from the impacts of noise on from estate, due to the topography and the locations of the buildings.

## Chairman Weiss

 Clarified, and Jeremy Camp affirmed, that the 17 conditions recommended by the Planning Commission apply to both the nonconforming use and the country inn. Supervisor Lawrence moved to set a public hearing on Carter Hall Estate LLC Special Use Permit & Site Development Plan (PH2023-06: SUP22-02/SP22-03) for June 20, 2023 at 6:30 pm or as soon thereafter as the matter may be heard. The motion carried by the following vote:

2023-05-08 Summary: At 10:02 am, Chairman Weiss called the meeting to order.

- A. <u>Sanitary Authority Code Changes & Updates</u>: Sanitary Authority Administrator Mary Meredith presented the following:
  - 1. The Sanitary Authority and Inboden Environmental Services, the contractor who manages the water and sewer systems, have suggested amending the Code of Clarke County Chapter 180, Water & Wastewater. The suggested changes provide clarification on the definitions of fats, oils, grease, and other non-polar petroleum and mineral products, as these pollutants are detrimental to the entire sanitary system. Additional suggested language codifies the current practice of using EPA and federal testing standards and accredited analytical laboratories.

The Board reviewed the proposed changes and asked several questions. Staff was directed to collaborate with Sanitary Authority staff to draft changes to

Chapter 180, including those proposed by Inboden, as well as additional regulations on penalties and fees for repeated code violations.

By consensus, the Board decided to consider setting a public hearing on amendments to the Code of Clarke County Chapter 180 at the next regular meeting.

- 2. The EPA has released new guidelines and requires utilities to determine the composition of all service lines and submit an inventory. The CCSA does not have any lead or copper piping in its system; however, there are some sections of galvanized piping. CCSA has contracted with Inboden Environmental, who will compile the required documents for submission in October 2024. The CCSA will continue to provide updates to the Board as they become available.
- 3. The CCSA has also contracted with Inboden Environmental to develop a Utility Master Plan. This plan will examine potential growth within the existing service areas compared to available capacity. This will assist with long term planning for any needed capital improvements.

The Board discussed and asked several questions, but took no action on either item.

At 11:12 am, Chairman Weiss adjourned the meeting.

19) Public Hearing: VDOT Secondary Six-Year Plan (PH2023-05)

Residency Administrator Ed Carter presented the following:

- Telefee funds are collected by VDOT for right-of-way usage by utility companies and then distributed according to population.
- The six-year plan is all based on projections, so numbers for FY25 through FY29 are rough estimates.
- Lockes Mill Road, Phase II Unpaved Road will receive enough funding in FY25 to be completed, so that project can be started in July 2024; projects like this cost about \$350,000 per mile.
- The Board has not identified any other roads for the rural rustic roads project and has less than 20 miles of unpaved road currently.
- Countywide Transportation Services funds can be used for smaller construction projects, such as lengthening a turn lane.

## <u>Supervisor Lawrence</u>

- Restated his request for data about the maintenance costs of unpaved roads in the county.
  - Ed Carter replied that other counties rank unpaved roads according to traffic volume, school bus routes, residences, accident history, maintenance activities, then and use that ranking to decide on future projects. Stabilized roads are graded a minimum of four times a year, and all of them will be re-stoned this year.

#### Supervisor Bass

- Asked if VDOT has identified any roads that should be included in the Rural Rustic Roads project.
  - Ed Carter answered no and advised that the road ranking system that other counties use removes politics from those decisions.

## **Chairman Weiss**

 Opined that the ranking system is useful for objectivity, but it does not factor in citizen concerns about paving roads increasing speeds.

#### Vice Chair Catlett

- Questioned why there is \$0 for FY24 and FY25 under Countywide Transportation Services.
  - Ed Carter responded that there is no money going into that account in those two years, the Telefee services funds for those two years are applied to the Lockes Mill Road Phase II project.
