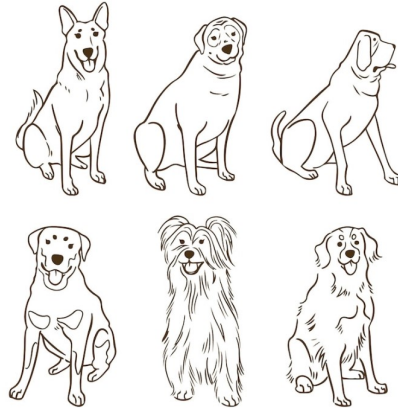

**\*\*\*REMINDER\*\*\* CLARKE COUNTY DOG LICENSE \*\*\*REMINDER\*\*\***



Clarke County law requires the Treasurer to collect license tax on all dogs 4 months of age and older.

Current rabies certificate(s) on each dog and/or dogs are required in order to purchase a dog license.

Dog licenses go on sale November 1st and must be purchased by January 31st

- MALE or FEMALE.....\$10.00 each
- SPAYED / NEUTERED .....\$ 5.00 each
- \* SMALL KENNEL (1-20 dogs).....\$30.00 each
- \* LARGE KENNEL (over 20 dogs).....\$40.00 each

\*A Kennel license may require an inspection by the Animal Control Officer prior to licensing.
