1) Call to Order

Chairman Weiss called the meeting to order at 1:00 pm.

2) Adoption of Agenda

Chairman Weiss recognized Deputy Commissioner of the Revenue Sue Braithwaite for the many years of tremendous service and dedication she has provided to the county and offered the Board's congratulations for her retirement.

3) Citizen's Comment Period

Bradley Cook of Longwood Lane in Bluemont

I was here in February and spoke about the traffic situation and speeds. I have seen some more police presence, which is greatly appreciated. I think it has helped somewhat. To help the police out, some of my neighbors and I are wondering if it is possible to get some of the signs, like there are in town and on Route 17 from Route 50 to 66, the speed limit signs that check and display actual speeds. I think of people that are just going with the flow of traffic do not realize how fast they are actually going. It makes it very difficult for us on the mountain to get on and off of Route 7. The other thing for VDOT is a question on the road-widening project: is it by design for the rumble strip to be right on the line? I am used to seeing them outside the line.

4) Employee of the Quarter Award – 1st Quarter 2024

Chairman Weiss presented the award to Sarita Emmons, Family Services Supervisor at the Department of Social Services, and read aloud the following:

Sarita has become an amazing leader for the services team. She also provides support to all of the staff at the agency. Sarita works with our benefits unit to ensure we are compliant with our quality assurance reviews for Title IV-E funding for our foster care children and connects our services clients with benefits. She frequently attends community events to ensure our community is aware of our available programs and services. Sarita always is available for staff and ensures the services team is covered and supported. She brings a wealth of knowledge, empathy, and leadership to her role. We are a better agency because of Sarita's support and leadership here in Clarke County Social Services.

5) VDOT Update

No VDOT representative was present and no update was provided.

Chairman Weiss instructed staff to send the citizen comments regarding traffic safety on Route 7 to Edinburg Residency Administrator Ed Carter.

6) Planning Department Annual Report

Planning Director Brandon Stidham presented the following:

- The Planning Department's annual report is provided in the meeting packet and includes the Planning Commission's required annual report as well.
- The department provides professional planning, code enforcement, project management, and technical services to support the county's planning and land use objectives, as well as special projects as assigned by the Board.
- The department's goals are to deliver professional-level technical guidance in a number of different subject areas, conduct effective enforcement of county ordinances, provide quality customer service across numerous platforms, and maximize finite county resources.
- Section 2 of the report summarizes all of the planning & zoning activities conducted over the last year. All applications reviewed by the Board and the Planning Commission are listed with approval, denial, or pending status.
- The department also provides planning & zoning support to the Town of Boyce, through a memorandum of understanding. There were not many special projects for the Town of Boyce, though staff attended several town council meetings to provide guidance on various projects and assisted customers with permit applications.
- Item 2-L lists all the special projects that the department and the Planning Commission undertook. This includes the recently adopted Transportation Plan, the Historic Resources Plan, Waterloo Area Plan, and Water Resources Plan. The Planning Commission agreed to leave these plans as-is and review them again in five years.
- Staff has been working with the Berryville Area Development Authority to update the Berryville Area Plan and will continue that work this year.
- Work has started on the Rural Lands Plan, which will be a conglomeration of the current Agricultural and Mountain Land Plans, as well as new guidance for the villages of Millwood and White Post.
- Finally, staff has also been working to build a database for the OnlineRME system, which will make health department and septic system records available for both internal use and public access.
- Item 2-M is new to this year's report and is a summary of enforcement actions taken by the Zoning Administrator.

- The department acts on zoning violations on a complaint basis. The highest category of new violations was short-term residential rentals, which are most often generated by complaints from adjoining property owners.
- The most common reason for people not getting permits is not realizing that a permit is required, so the Zoning Administrator will begin with an informational brochure and a gentle letter advising the property owner that they must obtain a permit within a certain period of time. If there is no response, a notice of violation is issued.
- Sections three and four report residential building permits and subdivisions.
 Totaling all the minor subdivision applications in 2023, there were 13 new lots created in the county and 4 maximum lot size exceptions were approved.
- There is also a table of used and remaining Dwelling Unit Rights (DURs) listed by election district. 49.4% of the total DURs in the county remain unused.
- Section 5 summarizes the conservation easement program by listing the number of easements added, dwelling units retired, appraised values, easements purchased, and the amount of money contributed by the property owner, the county, and grant funds.
- Section 6 summarizes biosolids applications, of which there were zero in 2023.
- Section 7 outlines the Historic Preservation Commission's activities and section eight reports on the Litter Committee.
- Much of the information in the annual report is also provided in the Planning Department's monthly report as well.

Chairman Weiss

- Observed that a recent article on the census report within various counties noted that Clarke had lost 16,000 acres of agricultural land.
 - Mr. Stidham noted that report was based on the agricultural census, which is taken by voluntary response.

Proclamation Recognizing April as Child Abuse Prevention Month 2024-02P

WHEREAS children are the foundation of a sustainable and prosperous society, and our welfare as a Commonwealth and a nation is built on a foundation of safe and healthy child development; and

WHEREAS child abuse is among our nation's foremost public health issues, with studies revealing a direct link between the abuse and neglect of children and long-term psychological, emotional, and physical effects, often with lifelong consequences for victims of abuse and potential impact for future generations; and

WHEREAS the Virginia Department of Social Services reports that child abuse affects more than 120,000 families each year in the Commonwealth as documented by local departments of social services and during SFY2023, there were 139 completed reports of child abuse and neglect accepted by Clarke County Department of Social Services involving 170 children; and

WHEREAS childhood trauma, including abuse and neglect, affects every segment of our community, and finding solutions requires input and action from everyone; and

WHEREAS protective factors such as economic and social supports create conditions that reduce or eliminate risk and promote the social, emotional, and developmental well-being of children; and

WHEREAS every child is entitled to love and care in a safe and nurturing environment free from abuse and neglect with access to the support and educational opportunities needed to help them grow and thrive; and

WHEREAS creating communities where Virginia's families are supported and strengthened through meaningful partnerships between schools, professional health services, community and faith-based organizations, businesses and law enforcement can prevent child abuse and neglect; and

WHEREAS April is National Child Abuse Prevention Month, a time for Virginians and Americans to be reminded of the courage and responsibility it takes to raise a child; and

WHEREAS through partnership with numerous state agencies and non-governmental organizations, Clarke County Social Services practices a robust prevention plan targeting resources and services to prevent abuse and neglect; and

WHEREAS we must work together as a Community to increase awareness about child abuse and neglect while creating safe and healthy environments for children to live with supportive families and engaged communities.

NOW, THEREFORE, BE IT RESOLVED the Clarke County Board of Supervisors does hereby recognize April 2024 as Child Abuse Prevention Month and call this observance to the attention of all our citizens; and

BEIT FURTHER RESOLVED the Clarke County Board of Supervisors recognizes the critical role that local family services workers play in supporting families in stress and protecting children at risk of child abuse and does commend and thank them for their service.

David & Marti Bryant, TM# 20-A-7, Anne McDonald TM# 20-A-5A & 20-A-5B

The Conservation Easement Authority is requesting approval of the easement donation for the above referenced parcels.

The Robert McDonald Trust, Anne McDonald, Trustee has applied to the easement authority for approval of an easement donation. The property is located in the 2000 block of Old Winchester Road 1,800' east of the intersection with Ginns Road. There are 2 properties: tax map 20-A-5A, 80 acres with 4 remaining DURs, and 20-A-5B, 7.99 acres with 1 remaining DUR. Both properties are vacant. The properties are primarily open pasture for hay and grazing. The property is within the Chapel Rural Historic District. The applicant would like to retire 3 of the 4 remaining DURs located on TM# 20-A-5A. No DURs will be retired on 20-A-5B.

The 2 properties were evaluated separately with regards to the criteria. Tax Map# 20-A-5A meets all of the 4 criteria. The property resource score is 60.4, it is adjacent to 3 existing easements, it is over 40 acres, and 3 of the 4 remaining DURs will be retired. Points were given for having frontage on Old Winchester Road, a state designated scenic byway, being adjacent to existing easements, being within the groundwater recharge area, having two sinkholes, and retiring 3 DURs. There is no lien on the property.

Tax Map# 20-A-5B meets 2 of the 4 criteria. The property resource score is 50.2, it is adjacent to 3 existing easements, it is not over 40 acres, and zero DURs will be retired. Points were given for having frontage on Old Winchester Road, a state designated scenic byway, being adjacent to existing easements, and being within the groundwater recharge area. There is no lien on the property.

Marti & David Bryant have applied to the easement authority for approval of an easement donation. The property is located at 2092 Old Winchester Road on the northeast side of the intersection with Ginns Road. The parcel consists of 39.062 acres, there are 2 remaining DURs and an existing house, built in 1877. The parcel is locally known as Duck Pond. The property has a mix of wooded areas and pasture. The property is within the Chapel Rural Historic District and the existing house is a contributing structure. The applicant would like to retire 1 of the 2 remaining DURs.

The property meets 3 of the 4 criteria. The property resource score is 82.5, it is adjacent an existing easement, and 1 of the 2 remaining DURs will be retired, it is not over 40 acres DURs. Points were given for having frontage on Old Winchester Road, a state designated scenic byway, being in easement and adjacent to an existing easement, being within the groundwater recharge area, having a sinkhole, retiring 1 DUR, and having a contributing structure in the Chapel Rural Historic District. There is no lien on the property.

Applications were submitted and preliminary approval given for the easement donations at the December and January CEA meetings. A site visit was conducted March 20th. Final approval for the easement donations are scheduled for April 12th. There are no outstanding issues.

The 80 acre parcel identified as TM# 20-A-5A was approved for subdivision by the Planning Commission on April 5^{th}

The there are several steps required to complete the recordation of the easements as follows:


- 1) The re-assignment of the Bryant's current VOF conservation easement to the County VOF approval 3/27.
- 2) Final approval of the Conservation Easements by CEA 4/12
- 2) Board of Supervisors approval of the Conservation Easements 4/16
- 2) The recordation of the Deed of Easement for Anne McDonald -20-A-5A after final approval by BOS 4/16
- 3) The recordation of the Planning Commission approved subdivision recorded immediately following McDonald Deed of Easement 4/16
- 4) The recordation of the merger plat of the 60 acres to the Bryant's recorded immediately following subdivision plat recordation 4/16
- 5) The recordation of the Deed of Easement for the Bryant's 99 acres recorded immediately after the merger plat recordation $4/16\,$

In total 119 acres will be placed, through donation, in permanent conservation easement retiring a total of 4 DURs, allowing for 2 additional dwellings, one on the current 39 acres, 20-A-7, and 1 on the 20 acres.

Recommendation: Approve the Conservation Easement Authority request for approval of the easement donations of David & Marti Bryant, TM# 20-A-7, Anne McDonald TM# 20-A-5A & 20-A-5B.

11) Proposed CY2024 Tax Rates and User Fees Resolution (2024-05R)

County Administrator Chris Boies presented the following:

- The proposed tax rates would be effective for the calendar year 2024 and the proposed user fee updates would be effective as of July 1, 2024.
- The only proposed change is returning the personal property tax rate to \$4.496
 and the rate for qualified Fire & Rescue vehicles to \$2.248.
- A public hearing on the tax rates and user fees was held on April 8, 2024 and there were no speakers on the matter.

Chairman Weiss

- Noted that Mr. Boies did an excellent presentation on the tax rates and the entire budget at the public hearing. The change to the personal property tax rate returns it to where it was from 2012-2022. Based on analysis, roughly 90% of people will pay less than they did last year because vehicle values have depreciated at least 10%.
- Further noted that the tax increase is tied directly to the change in the composite index by the state. The state's calculation cut funding for the schools by more than \$600,000 and the tax rate increase raises revenue by approximately \$500,000. Without the composite index change, the tax increase would be unnecessary.

Supervisor Bass

 Added that the composite index calculation is flawed and shared his hope that the state government prioritize fixing it. Supervisor Bass moved to adopt the CY2024 Tax Rates and User Fees Resolution (2024-05R) as presented. The motion carried by the following vote:

- Loudoun County is seeking a resolution of support for their SMART Scale application for the Route 601/Route 7 intersection.

2024-04-08 Summary: At 10:02 am, Chairman Weiss called the meeting to order.

A. <u>VDOT Secondary Six-Year Plan</u>: Ed Carter, residency administrator for the VDOT Staunton District, presented updated financial figures for the FY 2025-2030 Secondary System Plan. The current plan calls for Lockes Mill to be paved from 2.04 miles east of Route 608 to 0.96 miles east of Route 608 during FY 25. Another unnamed project exists for FY 30 and countywide transportation services is funded each year. Mr. Carter clarified that these funds can only be used for secondary roads, the current estimate to hard surface gravels roads is \$355k per mile, and that new legislation signed this year may allow rural rustic funds to be used for road repairs (previously they could only be used for hard surface). By consensus, the Board agreed to consider authorizing a public

hearing on this matter at their April 16 meeting (hearing possibly on May 21), to leave the unnamed project unassigned until ranking criteria can be developed over the next year, and to allow existing funding to be used for improvements to Morgan's Mill Road.

B. <u>Berryville District Supervisor Resignation</u>: Supervisor Bass read his resignation announcement aloud and the Board members thanked Supervisor Bass for his service to the County. By consensus, the Board agreed to post the Berryville District Supervisor position vacancy on the County website from April 9 to April 26, conduct interviews sometime between April 29 and May 10, to appoint a replacement at the May 13 work session, and to have the new board member in place for the May 21 meeting.

 - A. Clarke County School Division FY24 Supplemental Appropriation Requests
 - 1. CCPS has applied for and received a Security System grant from the Department of Criminal Justice Services (DCJS). These grant funds will be used to purchase security cameras and radios. The grant total is

\$36,425, which includes a required local match amount of \$7,285. This request is for expenditure and supplemental appropriation of \$29,140 to the capital projects fund. The local match of \$7,285 has already been appropriated as part of the FY24 original CCPS adopted budget.

- 2. This is a supplemental expenditure and revenue budget and appropriation request in the amount of \$17,977 to the capital projects fund, for the Boyce Elementary School playground equipment and installation. This appropriation represents the portion of the playground costs provided by the BES PTO and will be combined with CCPS expenses for a total project cost of \$32,977. The total project cost is captured for fixed asset value and used to calculate depreciation in future years.
- 3. This is a supplemental expenditure and revenue budget and appropriation request for the School Division operating fund in the amount of \$7,797.48 for repairs to Boyce Elementary School as a result of storm damage. An insurance claim was filed with the Division's insurance company and a claim payment of \$7,797.48 is being processed.
- 4. CCPS received \$30k in ESSER III Retention grant funds. These funds will be used for continuing education support for 13 provisionally licensed teachers, 3 teachers needing to add specific certifications, and 4 long term substitutes seeking their initial provisional license. This request is for supplemental expenditure and revenue budget and appropriation of \$30,000 to the CCPS operating fund.
- 5. There are additional federal ARP ESSER III funds available in the amount of \$18,411. These funds will be used to help cover a portion of the costs for the Cooley Upper vestibule and a Spot Vision Screener. CCPS intends to fully spend the ARP ESSER III grant funds by 6/30/24. This request is for supplemental expenditure and revenue budget and appropriation to the operating fund in the amount of \$18,411 in order to receive the federal funds.
