As the Director of Clarke County Department of Social Services (CCDSS), each year I prepare the annual report of the services and programs our agency provides to the citizens of the County. Our staff at CCDSS work diligently to support the mission, vision, and values of our agency to ensure the needs of our most vulnerable citizens are met.

This past fiscal year has been a difficult year for staff to endure with Medicaid unwinding, increasing caseloads, and consistent vacancies. However, our team persevered to meet critical timelines to ensure benefits were processed timely even during the challenges that faced the team and agency.

Our services team has continued to see an increase in caseloads with mental health crisis, domestic violence, homelessness, substance abuse, and behavioral needs of children presenting difficult to place. Complex cases and increasing volume have taken exorbitant amounts of time and critical new skills of our already strained family and adult services team.

This report provides only a glance of the what the staff does inside the building located at 311 East Main Street. It would require a novel to tell all the story of what they do for the people of Clarke County every day, 24 hours a day, 7 days a week, 365 days a year.

To be their leader is a privilege. To walk alongside them in the work that we do, to share in their commitment to the community, to be the human services support, connection, and community partner for Clarke County is an honor.

SERVICE PROGRAMS CHILD, FAMILY, & ADULT SERVICES

The goal of Clarke County Department of Social Services is to provide services and programs to the citizens of Clarke County that promotes and supports the development of healthy families and protects children and adults from abuse and neglect.

ADULT SERVICES/ADULT PROTECTIVE SERVICES

Adult Services (AS) allows the adult individuals to remain in the least restrictive setting and function as independently as possible by establishing and/or strengthening appropriate family and social support systems or by supporting the adult in self-determination. AS supports impaired adults aged 18 or older, and their families when appropriate. Adult Protective Services (APS) investigates reports of abuse, neglect and exploitation of adults aged 60 and over and incapacitated adults over 18 years of age and provides services when person is found to need protective services.

FOSTER CARE

The foster care program provides services to children and families when circumstances require the child to be removed from their home. Foster care provides a safe and stable environment for children and older youth until the issues that made placement outside the home necessary are resolved. When a child cannot return home, another permanent home is found for the child through adoption or legal custody by a relative.

In-Home and prevention services help children remain safely in their homes or with relative caregivers. Through family engagement, continuous assessment of risk, safety, and protective factors, the In-Home services programs preserves families, reduces entry into foster care, and builds stronger, healthier parent-child relationships.

THE CHILDREN'S SERVICES ACT

The Children's Services Act (CSA) is a law enacted in 1993 that establishes a single state pool of funds to support services for eligible youth and their families. The purpose of CSA is to provide high quality, child-centered, family-focused, cost-effective, community-based services to at-risk youth and their families. State funds, combined with local community funds, are managed by local interagency teams who plan and oversee services to youth.

<u>CFW</u> CLARKE, FREDERICK, & WINCHESTER FOSTER CARE CONSORTIUM



In FY22-23, CFW provided information sessions to 44 prospective foster families. Of those 44 families, 35 completed the training and assessment process to become fully approved foster families. CFW also maintains the ongoing certification process for foster families required every three years. At the end of FY23, CFW maintained 30 approved foster homes.

CFW provides the training and assessment process to our Kinship families to ensure the safety and well-being of relative children being placed with family members. Last year, CFW approved 7 kinship family homes.


CFW holds monthly informational sessions for prospective families to learn about the foster parent training and approval process.

Total amount (incl. NER costs & Special Funds) spent on Social Services in the Locality in SFY 2023


