Filing Deadlines for All Planning Commission Meetings or Public Hearings (Rezoning, Special Use Permit, Site Plan, Major & Minor Subdivision)

PRE-APPLICATION CONFERENCE DEADLINE

Applicants for rezoning, special use permits, site plans, and subdivisions are required to hold a pre-application conference with Department Staff no less than seven (7) days prior to filing the application. It is best to schedule this meeting in advance with Department Staff to ensure their availability and to provide sufficient time for review. The purpose of the conference is to ensure that the Applicant is aware of all submission requirements and can file a complete application by the desired deadline. The deadlines to hold the pre-application conference in order to meet the monthly application filing deadline are as follows:

APPLICATION FILING DEADLINE

All complete applications shall be filed with the Department of Planning by the deadline below in order to be considered by the Planning Commission (PC) at their next regular meeting. The Zoning Administrator shall review the application to determine whether all required elements have been provided including fees and completion of the pre-application conference with Department Staff. In the event that the application is incomplete, it will be returned unprocessed along with the fees to the applicant.

The Application Filing Deadline is 4:30PM on the first Friday of each month unless otherwise noted on the schedule. In the event that the Department of Planning is closed for inclement weather or another reason, the Application Filing Deadline will be extended by one week to the following Friday.

FILING OF SUPPLEMENTAL MATERIALS

All supplemental materials filed by the Applicant to demonstrate compliance with the technical elements of an application shall be provided to the Planning Commission or Board of Supervisors no less than 14 days_prior to the first public hearing date, and no less than 10 days prior to the date of any continued public hearing.

Any materials provided after this deadline shall not be considered by the Commission or Board at the scheduled public hearing. In the event that this deadline falls on a weekend or date in which the Department is closed, the deadline shall be the immediately preceding business day.

Following the filing of a complete minor subdivision application, the Applicant shall provide all new or revised materials no less than 3 business days prior to the work session meeting at which the Planning Commission is scheduled to consider the application. Any materials provided after this deadline shall not be forwarded to the Planning Commission for consideration until their next monthly meeting cycle.

DEADLINE TO REQUEST ADMINISTRATIVE DEFERRAL

An Applicant may request the Zoning Administrator to administratively defer an application that has been scheduled for public hearing. Requests for deferral shall be provided in writing prior to Department Staff finalizing the public hearing advertisement for the application with the Winchester Star. Public hearing advertisements are typically finalized three weeks prior to the public hearing date. Please contact the Department of Planning to determine the exact date of this deadline as the newspaper's submission deadlines can vary.

Applicants that are granted an administrative deferral of their application by the Zoning Administrator will not be charged a re-advertising fee.
