



Mr. Johnston presented a proposed Easement Purchase Agreements, signed by James H. Digges, for his approximate of and known as Greenway Court. Mr. Johnston outlined the terms of the agreements, dated April 22, 2003, that are attached to these minutes.

Chair Mackay-Smith asked for comments on this proposal. Mr. Hobert reviewed the development of the Easement Purchase Program in Clarke County and stated that he believed this proposal was consistent with the Program and its goals and objectives as established by the Board of Supervisors. Mr. Bieschke stated that he supported approval of the proposed easement agreements, as they would protect a National Historic Landmark and one of most historic properties the Mid-Atlantic Region. Mr. Weiss said that he also supported the proposed agreements as they encompassed a sufficient amount of land to ensure a viable base for farming activities and that the easement would provide a buffer around the community of White Post. Ms. Radford stated that she supported the proposal, as this was a gem of a

property that was an important component to the beginnings of our nation and would be a fitting beginning for the efforts of the County Easement Authority. Chair Mackay-Smith stated that Clarke County was a leading county in Virginia with the highest percentage of its land in open space easement and that the Easement Purchase Program was now lowing lower and middle income property owners to join in adding to Clarke County's easement base. She called for a motion on the proposal.

On motion of Ms. Radford, seconded by Mr. Bieschke, the Authority unanimously authorized the Chair of the County Easement Authority to accept and sign, on behalf of the Authority, the proposed Easement Agreements for the approximate 145 acres comprised of Tax Map Parcels 28-A-52 & 53 and owned by Jim Digges.

On motion of Ms. Radford, seconded by Mr. Bieschke, the Authority unanimously recommended to the Board of Supervisors the approval of these proposed Easement Agreements.

Chair Mackay-Smith stated the Clarke County Easement Purchase Program was created to preserve and protect Clarke County's resources. Properties already under easement in Clarke County carry specific permanent restrictions to protect natural and historic features and limit the number of allowable parcels for residential use. Clarke County's zoning regulations have effectively addressed rural residential sprawl, especially when compared to development activity in adjoining counties. As approved by the Board of Supervisors in June 2002, the Clarke County Easement Program does not only retire dwelling unit rights, but selects properties that contain outstanding natural and cultural features to restrict in perpetuity in accordance with the wishes of property owners. The Program offers compensation to lower and middle-income property owners in exchange for these permanent limitations as well as the retirement of their valuable development rights.

Today, the Clarke County Easement Authority is pleased to accept the offer by Jim Digges to place a conservation easement on two nationally significant historic parcels of land of approximately 145 acres, located one mile southwest White Post, Virginia. The first parcel contains 4.9 acres and encompasses the 1747 site of Greenway Court, originally the colonial seat of Thomas Lord Fairfax. When Lord Fairfax inherited the 7,800 square mile grant of Northern Neck from his mother, a daughter of Thomas Lord Culpeper, he became the proprietary owner of all the land between the Potomac and Rappahannock Rivers. In 1747, when he was 54, Lord Fairfax started construction of Greenway Court and lived there until he died in 1781. From 1749 to 1751, Lord Fairfax engaged the young George Washington as a surveyor. Greenway Court is significant for several reasons. Lord Fairfax, Baron Cameron, was the only member of the British aristocracy to actually occupy a permanent residence in the American colonies. As proprietor of the Northern Neck, Lord Fairfax received rents and carried out land sales at the 18th-century stone land office still standing at Greenway Court. Lord Fairfax's estate and resources educated and enlightened the young George Washington while he surveyed the area. In 1975, Greenway Court was listed as a National Historic Landmark by the National Park Service. The National Historic Landmark designation is only given to places: 1. where significant historical events occurred, 2. where prominent Americans worked or lived, 3. that represent those ideas that shaped the nation, 4. that provide important information about the nation's past, or, 5. that are outstanding examples of design or construction. Fewer than 2,500 sites in the United States have been given the NHL designation. Under the terms of the proposed easement, archeological research will be allowed on the Greenway Court property, as well as work to stabilize and rehabilitate the 18th-century Land Office and Arsenal.

The second parcel is just under 140 acres and has been farmed by the Digges and Kennerly families for more than 150 years. It contains a perennial stream and has five dwelling unit rights. Mr. Digges has agreed to extinguish three dwelling unit rights. In addition, the two remaining dwelling unit rights must be located beyond a ridge line 750 feet west of the parcel containing the historic landmark. This restriction places any future residences effectively out of sight of the existing 18th-century buildings.

r. Digges has agreed to the restrictions placed on both properties in exchange of \$225,000 in compensation. The recommended purchase price is based on an independent appraisal by a licensed appraiser, combined with the value of the additional restrictions on the National Historic Landmark parcel and the view shed and subdivision restrictions on the adjoining 140 acre parcel. Today, the Clarke County Easement Authority has unanimously and

enthusiastically recommended the purchase of the Greenway Court easements to the Board of Supervisors. This is a significant milestone for Clarke County.

Greenway Court Easement



Ranch and Farmland Protection Program; USDA Natural Resources Conservation Service - Mr. Johnston presented a memo from Alison Teetor, County Natural Resource Planner, outlining the Program. In her memo Ms. Teetor noted that this federal program has money available, as a 50/50 match, for the purchase of conservation easements on agriculturally valuable property. She reported that money can be requested only for specific farms, so she suggested the Authority consider initiating a second round of easement applications to take advantage of funds available in the current federal fiscal year ending 30 September 04.

Discussion on the sales of tax credits – Review of letter from Mark Botkin - Mr. Johnston reported that Mr. Botkin has submitted a revised letter, after conferring with the Authority's attorney, Robert Mitchell, clarifying his understanding that the Authority is enabled to hold easements, but reiterated his position that the Authority did not have an active role to play in the selling of tax credits except one of public information. Mr. Mitchell discussed the Authority's role in the selling of tax credits by a conference telephone call.

Solicitation of private financial contributions - Mr. Hobert stated that he understood that two members of the Board of upervisors, John Staelin and Pete Dunning., were willing to host a fund raising event for the benefit of the Authority. In conjunction with this event, Ms. Radford suggested that the Authority contact Kate Petranech, a marketing consultant on retainer with Downtown Berryville, Inc. to develop a fund raising plan incorporating the above referenced fund event into a larger strategy. Mr. Johnston said he would contact Ms. Petranech and invite her to the next meeting.

Discussion of budget request for easement purchase program - The Chair said she would discuss next year's County budget with the Board of Supervisors and asked Mr. Ohrstrom and Ms. Radford to prepare an Authority budget to present to the Board.

Status of Easement Properties

- Greenway Court Mr. Johnston reported he was applying for General Assembly funds for 25% of a \$200,000 project to renovate the historic structures and study the archeological resources at Greenway Court. He said he would be applying in May for 50% of the funds from a federal program for National Historic Landmarks, Save American's Treasures.
- Boyce Crossing Tree Preserve Mr. Johnston reported that this proposed easement was scheduled to be considered by the Board of Supervisors as a co-holder at their December 16th meeting and as many members of the Authority should be present as possible. Mr. Ohrstrom and Ms. McKelvy said they planned to be attend the Board meeting.
- Linden (proposed) Mr. Johnston reviewed the draft easement with the Authority. A conference telephone call was held with Robert Fortna, husband of one of the 6 family members that own the property. Mr. Johnston stated the Authority's willingness to consider the easement was based on being able to co-hold the easement with the Virginia Board of Historic Resources, having a survey of the property, and having the agreement of all property owners. Mr. Fortna said he understood the Authority's wishes and appreciated their consideration. Mr. Johnston said he would put the Authority's concerns in a letter to Mr. Fortna and that he would circulate this letter to the Authority before sending.
- **Dimmel** Mr. Johnston reported that Rick Dimmel was still interested in an easement on a two acre property containing a log cabin near Millwood and he was working on the details of such an easement.

There being no further business, Mr. Bieschke moved and Ms. Radford seconded, that the Authority adjourn to its next regular feeting at 5:00 pm, Wednesday, 14 January 2004. The motion was approved unanimously.
