Call to Order

At 9:39 am, Chairman York called the meeting to order.

Approval of Agenda

Approval of Minutes

Anne Cushman moved to approve the minutes of July 17, 2024, as presented. The motion carried by the following vote:

Designation of Board Chair and Vice-Chair

The Board discussed the need to formalize a vote for Chair and Vice Chair of the Social Services Board. Doug Lawerence moved to approve, seconded by Anne Cushman that Robin York serve as Chair of the Social Services Board and Laura Dabinett as Vice-Chair of the Social Services Board.

Advisory Board and Administrative Board

Director provided updates requested regarding questions from last meeting. Director placed question to the League White Board for input from other agencies that had made the change from Administrative to Advisory Boards. Responses included the Advisory Board allowed for "alignment with the County, streamlined processes for deviation, provided a clear path for citizen access, eliminated quorum issues for meetings, and provided support for the Director." The Director also reported that an additional 3 agencies had switched from Administrative to Advisory Boards since the meeting in August, and that Fredrick will be making the switch in the near future. As requested by the Board, the Director researched and found that only one agency had switched back from Advisory to Administrative but was not given a reason why this occurred.

The Director provided additional information regarding the benefits of an advisory board, including removing the responsibility of budget, program and personnel oversight from administrative board members who may not be as verse in complex budgeting processes as the County Administration team. In addition, having the County Administrator provided direct supervision and support for the Director that would be more accessible than waiting for the monthly board meetings.

After a discussion, Laura Dabinett motioned to approve a vote in support of an Advisory Board at 10:16 a.m. and Barbara Byrd seconded the motion. The vote was tabled until the next meeting after further discussion by Chairman York and Mr. Lawerence.

Chairman York requested additional information regarding the benefits of an administrative board be provided at the next meeting.

Board members discussed the vacancies on the board and how to move forward with those with the ongoing decision. The members agreed it would be best to wait to have new members join the Board until a decision was made regarding the type of board to avoid confusion and unnecessary training. Board members continue to discuss with community members of the possibility of serving on the social services board.

Director's Update


Director briefed Board members on the critical staffing issues facing the Department. Director gave a brief update on continued vacancies and that the benefits team had received another resignation. The services team continues to recruit for the foster care position, and that currently the Director is covering finance due to the loss of the administrative services manager. Director requested to engage Tom Morely of Snowflake Consulting for 10 hours of advising on how to best assess the resources and positions we currently have and to maintain morale during the extreme turnover. Director explained Mr. Morely was willing to provide his services at \$125 per hour. The Director would like to prepare a strategy to maximize retention of senior, seasoned employees and recruitment of new employees for vital positions. The Board opted not to engage Mr. Morely at this time but to explore alternatives for retention. The Board opted to table the discussion and look into providing a lunch or catered meal for staff in the future to help improve morale.

Chairman's Comments

Chairman York stated he had been preparing the Director's performance evaluation as it was overdue. This would be an interim evaluation and a full evaluation would need to be done in January 2025. Chairman York reported he had been consulting with County Administrator Chris Boies for input. He asked the board members if they would like to review or have any input on this interim evaluation. The Board members agreed he could move forward with Mr. Boies for the interim evaluation for the Director.

The Board was polled, and no other matters were needed for discussion. No other subjects in the room. Motion by
Doug Lawrence seconded by Barbara Byrd, the Board by voice vote, voted unanimously to adjourn the meeting.
Motion carried. The meeting adjourned at 10:49 am. to reconvene on September 18, 2024, at 9:30 a.m. at the Clarke
County Government Center, 101 Chalmers Court, Berryville, Virginia 22611.




