Bank Account:

Ms. Teetor reviewed the financial spreadsheets. Current fund balances show a total fund balance of \$576,405.77 consisting of \$166,282.15 in the donations account, \$241,682.91 in stewardship/restricted, and \$169,440.71 in local funds. Ms. Teetor explained that the expenditures for August included the summer newsletter, banners and materials for a booth at the Clarke County Fair, and paying the summer intern.

Campaign for the Authority:

Ms. Couch-Cardillo stated that donations were \$11,170.00 from 79 donors. She stated that the summer newsletter had been published and mailed. Ms. Couch-Cardillo and Chair Buckley discussed the visibility of the CCEA banners and booth at the Clarke County Fair. She reviewed the plans for the upcoming donor reception on October 11th and stated that the invitations had been sent to the printer for distribution.

Ms. Couch-Cardillo asked for ideas for the fall newsletter and Ms. Lemmon confirmed that the newsletter could be included with the tax bill sent by the Treasurer's Office as long as the remittance envelope is

omitted. The Authority discussed how omitting the remittance envelope may impact donations to the CCEA but it was agreed that the primary purpose of the fall newsletter was to educate all county landowners about the program. For the newsletter, Mr. McKay suggested including a landscape photo taken from Route 7 and a caption explaining that 25% of the county is in conservation easement. Ms. Teetor suggested a small article explaining the new online septic database that will go live next year and how it will help conserve groundwater quality.

Ms. Lemmon discussed posting CCEA banners at various locations across the county and Ms. Couch-Cardillo asked the Authority to start thinking about who they would like to nominate for the 11th Wingate Mackay-Smith Land Conservation Award.

Ms. Couch-Cardillo reported that there were no new donors for the month of August.

PEC updates from Tia Earman:

Ms. Earman explained that Piedmont Environmental Council (PEC) hired a new staff person to cover the conservation efforts for three counties including Clarke. She confirmed with Ms. Teetor that the \$37,000 Clarke fund check had been received for the Lilly easement. She reported that PEC continues their discussion on data centers in the area.

Discussion:

a. Landowner grant contribution

Ms. Teetor described how staff had been discussing the possibility of reducing the 25% landowner contribution to purchase easements based on their income using a sliding scale. She explained that the state and federal grants used for purchase easements do not take into account landowner income unless the applicant makes over \$900,000. Therefore, in most cases, the grants could make up the difference in cost of the easement. Ms. Teetor explained that the scale used to calculate the reduction is the inverse scale that is used to calculate DUR purchase offers. She stated that the reduction in landowner contribution may be an additional incentive for lower income landowners to place their land into easement especially as easements have become more restrictive.

The Authority discussed how the building envelope policy has caused some pushback from potential applicants but agreed that it was necessary due to recent tax court cases. The Authority voted 4-0-0 to approve the sliding scale used to reduce landowner contributions to grant purchase easements.

Report on Easement Donations/Purchases:

a. Summary of easement applications/inquiries

Ms. Lemmon reported that she is still working with Mr. Weir on his grant application. She mentioned that she is still waiting on a signed purchase agreement from Mr. Williams but is hopeful that they will still be able to close by the end of the year. She confirmed that Mr. Williams agreed to the single family dwelling sizes and building envelopes approved at the previous meeting. Ms. Teetor explained that Mr. Fansler is reviewing the draft deed with his lawyer but it may be possible for the easement to close by the end of the year. Ms. Lemmon explained some of the inquiries that may lead to future applications and the withdrawn application from RSP Enterprises.

b. Mike & Geetha Berry – new application – DUR purchase TM# 32-A-66

Michael and Geetha Berry have applied to the easement authority for approval of a DUR purchase easement. The property is located at 790 Frogtown Rd, is approximately 80 feet north of the intersection of Frogtown and Morgan Mill Rd, and is identified by Tax Map# 32-A-66. The property consists of 60 acres, has 2 DURs, and the principle property use is grazing and timber harvest.

The property resource score is 70.9, the applicant would retire 1 of the remaining 2 DURs, and it is more than 40 acres. Points were given for extinguishing a DUR, having steep slopes, a spring, and being owned by the same family for more than 50 years.

Ms. Lemmon relayed that after submitting an application to the Authority that Mr. Berry reached out and explained that he may do a boundary line adjustment (BLA) with his neighbor. She suggested to the applicant to complete the BLA before moving forward with the application.

The Authority voted 4-0-0 to approve the preliminary application of the Berry purchase and request staff to schedule a site visit once the applicant has completed the planned BLA.


