The following action is proposed: "Be it resolved that the FY 16 General Government Capital Projects fund budget be increased \$33,900, and the same appropriated, and that revenue from the Commonwealth be recognized in the amount of \$23,900, and revenue from the Greenway Court Foundation recognized in the amount of \$10,000, all for the purpose of restoring the Greenway Court historic structures."	162
2.	 Modification to Planning Fees and Request for Waiver. The Finance Committee heard a citizen request for refund of a portion of planning fees arising from a situation where a boundary line adjustment results in the need for a rezoning. This situation results in a fee that is disproportionate to the review time required by County staff. The Planning Director proposed bringing forward a recommendation for a new fee to cover such situations at the May Finance Committee. Since the Committee meeting it has become clear that the full fee has already been paid, though the check has not been cashed. Action: The Board should consider two options: a. Grant a waiver now that would refund a portion of the fee, and consider the policy next month. b. Consider the policy next month, and adopt it with a retroactive clause that would ensure that this particular case was treated under the new policy, 	162
