# 4) VDOT Update

Ed Carter, Assistant Residency Administrator, provided the following update:

# Maintenance

- VDOT began moving operations on primary's and boom axe cutting on secondary's;
- VDOT will continue with both this month;
- Conducted grading operations and stone application on non-hard surfaced roads and will continue this month;
- Assisted with installation of plows and spreaders on contractor equipment in preparation of upcoming winter season;
- VDOT is currently averaging removal of 10 deer carcasses per day;
- VDOT is also picking up an increased amount of debris including 18 discarded tires from various routes:
- VDOT's contract tree removal crew will be back in the area this month.

# Projects:

Rt. 761 Bridge: Received consensus from Board on preferred option for replacement.
 VDOT will be meeting with Frederick County on November 27 to gather its input on the project.

# Board Issues:

# 5) Shenandoah Area Agency on Aging Update

Linda Holtzapple, newly-appointed Executive Director, appeared before the Board to introduce herself and provide update. Highlights include:

- Ms. Holtzapple worked with the Berkeley County, West Virginia, agency on aging for nearly fourteen years. Also worked seven years with the American Red Cross and five years with the March of Dimes.
- Virginia and West Virginia provide the same programs through the Older Americans Act
- SAAA covers six jurisdictions.
- Senior Olympics conducted at Clarke County's Senior Center. Parks and Recreation staff were impressive in the event organization and support.
- Expressed appreciation for Robina Rich Bouffault, SAAA Board member, stating that she was a strong member and very engaged.
- Expressed appreciation for Clarke County's support and response.

- Clarke County has the lowest, 8%, participation in the regional service area. The need for support services in Clarke is not as strong as other communities in the region.
- SAAA does investigate nursing home complaints; however, depending on the nature of the complaint, other governmental entities may be involved.

Chairman Weiss expressed the Board's appreciation to Ms. Holtzapple and Mrs. Bouffault.

# 6) Clarke County Public Schools

School Superintendent Chuck Bishop appeared before the Board to provide an update. Highlights include:

- No Child Left Behind Act is being replaced by Every Student Succeeds Act.
- SOL scores are consistent with state averages.
- All schools are currently accredited by the Virginia Department of Education.
- Johnson William Middle [Reading], and Elementary Schools D.G. Cooley [Math] and Boyce [Reading], each must have an improvement plan.
- High School continues to have a strong graduation index.
- Class of 2017 graduated 189 with 27.5% receiving a standard diploma and 68.2% received an advanced-credit diploma.
- Statistics presented reflect the percentage of students planning to join the military after high school.
- Reviewed statistics on postsecondary plans and division demographics.
- Average daily membership for the 2017-2018 School Year 1,944 K-12 and 44 pre-K students. Last school year's ADM – 1,960.
- School Administrative Offices have moved into the renovated Primary School.
- Standards of Accreditation are changing.
- Continue to partner with Lord Fairfax Community College.
- Continue to address facility upgrades / equipment replacement.
- In the process of updating the Strategic Plan.
- School report cards are now called school quality profiles.

Supervisor Catlett asked for explanation of the pre-K program.

Vice Chair McKay put forth that he did not support the IB program in the Schools and asked the Superintendent to review ways to better utilize funding.

Superintendent Bishop remarked that there was always room for growth and expressed his strong support for continuous improvement and continuous growth.

Supervisor Byrd commented that some of their tenants move to Clarke County because of the excellent school system.

Chairman Weiss thanked Superintendent Bishop for his update and expressed the Board's appreciation for his hard work and dedication.

At their November 16, 2017 meeting the Authority gave preliminary approval to the following easement donation. The Authority requests the Board of Supervisors to authorize the Chairman of the Board of Supervisors to execute deeds, easements, and other documents necessary to the

Arden Carroll has applied to the easement authority for approval of an easement donation. The property is located on the west side of Old Chapel Road approximately 4/10 of a mile south of the intersection with Browntown Road. The property currently consists of two parcels Tax Map# 21-A-46, 10.47 acres, that has an existing house constructed in 1900 and 0 DURs, and Tax Map# 21-A-46A, 8.1 acres, vacant, with 1 DUR. The applicant proposes to merge the 2 parcels and retire the 1 remaining DUR.

The parcel is zoned AOC and is currently in use value taxation, in accord with the Commissioner of Revenue's requirements, therefore a donation may be considered if at least two of the following four guidelines are met:

- the parcel's Property Resource Score is at least 35;
- at least one dwelling unit right is extinguished by the conservation easement;
- 3) the parcel is adjacent to a parcel already under permanent conservation easement;
- the property has a minimum area of 40 acres.

The property meets 2 of the 4 criteria. The property resource score is 55.5. The applicant would retire the remaining DUR. It is not next to an existing easement and it is less than 40 acres. Points were given for retiring 1 DUR, have frontage on the railroad, being within the Prospect Hill Spring drainage basin, and having a structure that is potentially contributing to a rural historic district.

#### Recommendation

Approve the easement donation and authorize the chair to sign documents associated with the transaction.

# Conservation Easement Authority: Application for Donation – Stephanie Burgevin

Alison Teetor, Natural Resources Planner and staff representative to the Conservation Easement Authority, reviewed the request explaining that since the date of her memorandum [below] Ms. Burgevin decided to increase the number of donated DUR's from one to three.

SUBJECT: Application for Donation - Stephanie Burgevin

At their November 16, 2017 meeting the Authority gave preliminary approval to the following easement donation. The Authority requests the Board of Supervisors to authorize the Chairman of the Board of Supervisors to execute deeds, easements, and other documents necessary to the transaction.

Stephanie Burgevin has submitted an application for an easement donation in October 2016. The property is located at 721 Kennel Road approximately 7/10 south of Route 50. The parcel is identified as Tax Map# 38-A-17, consisting of 87acres. The parcel has a couple of outbuildings but no dwellings, consisting of primarily pasture with scattered woods. There are 4 DURs remaining on the parcel. The applicant originally wanted to retire 3 of the 4 DURs, however her appraiser wanted to confirm that the property could be subdivided and based on current zoning requirements she would need a 30° access easement to the property which she does not have. Therefore, she has revised her request to retire only one DUR leaving 3 on the property. The Easement Authority has approved construction of a primary dwelling and a tenant house. The third DUR cannot be utilized under current zoning and she will likely amend the deed of easement in the future to retire this DUR as well

The parcels are zoned AOC and currently in landuse, in accord with the Commissioner of Revenue's requirements, therefore a donation may be considered if at least two of the following four guidelines are met:

- the parcel's Property Resource Score is at least 35;
- at least one dwelling unit right is extinguished by the conservation easement;
- the parcel is adjacent to a parcel already under permanent conservation easement;
- the property has a minimum area of 40 acres.

This property meets all 4 of the criteria. The revised Property Resource Score is 63.6, the parcel is over 40 acres, the applicant is interested in retiring 1 of the 4 DURs and it is adjacent to parcels already under permanent conservation easement. Points were given for retiring 1 DUR, being adjacent to existing easements, the parcel is within the Greenway Rural Historic District and has two sinkholes.

#### Recommendation

Approve the easement donation and authorize the chair to sign documents associated with the transaction.

# Vice Chair McKay moved to accept the easement donation.

Vice Chair McKay put forward the following:

- The plat provided originated in the Lord Fairfax era, surveyed by George Washington, and has not changed since that time.
- The property originally belonged to a family that grew apples in the 1700's.
- Very few such properties remain.
- This donation demonstrates how the easement program preserve these properties.

# 10) Board of Supervisors Work Session Items

# A. <u>USGS Update by David Nelms</u>

11-09-2017 Summary: Mr. Nelms provided an update on the ongoing water quality and quantity research program. He reminded the Board of the importance of maintaining data sampling in future years. Mr. Nelms promised to provide links to additional information for the Board's use.

11-21-2017 Action: No action required during the regular meeting.

# B. Parking Area – Appalachian Trail

- 11-09-2017 Summary: The Board discussed the importance of the additional parking to serve the Appalachian Trail and to authorize to staff to proceed with clearing and grading.
- 11-21-2017 Action: David Ash advised that VDOT and Alison Teetor were reviewing details.

# C. Legislative Priorities 2018 Review

11-09-2017 Summary: The Board tabled review until its regular meeting.

11-21-2017 Action: Following lengthy discussion, by consensus the Board approved the 2018 Legislative Priorities as follows:

2018 Legislative Priorities and Positions for Clarke County 11/21/2017 Revision

Issue: Broadband Clarke County urges the Commonwealth and Federal

Government to assist communities in their efforts to deploy universal, affordable access to broadband for all areas, particularly in under-served and rural areas.

Additionally, Clarke County opposes mandates that limit or restrict local use authority for the siting of telecommunications infrastructure or result in a negative fiscal impact to county budgets.

Issue: Drug Courts, Treatment, and Substance Abuse Assistance Clarke County urges the General Assembly to continue and expand the use of Drug Courts, treatment, and substance abuse assistance in an effort to provide a more complete and less costly alternative to employing only the criminal justice system to resolve the issues surrounding substance abuse.

Issue: Education

Clarke County supports full funding of Virginia's Standards of Quality as recommended by the Board of Education. The Commonwealth should fund its share of the true cost of K-12 public education without reducing other parts of the budget affecting local government or shifting costs from the Commonwealth to localities.

In addition to meeting its obligations to fund fully instructional staff, Clarke County believes the Commonwealth should meet its obligation to fund fully the support side of K-12. Full restoration should be make of the cuts made in since 2009 in areas related to support staff funding including the elimination of the funding cap on support positions, reinstatement of the Cost of Competing funds for support staff, etc.

Clarke County supports legislation to adjust the calculation of the local Composite Index to base its Real Estate value calculations on use-value instead of true value in localities that have adopted use-value taxation.

Issue: Ethics Rules

Clarke welcomes a review of the Commonwealth's Ethics Rules but believes that the rules that affect local jurisdictions and their Boards, Commissions, Authorities and Committees are strong enough today. Clarke cautions that any increase to the ethics rules affecting localities could prove detrimental to getting people to serve in local government positions. On the State level, Clarke supports the idea of recording the votes of individual members of the General Assembly at all subcommittee meetings.

Issue: Funding for State Mandated

Clarke County urges the Commonwealth to meet its full funding obligations for Constitutional Officers and their

### Positions and Jails

state mandated positions. In addition, Clarke requests that the state budget be amended to fund local and regional jails based on actual costs as determined by the Annual Jail Cost Report, published by the Compensation Board.

Issue: Land Conservation

Clarke County supports the Purchase of Development Rights program, the Tax Credit program for the donation of easements, the transferability of tax credits.

Issue: State Tax Reform, Cost and Revenue Shifting and State Year-end Surplus Funds Clarke County calls upon the Commonwealth to restructure state income, sales and use taxes to address anachronistic tax policies. Tax reform is required to help buttress the Commonwealth's General Fund that finances most core government functions and must be stabilized to meet current and foreseeable core service demands. Failure to address this need has resulted in the unfair gradual shifting of costs and the outright reduction in aid to localities to balance the state budget. With each passing year Clarke County has been required to raise real estate taxes in order to incrementally subsidize a variety of traditionally state funded (or state shared) costs (Compensation Board, Cooperative Extension, Line of Duty, Social Services and the court system for example). This cost shifting places a tremendous burden on a regressive real estate tax system. Cost shifting must stop and the tax system must be reformed to reduce the burden on the real estate tax. Action must be taken to restore "Aid to Localities".

At a minimum tax reform should meet the following criteria:

- Reduction of local dependence on the real estate tax.
- Address fairness in taxing structures and "level the playing field" to eliminate unequal treatment; for example, ensuring the collection of sales tax from internet sales thereby promoting uniformity and fairness in the tax treatment of businesses selling goods in the Commonwealth.

- Ensure equal taxing authority to towns, cities and counties. Clarke County's support for equal taxing authority is broad and includes requesting and supporting action by the General Assembly for partial measures such as authorizing the imposition of meals tax and cigarette and tobacco tax without need for referendum.
- Protection of the commonwealth's general fund and preservation for core government functions such as public education, health and human services, public safety, natural resources and environmental services. Transportation maintenance and improvements should be paid by user fees.

Issue: Water Availability Clarke County supports proactive state action in reviewing and establishing regulations and programs to ensure that localities water sources are protected and that water quantity, as well as quality be protected.
