4) Clarke County Sheriff's Office Update

Sheriff Tony Roper appeared before the Supervisors to provide updates on the following matters.

Developments with Sheriff's Office construction

- A construction time line has been established and shall be provided to the Board of Supervisors.
- Sheriff Roper will be supervising the renovation project. Bobby Levi is actively involved. The project architect is Michael Proffit.
- Project has not gone out to bid
- Project scope is still being defined. Remodeling the cells is an area for consideration.
- HVAC issues have been identified and boiler replacement is recommended.
- By consensus, the Board agreed that David Ash and David Weiss (Grounds and Maintenance Committee) will work closely with the Sheriff to finalize planning of the project and oversee implementation upon approval of the Board of the agreed upon project scope and budget.

Recent horse seizure case

- Two horses were seized from the same location / owner.
- Supervisor Byrd provided a great deal of assistance in this endeavor that occurred during the holiday.
- The euthanized horse has been picked up by Valley Protein. The County is responsible for the fee.
- The other horse is currently staying at a local veterinary clinic for evaluation and a daily board fee is being applied.
- A court hearing is scheduled for Wednesday, January 9 and Supervisor Byrd will be in attendance.
- Suni Mackall, Commonwealth Attorney, is handling the criminal case.
- Sheriff Roper will advise Ms. Mackall that the Supervisors are requesting that an Order be entered granting reimbursement to the County for expenses associated with the matter. Chairman Hobert suggested an Order or Judgment could be a lien on the real property of any responsible party.
- Supervisor Byrd will attempt to determine the value of the remaining horse.

Expansion of Farm Act

Chairman Hobert reviewed the following proposed resolution opposing HB1430.

Resolution Expressing Opposition To HB1430 2013-01R

Whereas, Clarke County has a well-documented history of vigorously supporting its agricultural industry and the rights of its farming community, and

Whereas, HB 1430, introduced by Del. L. Scott Lingamfelter, proposes to curtail local zoning authority to regulate commercial activities in agricultural areas by extending Virginia Right to Farm Act protections to retail-based activities accessory to agricultural operations that include sale of art, literature, artifacts, furniture, food, beverages, and other items, and

Whereas, HB 1430 would also impose penalties on county elected officials and employees who attempt to enforce local zoning ordinances that may conflict with this proposed regulation by holding such officials personally liable for such enforcement actions, and

Whereas, Code of Virginia regulations currently do not consider such retail-based activities as exclusively agricultural in nature and currently allow local governments to determine their permissible use in agricultural areas in conjunction with zoning and land use powers, and

Whereas, HB 1430 fails to express a compelling public need that would be addressed by permitting this expansion of the Right to Farm Act and also fails to provide clear delineation of how these uses must be related to the agricultural operation in order to achieve the intended protections.

Now therefore be it resolved that the Clarke County Board of Supervisors expresses its unequivocal opposition to HB 1430 on grounds that it represents an unsupported erosion

of local zoning authority and lacks clear language and explanation as to its relationship to the preservation of agriculture in the Commonwealth.

Be it further resolved that the Board is concerned that any expansion of the Right to Farm Act beyond traditional agricultural protections and into unrelated commercial activities will threaten the viability and legitimacy of the Act into the future.

State Proposed Pay Increase for Education Employees

Supervisor Staelin requested Board discussion on the Governor's proposed pay increase for education employees. He put forth that in FY2012 Clarke County had given an additional 2% above the state-mandated 5% increase. He stated that while he did not support mandating salary increases if it were passed than there should be some consideration given for raises given within a specified period such as the biennium.

Following discussion, by consensus, the Board agreed to task Chairman Hobert with preparing a letter expressing the County's position and to share the letter with VACo.

2.2-3700 The Virginia Freedom of Information Act

Supervisor Staelin drew the Supervisors attention to the following bullet on page 53 of the meeting packet.

2012 FOIA LEGISLATIVE UPDATE

 Provides that a member of a public body shall be permitted to attend a closed meeting held by any of its committees or subcommittees, provided such member does not participate in any discussions held by the committee or subcommittee conducting the closed meeting. The bill requires that the minutes of the committee or subcommittee include the identity of such member who attended the closed meeting. HB 480 (Albo) amending § 2.2-3712;

Specific Code Cite: § 2.2-3712. Closed meetings procedures; certification of proceedings. Virginia Freedom of Information Act (FOIA); attendance by certain members in a closed meeting. Provides that a member of a public body shall be

permitted to attend a closed meeting held by any of its committees or subcommittees, provided such member does not participate in any discussions held by the committee or subcommittee conducting the closed meeting. The bill requires that the minutes of the committee or subcommittee include the identity of such member who attended the closed meeting.

HB 480 (2012 Acts of Assembly, c. 428).

Following discussion, by consensus, the Board agreed, if they had any doubt, to refrain from attending closed sessions until legal opinion was rendered; and further, the Board requested clarification from the County Attorney as to the applicability of this legislation, particularly with regard to Board members serving as "liaison" to a committee, board or authority.
