- Explanation of first paragraph on Page 16 re schools.
- o Explanation of Effective Rate referenced in Table 4.
- Explanation of Page 20 how number were calculated Clarke County budget or industry standard.
- o Explanation of plan referenced on Page 22.
- o Change first bullet on Page 23 from "annual" to semi-annual.
- Check amount of land in easement against figure noted on Page 30.
- o Provide Mr. Siegel with a corrected list of interviewee names.
- Items Requiring Follow Up Tom Judge:
  - o Review Appendix C Clarke Budget to determine reasonable cost.
  - Review the figures provided in the report to ensure accuracy.
