At a regular meeting of the Board of Supervisors of Clarke County, Virginia, held in the Board of Supervisors Meeting Room, 2nd Floor, Clarke County Circuit Courthouse, Berryville, Virginia on Tuesday, February 24, 2009.

Call to Order

Chairman Staelin called the meeting to order at 5:30 p.m.

FY10 Budget Discussion

Tom Judge distributed a revised packet for review and discussion at the work session.

- Subsequent to meeting with the Sheriff, \$75K in court fines and forfeitures was restored to revenues. Chairman Staelin instructed Tom Judge to recheck with the Sheriff for clarification.
- The Planning Director was conservative on estimation of engineering fees; and upon review of expenditures fees, fees were adjusted up \$20,000.

- Machinery and Tools, based on book value, have been reduced \$32,792.
- Deficit at this time is (\$415,372). There was discussion on how the budget could be balanced and deficit remedied including the use of undesignated fund balance or through tax increase.
- There was discussion on the use of pay-as-you-go funds.
- There was discussion of the allocation of general fund non-categorical shortfall.
- Departmental budgets were reviewed. David Ash put forth that funding for part-time salaries was used to cover shortfalls, which could create issues if the policy is not adhered to or if an unforeseen need arises.
- Vice Chairman Hobert expressed concern regarding reduced funding for Economic Development and suggested that these duties be reassigned to a designated member of current staff.
- Chairman Staelin encouraged fellow members to review and provide feedback on the proposed budget.
- Chairman Staelin requested that Tom Judge confirm communications tax, tax on wills, courthouse security fees and animal license fees.
- Tom Judge explained the Proposed Budget By Category Report followed reviewed and discussion.
- The Supervisors reviewed the U.S. Economic Forecast from Wachovia with a focus on forecasted light vehicle sales.
- The proposed FY10 personal property rate is \$5.02. Chairman Staelin suggested advertising the amount being picked up by the State.
- The goal for this budget is to set the figures to make no more than \$300,000 less. Chairman Staelin said that he would like to see the Supervisors pass a resolution establishing this goal, basing the forecast on calendar year tax collections.
- A Work Session was tentatively set for 5:30 p.m. on March 5, 2009.
- The Joint Administrative Services Board will review employee health benefits on Monday, March 2.
