#### Citizens Comment Period

<u>Don Locke, Piedmont Environmental Council</u>, appeared before the Supervisors on behalf of the Council to offer praise and support on the occasion of the 30<sup>th</sup> anniversary of passage of legislation adopting sliding scale zoning.

#### **VDOT**

Jerry Copp – Maintenance and Operations Items and Residency Administrator and Ed Carter – Six-Year Plan Programs and Enhancement, Recreational Access, with Charlie Monroe – Area Maintenance Superintendent, appeared before the Supervisors to provide the monthly update.

- Maintenance work accomplished since last Board meeting:
  - Completed mowing operations on 75% of secondary routes and primary routes 7 & 50.
  - Conducted milling and paving operations on primary routes and trimmed brush from signs on primary routes.
  - Removed hazardous trees along routes 340, 651, 633 and 601; There are two
    trees remaining on route 636 that we are waiting on colder weather due to bee
    infestations.
  - Began scraping on various non-surfaced routes.
  - Conducted our snow removal dry run in preparation for winter.
  - Performed sidewalk repair in the Town of Berryville.
  - Completed repairs on shoulders of Route 340 North by cigarette store.
- Maintenance work planned for the upcoming month:
  - o Complete moving operations on secondary routes and route 340 south.

- Repair shoulders along route 761 and various primary routes.
- o Continue scraping operations on non-surfaced routes.

# Other Projects of interest:

- Rt.604 Ebenezer Road The design engineer has completed the box design and we are in the process of recalculating our construction estimate and are beginning affected property owner contact. It is still our plan to begin construction this fall. Jerry Copp explained that speed limits for this section shall be reviewed and posted.
- Mosby Boulevard We have received the consultant's preliminary plans. The preliminary field inspection plans have been received and a meeting to review comments is scheduled for November 2.
- Rural Rustic Program Ed Carter distributed, reviewed and answered questions on the Rural Rustic Road Program. The Supervisors expressed concern about raising citizens' expectations when funding was not available.
- Supervisor Comments and Requests:
  - Supervisor Byrd presented a request from the Clarke County Library Advisory Council for larger / better Government Center signage.
  - Supervisor Byrd requested repair of shoulders on Summit Point Road.

At the request of Chairman Hobert, action to set public hearing was held until all matters were presented.

## Set Public Hearing: Zoning Map Amendment (Rezoning) RZ-10-01

E. Alexander Lee and Monica Villegas request an amendment of the County Zoning Map of 0.0868 acres so as to rezone from Neighborhood Commercial (CN) to Rural Residential (RR) on a portion of Tax Map Parcel 30A-((A))-33), located at 24 Tannery Lane, Greenway Magisterial District. RZ-10-01

Chuck Johnston reviewed the request to amend the County Zoning Map.

## Set Public Hearing: Text Amendment TA-10-07

The Clarke County Planning Commission recommends the amendment of the Zoning Ordinance:

- Sections 3-A-1-a-1, 3-A-2-a-1, 3-A-3-a-1, Special Uses in the AOC, FOC, and Rural Residential Zoning Districts so as to delete 'Assisted Living Facilities',
- Sections 3-A-1-a-2, 3-A-1-a-2, 3-A-1-a-2 Accessory Uses and Structures in the AOC, FOC, and Rural Residential Zoning Districts so as to allow a 'Temporary Family Health Care Structure',

- Section 3-C-2, Supplementary Regulations for uses in Various Districts so as to establish regulations for a 'Temporary Family Health Care Structure' and to delete the reference to Assisted Living Facilities in the supplemental regulations for Home Occupations,
- Sections 9-B-13, definition of the term 'Assisted Living Facility' so as to delete this term,
- Section 9-B-60, definition of the term 'Single Family Dwelling' so as to include the term 'Assisted Living Facility' as defined in Virginia Code Section 15.2-2291 so that Assisted Living Facilities (for up to eight individuals with mental illness, mental retardation, or developmental disabilities or no more than eight aged, infirm or disabled persons, and with one or more resident counselors or other staff persons) to be considered residential occupancy by a single family and to not have conditions more restrictive than those imposed on residences occupied by persons related by blood, marriage, or adoption. TA-10-07

Chuck Johnston reviewed the proposed changes explaining that, while unrelated, these were now mandated by state legislation.

## Set Public Hearing: Text Amendment TA-10-08

The Clarke County Planning Commission recommends the amend of the Zoning Ordinance:

 Section 9-B-176, definition of the term 'Tract', so as to add a phrase to state that if a tract is divided by a public road is located totally in the ten-year floodplain, then the parcel shall be considered a single tract.

Chuck Johnston reviewed the proposed amendment to the Zoning Ordinance. In response to queries regarding "takings", Mr. Johnston was instructed to seek clarification from Robert Mitchell.

#### Set Public Hearing: Text Amendment TA-10-10

The Clarke County Planning Commission recommends the amendment of the Subdivision Ordinance:

- Section 4-G-7, so as to label this section as 'Term of Validity of Preliminary Plats' and replace the current text with language consistent with Virginia Code Section 15.2-2260- F&G and
- Section 1-C-1, Recordation of Plats, so as to shift this section to a new section 4-K, Recordation of Plats, under Section 4, Procedure for Subdivision Approval.

Chuck Johnston reviewed the proposed amendment to the Zoning Ordinance.

Set Public Hearing: CC-10-06 Chapter 175 Vehicles and Traffic 175-11 Reimbursement of Expenses Incurred in Responding to DUI and Other Traffic Incidents

The Clarke County Board of Supervisors will consider the amendment of the Code of Clarke County Chapter 175 Vehicles and Traffic 175-11 to correct content and typographical errors, to

more closely track the language of the enabling legislation, and to update the flat fee amount from \$250 to \$350.

David Ash advised that the change proposed was for the purpose of clarification and to update County Code with state legislation.

Set Public Hearing: Amend 2006 VPSA Bond Resolution to Authorize Use of Funds on Additional School Projects

"Be it resolved that public hearing be set for Tuesday November 16, 2010, at 6:30 pm or as soon as the matter may be heard, to consider whether funds borrowed from the Virginia Public School Authority for the purpose of constructing a new high school, which are over and above the amount needed to construct the new high school, may instead be used in the renovation of other school buildings."

Tom Judge reviewed the request to re-purpose the VPSA funds for other school projects and distributed a resolution passed by the Clarke County School Board at their October 18, 2010 Regular Meeting titled Resolution Requesting and Consenting to the Use of Bond Proceeds for Additional School Purpose.

Supervisor Byrd moved to set for public hearing on November 16, 2010 at 6:30 pm or as soon thereafter as the matter might be heard the following matters:

Scheduling and follow-up support is also requested.

# Personnel Policy Revision

<u>Personnel Committee comments October 12, 2010</u>: The committee recommends the revision of the Procurement Policy to provide authority for the CAO to authorize exceptions to the policy when, in his opinion, a reasonable explanation is provided, and the addition of policy statements providing guidance in the event of temporary and contagious illness occurring in the workplace.

As a Consent Agenda item, the Board approved the proposed changes at the regular meeting.

## Work Session

Zoning Ordinance Text and Map Amendment

<u>Work Session comments October 12, 2010</u>: After discussing the proposed text changes with the Planning Commission representatives, the Board asked that the Planning Commission review, revise and return the proposal for the Board to consider.

No action was taken during the regular meeting.

#### Legislative Priorities Review and Update

<u>Work Session comments October 12, 2010</u>: Supervisor Staelin proposed the Board consider adding to the priority list a position on Water Supply Planning stating that "Clarke County believes that science, rather than power politics, should govern the approval process of the local and regional water supply plans (to be completed in 2011).

Moreover, it is important that the targets set in the minimum in stream flow studies of the Shenandoah River be honored so as to protect both the aquatic life in the river and the recreational use of the river."

Supervisor Staelin recommended the Board consider a position on TMDL subsequent to the impact of that regulation becoming better understood.

It was also suggested that the Board support raising the limits on fees recovered from the disposal of Biosolids and that the Board strengthen its opposition to shifting education and transportation costs from the state to the localities, as well as opposed reductions in compensation board funding.

Following discussion during the regular meeting, the Supervisors agreed that the document was a work in progress.

Vice Chairman Weiss contributed that the Farm Bureau continued to hold the same policy in support of TMDL. He also informed the Board that Cooperative Extension had been directed by the state legislature to review itself and to return to its core mission. In response, Cooperative Extension is now in the final stages of preparation of its own report featuring a shift toward a regional focus.

Supervisor Staelin commented on the privatizing of liquor stores. He briefly reviewed the regional 30-year water plan. Supervisor Dunning contributed that efforts to protect the Chesapeake Bay were important.

Supervisor Staelin moved to accept the 2011 Legislative Priorities as drafted with the addition of "reasonable cost" to TMDL. The motion was approved by the following vote:

Supervisors meeting. The Board also tentatively established December 13 at 10:00 am as the date for the Board of Supervisors December Board meeting.

No action was taken during the regular meeting.

# Special Event Permit Fee Revision

Work Session comments October 12, 2010: The Board directed that the fee schedule for special events be revised to change the proposed fee for subsequent year medium and large events to \$100 per year; to add a fee of \$100 for reviewing or revising any previously approved event, with said review to be performed by the initial approving authority; to clarify that any change in the size, scope, date, location or change in ownership of property or management of the event constitutes cause for review; to clarify that the fees paid are non-refundable and not transferable to other activities, and, to require that any applicant approved fro more than a single event be required to sign an agreement prepared by the County attorney agreeing to the conditions above and further agreeing to provide the County Administrator with written notice containing the names and current contact numbers of all event management personnel, vendors, caterers, public safety providers and contracted services not less than 30 days in advance of each subsequent event.

The Board also authorized refunding of any fees in excess of the amount listed above previously paid for future events.

During the regular meeting, David Ash reviewed the Board discussion from the October 12, 2010 Work Session.

Supervisor Dunning stated that he did not support proposed change and moved to strike approval of applications for multiple years and to strike reduction of fees for multiple years.

Supervisor Staelin put forth that it was his understanding that the Supervisors had the right to stop an event if an applicant failed to comply with the approved permit. He stated that all the multi-year events approved by the Supervisors have been previously approved and have a proven track record.

Vice Chairman Weiss opined that multi-year permits were simpler for staff, as well as the applicant.

Supervisor Dunning withdrew his previous motion.

Supervisor Dunning then moved to limit approval to two years multiple year requests with no fee reduction associated with subsequent years.
