Citizens Comment Period

<u>Tom Nolan</u>, requested time on the February 19, 2008 Board of Supervisors Regular Meeting Agenda to make an oral presentation on the Composite Index.

Chairman Staelin affirmed the addition of this item on the February 19, 2008 agenda.

<u>Marie Applewood</u>, expressed concern for the progression of the County. She put forth what she perceives as a need for wireless internet service opining that this was a professional community that needed to keep up with technology.

Ms. Applewood provided David Ash with contact information for ComCast, a cable provider.

Chairman Staelin responded that in conversations he has had with other similar providers he knew that there were certain thresholds that must be met.

<u>Chuck Johnston</u>, White Post Village Association board member, spoke in support of wireless internet service.

Mary Flagg, Clarke County resident, added her support for wireless internet service.

David Ash interjected that he and Michael Hobert have had discussion regarding wireless internet service with Mark Bayliss, Visuallink – an internet provider, who showed little interest in pursuing the matter.

Chairman Staelin asked staff to include wireless service in the Supervisor's goal setting discussions.

VDOT

Jeff Lineberry, with Bob Childress and Charlie Monroe, provided the monthly update from the Virginia Department of Transportation.

Maintenance, Construction Updates and Supervisor Concerns,

- Shoulder work resulting from paving problems continues on Route 340.
- Clean up from the windstorm continues on Route 601.
- Grading of non-treated surfaces continues.
- Response to snow storms continues including the brief snowfall this morning.
- Speed zone review requests are still in process.
- Signal studies on Route 340 and Business 7 is in process with speed samples to be taken at the end of January to determine if they meet warrants for signalization. Mr. Lineberry stated that he would take the concerns expressed by the Supervisors back to the engineers who performed the study.
- The intersection of Route 340 and Route 723 in Boyce did not meet signalization warrants.
- Flashing lights will be added to Route 340 at Senseny Road.
- Bob Childress asked to be included on the Work Session Agenda for the Secondary Sixyear Plan on February 11, set public hearing on February 19 and public hearing on March 18 in the afternoon.
- Supervisor Byrd provided pictures of the culverts on Russell Road. Charlie Monroe advised that he had reviewed and any remediation would have to go through VDOT's environmental group.
- Supervisor Byrd praised VDOT for doing a good job on Clarke County roads.
- Supervisor Byrd requested that VDOT give her three dates they would be available to meet with residents on Allen Road.
- Jeff Lineberry stated that studies on Stringtown Road are still on the list.
- Vice Chairman Hobert asked VDOT to look at the crosswalk at Hermitage and Buckmarsh.
- Bob Wade, Planning Commissioner, put forth speeding and other safety concerns on Route 7 going west.

Public Hearing PH 08-01 Grant of Right-of-Way to the Potomac Edison Company

The Clarke County Board of Supervisors proposes to grant a ten-foot wide right-of-way to the Potomac Edison Company [dba Allegheny Power] along northern property line of the site of the new Berryville-Clarke County Government Center (Tax Map Parcel 14A5-((A))- 65), which is jointly owned by the Town of Berryville and Clarke County. This easement would be approximately eighty-five feet in length and will accommodate the electrical service from an existing electric pole to a new transformer. This easement is necessary to provide electrical service to the Berryville-Clarke County Government Center.

The Berryville Clarke County Government Center Construction Committee members David Ash, County Administrator, and David Weiss, Supervisor Buckmarsh / Blue Ridge District, reviewed the requested easement.

At 2:15 p.m. Chairman Staelin opened the public comment portion of the public hearing. There were no persons present wishing to comment therefore this segment of the hearing was closed.

Clarke County Public Schools Update

Robina Rich Bouffault, Chair - Clarke County School Board, appeared before the Supervisors to provide an update on Clarke County Public Schools. Chairman Staelin welcomed Ms. Bouffault and extended the Boards' congratulations. He put forth that the Supervisors were hoping for greater communication with the new School Board and regular monthly updates. Mrs. Bouffault concurred.

The following are highlights of Ms. Bouffault's update:

- John Taylor, interim Superintendent, is settling well and is meeting with faculty.
- The School Construction Committee will have its first meeting January 16.
- Both Alton Echols and Beverly Byrd have given written permission to have testing done on their respective properties including cost feasibility studies. Results from previous studies of the Byrd site will be used. A progress report is expected in time for the February 4 School Board Meeting. The School Board's goal is to have all tests completed prior to the end of June 2008.
- There is still no response to the Schools or the Planning Department from the Salvation Army or their agents, PHR+A.
- The Construction Committee is gathering and reviewing documents with the contracts prior to authorizing payments.
- Vice Chairman Hobert advised that the contracts need to be protected and that if there
 was a breach of the contract it should be pursued. Mrs. Bouffault responded that the goal
 was to have review and comment completed by the end of March.
- CAD files will be provided for the site.
- The School Board would like to explore the creation of a joint maintenance service to maximize efficiencies.

Chairman Staelin requested staff provide letters of acknowledgment to Principal Susan Catlett at Boyce Elementary School for receiving the Board of Education's VIP Excellence Award and Principal Brenda Jones at D.G. Cooley Elementary School for receiving the Board of Education's VIP Competence to Excellence Award.

Collection and Expense Reimbursement

Payment of all applicant fees and charges shall be made to the Treasurer of Clarke County at the time of application for actions pertaining to zoning and subdivision matters. Fees and expenses for professional consulting services deemed necessary by the Board of Supervisors, Planning Commission, or other review boards for the evaluation of applications shall be reimbursed to the County at cost. The County may require a deposit for professional consulting service fees to be paid at application submittal.

Fee Waiver

The Board of Supervisors may waive fees in whole or in part for hardship or other unique reasons justifying relief. The Board of Supervisors or Planning Commission, at no cost to the landowner, may initiate zoning Ordinance Amendments. The Board of Supervisors has granted waivers for the following circumstances:

- 1. Zoning Application for housing for low/moderate income elderly citizens developed by a non-profit entity;
- 2. Zoning Applications for volunteer emergency service provider uses;
- 3. Zoning Applications for municipal water storage uses;
- 4. Zoning Applications for County-owned recreational uses; and
- 5. Special Use Permit and Site Plan Applications for nursery, day care, or pre-school uses operated by a non-profit entity in an existing structure.

Refund

Republication Costs

If the County has published a request in accord with public notice requirements and the applicant fails to meet their obligation for providing notice by posting signs and/or sending legal notice to adjoining property owners, the additional costs of republishing the request shall be paid by the applicant in addition to standard fees paid.

Update on Compensation and Classification Study

David Ash advised the Personnel Committee that the draft report had been returned to the consultant for revision of several key components and that the consultant would be available at the February Committee meeting to review the document and the consultant's recommendations. The Consultant will also plan to be available at the February 19 BOS meeting to present the recommendation to the Board. Chairman Staelin advised Mr. Ash that he and Supervisor Byrd would work with him on an alternate date for review by the Personnel Committee.

USGS Status Report on Ground Water Study and Proposal for Continuation

David Nelms provided the Board with an update on the status of the Ground Water project in Clarke County, identified information and/or trends that can be helpful to the Board in adopting ordinances or regulations benefiting the health, safety and welfare of the public and provided the Board with a proposal identifying the benefits and costs of continuing the project for another year.

Discussion is recorded in the January 7, 2008 Organization Meeting & Work Session minutes.

Update on status of HOME Consortium Program

Due to time constraints, this item was moved to the January 15, 2008 regular meeting.

Finance

Budget Calendar Update

An update of the budget calendar was distributed that included adjustments based on input from the Board of Supervisors since their last meeting. The Finance Committee recommends the adoption of the proposed calendar with the understanding that it can be further modified should the need be presented.

Supervisor Weiss asked that the evening Work Session times be moved from 5:00 to 5:30 pm.

Waterloo Agreement

Mike Legge provided a memorandum describing action taken by the Clarke County Sanitary Authority with respect to the Waterloo agreement. The Finance Committee recommends implementation of the proposed settlement as soon as possible with the understanding that doing so will halt the accrual of interest on the part of the investors and that the County will have to wait until such time as payments for new connections are made to receive payment.

Tom Judge provided a short summary advising that no additional appropriation would be needed.

Composite Index Research

Results of an investigation into the source of the increase in the composite index were reviewed. The Finance Committee recommends that Board Members support representatives in the General Assembly who are working to change the composite index so as to avoid this adverse condition caused by such a small number of individuals.

Chairman Staelin stated that he had spoken with Delegate Joe May regarding this matter today; and it is anticipated that he would be monitoring this in the General Assembly. Further, Senator Jill Vogel has proposed a new bill that would change the process.

Tom Judge stated that there is still some hope that a small adjustment could be made for land in conservation easement at its use value.

View Engineering

The Finance Committee recommends staff continue contract negotiation efforts to resolve this matter as discussed. There is a desire to hire an engineer for School construction matters and View Engineering is being considered.

Clarke County Historical Association

Robert Levi, Maintenance Director, met with Ms. Lee and is preparing a cost estimate for the desired work and will have it available by the date of the meeting provided some additional information regarding fixtures etc is provided. The Finance Committee recommends a supplemental appropriation of \$38,979 to the Clarke County Historical Association with funds to come from those designated as Government Savings.

Following review, Supervisor Dunning moved to adopt the resolution "Be it resolved that FY 08 budgeted expenditures for the Clarke County Historical Association be increased \$38,979, and the same appropriated, for the purpose of donating toward the purchase of a media product describing land use in the County, and be it further resolved that the fund balance designation for government savings be reduced in the same amount."

Sheriff's Request to employ Replacement Deputy

The Sheriff has notified me that he will be losing an employee in April. A replacement will have to attend basic training for approximately 4 months. The Sheriff is requesting the Board authorize employment of the replacement immediately so that he/she may attend basic training while the current deputy is still employed.

The Finance Committee recommends approval of the Sheriff's request to hire an additional deputy in order to allow him to send the deputy to basic training in anticipation of the retirement of a current deputy in April. Funds to come from those already available in the sheriff's budget provided that the Board understands he will be using overtime funds that could be needed should some unanticipated event occur.
