The Board of Supervisors of Clarke County will conduct a public hearing in the Berryville Clarke County Government Center Main Meeting Room, 101 Chalmers Court, 2nd Floor, Berryville, VA, on Tuesday, July 21, 2020, at 6:30 pm to hear public comment on the following matters:

PH 2020-03: CC-2020-01 Chapter 165, Article XVIII: The Clarke County Board of Supervisors shall consider amending Clarke County Code Chapter 165 Article XVIII Assessment of Court Costs for Courthouse Security § 165-81. Fee imposed collection, use – in accordance of the Code of Virginia to allow for the increase of court security fee for persons convicted in Clarke County District or Circuit Court from \$10 to \$20 effective upon passage.

PH 2020-04: Relocation or Change, by Agreement, of Boundary Line between Clarke County and Warren County: Pursuant to Virginia Code Section 15.2-3106 et seq., to relocate or change, by agreement, the boundary line between Clarke County and Warren County, so that such portions of those parcels which are currently located in Warren County according to the boundary line established by Chapter 20 of the 1835-36 Acts of the General Assembly, creating Clarke County, and which are currently designated as Clarke County Tax Parcel Number 37A1-3-26A, Clarke County Tax Parcel Numbers 37A1-3-27, Clarke County Tax Parcel Number 37A1-3-28, Clarke County Tax Parcel Number 37A1-3-29, Clarke County Tax Parcel Number 37A1-6-30B, Clarke County Tax Parcel Number 37A1-3-31A, Clarke County Tax Parcel Number 37A1-3-32, Clarke County Tax Parcel Number 37A1-3-33, Clarke County Tax Parcel Number 37A1-1-39, Clarke County Tax Parcel Number 37A3-A-A, Clarke County Tax Parcel Number 37A3-A-B, Clarke County Tax Parcel Number 37A3-A-C1, Clarke County Tax Parcel Number 37A3-A-D, Clarke County Tax Parcel Number 37A3-A-E, Clarke County Tax Parcel Number 37A3-3-A1, Clarke County Tax Parcel Number 37A3-3-B2, Clarke County Tax Parcel number 37A3-3-C1, Clarke County Tax Parcel 37A3-3-C2, Clarke County Tax Parcel Number 37A3-5-45, Clarke County Tax Parcel Number 37A1-3-25, and Clarke County Tax Parcel Number 37A1-3-26 would be wholly contained within Clarke County.

Such portions which are currently designated as Warren County Tax Parcel Number 7A-6-44 and Warren County Tax Parcel Number 7A-3-63 would be wholly contained within Warren County.

Whole parcels currently designated as Clarke County Tax Parcel Number 37A1-1-39, Clarke County Tax Parcel Number 37A1-1-38, Clarke County Tax Parcel Number 37A1-1-37, Clarke County Tax Parcel Number 37A-1-36, Clarke County Tax Parcel Number 37A1-1-35, Clarke County Tax Parcel Number 37A1-1-34, Clarke County Tax Parcel 37A1-1-33, Clarke County Tax Parcel Number 37A1-1-32, Clarke County Tax Parcel 37A1-1-31, Warren County Tax Parcel Number 7A-3-64, Warren County Tax Parcel Number 7A-3-66A, Warren

County Tax Parcel Number 7A-3-33, Warren County Tax Parcel Number 7A-3-32, Warren County Tax Parcel Number 7A-3-1, Warren County Tax Parcel Number 7A-3-2, and Warren County Tax Parcel Number 7A-3-3 would be wholly contained within Warren County.

Whole parcels currently designated as Warren County Tax Parcel Number 7-8 would be wholly contained within Clarke County.
