**Meeting of the Clarke County Electoral Board  
November 3, 2021  
2<sup>nd</sup> Floor Conference Room**

1. The meeting of the Clarke County Electoral Board was called to order at 10:07 by Chairman, Randy Sprouse. Also present were Vice Chair-Darryl Glenney, Secretary-Carol Westervelt and General Registrar-Barbara Bosserman.

Observers present:

- Mark Tate, Clarke County Republican Chairman
- Zach Pruckowski, 10th District Democrat Chairman.
- Abiel Alvarenga, Republican Party of Virginia

The purpose of this meeting is to conduct the canvas of the election held November 2, 2021.

2. Provisional ballots were examined first. The decision was made to hold any provisional ballots approved to be counted until the Board reconvenes on Friday, November 5, 2021.
  - Russell Precinct: 4 Provisional Ballots
    - Three of the provisional ballots were for voters who had applied for an absentee ballot, but did not have the ballot with them.
      - Will wait until after 12 noon on Friday November 5<sup>th</sup> to allow time for the absentee ballot to be returned. If not returned, the ballots will be counted.
    - One was cast by a voter who was at the wrong precinct and confused with a voter on the pollbook with the same name having been issued an absentee ballot.
      - The decision was made to count the provisional ballot.
  - Pine Grove Precinct: 1 Provisional Ballot
    - Shown on the pollbook as already having voted
      - Precinct Chief attached an Incident Report stating he believes another voter was checked-in in error causing the confusion. The decision was made to count the provisional ballot.
  - White Post Precinct: 1 Provisional Ballot
    - Voter applied for an absentee ballot, but does not have the ballot
      - Will wait until after 12 noon on Friday November 5<sup>th</sup> to allow time for the absentee ballot to be returned. If not returned, the ballots will be counted.
  - Buckmarsh Precinct: 1 Provisional Ballot
    - Voter applied for an absentee ballot, but does not have the ballot

- Will wait until after 12 noon on Friday November 5<sup>th</sup> to allow time for the absentee ballot to be returned. If not returned, the ballots will be counted.
3. The Statement of Results for all precincts, including Central Absentee Pre-processed, Election Day and Early Voting, were reviewed for accuracy. No corrections were necessary. Great Job!

  - All SORs and tapes were signed

The meeting was recessed until 3:30 P.M., Friday, November 5, 2021 to allow the required time for absentee ballots postmarked on or before election day to be returned and processed by the Central Absentee Precinct.

Also present were Chair-Randy Sprouse, Secretary-Carol Westervelt and General Registrar-Barbara Bosserman.


1. The Statement of Results for Central Absentee Precinct – Post Election was reviewed and accepted.


The next meeting will be February 3, 2022 at 10:00 AM.
