1) Call to Order

Chair Weiss called the afternoon session to order at 1:00 pm.

# 3) Citizens Comment Period

No persons addressed the Board.

# 4) VDOT Update

Ed Carter, Resident Administrator, provided the following update:

- Maintenance activities this past month have been primarily dedicated to snow and ice removal activities and storm debris removal.
- We did some hazardous tree removal on various routes and plan to continue this month.
- We started brush trimming on Boom Rd. and will continue as well as on Bishop Meade and Browntown Rds.
- We have addressed numerous potholes and expect many this month with the extreme temperature swings.

# Board Issues:

 We are addressing shoulder concerns on Stringtown Rd. As soon as the weather warms, work will commence.

## Vice-Chair Terri Catlett

- Asked when the intersection at Route 601 and Hwy. 7 would get attention. Ed
   Carter informed the Board that VDOT received three proposals. This week,
   there is a meeting to discuss the proposals and put together cost estimates.
   Once that happens, VDOT will come to the Board for input.
  - Chair Weiss asked how much influence the Board has? Ed Carter said if the Board is vehemently opposed, the intersection can stay as it is; adding funding would still need to be sourced before any work could begin.
  - Vice-Chair further asked if there were any comparable projects? Ed
     Carter confirmed various similar projects across the state and will get
     that information for the board once a proposal is recommended.

 Supervisor McKay asked if the Federal government would help fund a project like this? Ed Carter stated he could not say for sure, adding with the Infrastructure Act and the different pots of money, he was unsure what funding they could get.

# **Chairman David Weiss**

- Asked where Route 7 Safety Implementation Study was at in the process? Ed
   Carter stated that a status report could be provided at the next meeting.
  - Chris Boies offered the option of VDOT attending a work session to discuss. Ed Carter replied that he is happy to visit when convenient for the Board.
  - Supervisor Lawrence asked if the Old Charlestown Bridge could be added to a work session agenda, further asking if any feedback had been received? Ed Carter stated the most pushback received was with the detour route. VDOT is currently getting quotes from suppliers to see if the construction season can be shortened by using one long bean instead of two short beams. The concern was that a long beam could not get delivered down the road, or the crane could not be placed in a position to safely move the beam. If VDOT can get one beam instead of two, the construction cycle could possibly be shortened from two years to one year.
- 5) Economic Development and Berryville Main Street Updates

Felicia Hart, Director of Economic Development and Tourism, presented the following:

## **Economic Development**

- Broadband Our VATI grant for universal broadband coverage in Clarke
  County was approved by the State. Participated in a VATI conference call
  with the Department of Housing and Community Development (DHCD) and
  all participating localities to get an overview of the contract
- I continue to work one-on-one with the Lord Fairfax Small Business
   Development Center. Numerous (9) local business introductions have been made, which the LFSBDC has immediately followed up with.
- Met with the owner of the LGV group and his property manager. I've since made numerous introductions, including local businesses, local realtors, EDAs in Winchester and Frederick County, along with introductions to the Lord Fairfax Small Business Development Center and to both the Virginia

Economic Development Partnership (VEDP) and the Virginia Economic Developers Association (VEDA). I continue to have regular conversations with all entities regarding updates. We have a conference call with the VEDP and LGV for an interview to participate in the Economic Gardening Program (Cochran Lumber and C2Management have already participated).

- We've developed an Agritourism summit in partnership with
  Winchester/Frederick County to bring our local farmers together for a
  meet/greet. At this conference, we will be discussing their needs
  (local/state) to better determine how we can be of assistance to them. We
  have already reached out to the leadership of the Clarke County Farmer's
  Market to participate. The meeting is scheduled for February 25<sup>th</sup> at 11:00
  and will be hosted here in Clarke County at the Ruritan grounds.
  Participation is free, and lunch/materials will be served.
  - Almost 60 have signed up so far. Registration is open until Friday, February 18, 2022.
  - Vice-Chair Catlett offered her praise for the agritourism event and hopes everyone has a take-away from the event, adding she had heard from multiple constituents who are excited about the event.
- Have reached out to the group that purchased the Battletown Inn to see if I can be of assistance. I have not heard back, but it would appear that the project is on hold while owners develop a game plan after an initial walk-through with County Building Inspector.
- I continue to work closely with the Clarke County Farmer's Market to help promote their events and assist them with regional/state/federal events and potential fundings for their members.
- I continue to work closely with local realtors to get a heads up on properties that will be coming on the market soon. This allows us to work one on one with them and make introductions to appropriate potential business owners.
- I have made several introductions to property owners in the Waterloo area. These introductions are for realtors/businesses outside our area who are looking at potential properties.
- Clarke County will be represented again in the upcoming Widget Cup on April 7<sup>th,</sup> hosted in Winchester. This is a partnership between EDAs and the school systems in Winchester and Frederick and Clarke Counties. Clarke County currently holds the title.
- We are already working on the Economic Development Advisory Committee Spring Tour.

- Along with the EDA Directors for Winchester and Frederick County, I
  presented to the Top of Virginia Chamber's Leadership class. The discussion
  was on economic development and tourism.
- Clarke County Economic Development was represented at the Employer
  Expo hosted in Winchester at the War Memorial Building. In addition to my
  serving on the planning committee, Clarke County had two local businesses
  host recruiting tables at the event. The next event is scheduled for May
  25<sup>th</sup> at the same location. We are currently pushing this information out to
  our local businesses.
- Have met with the owner of Clarke Monthly to see how we can better collaborate on getting the word out about new programs/projects Clarke County is participating in and opportunities for our Clarke County citizens.
   Opportunities like the Habitat Home Repair program are out there we just need to help get the word out. Jennifer Parker with DSS has several new programs that can assist some of our citizens.
- We continue to push the "Return to Earn" grant program that reimburses companies (up to \$500) for sign-on bonuses. This is a program through the Governor's office.
- We continue to make introductions for local companies that have an immediate hiring need. Introductions include Clarke County High School, Top of Virginia Chamber, Christine Kriz at Lord Fairfax Small Business Development Center, United Way, and numerous local and state agencies.
- I continue to have monthly phone calls with representatives of the Virginia Economic Developers Association (VEDA).
- Continue to meet with Christy Dunkle for updates/catch-up.
- Continue to meet regularly with Clarke County's Planning and Zoning Directors for updates.
- I continue to regularly post upcoming events (training, meetings, etc.) on the Economic Facebook page.
- Work/talk continues regarding the water/sewer subsidiary program offered in the Waterloo area. I have made a presentation at the Blue Ridge
   Association of Realtors, have made other regional associations aware, and continue to talk with local property owners in the area about this. After a call from a local realtor, Chris and I met and talked with the Sanitary Authority about our fees and how they are determined.
- Work/talk continues on sewer/water in the Double Tollgate area from Frederick Water. Chris Boise has been regularly meeting with them to discuss the next steps.

- I continue to work directly with Shaine Coleman from Clarke County High School to make introductions to our local businesses for those students who may not be attending college. This includes working to find potential jobs in our area and also allows the students to "shadow" an employee to determine if they really are interested in that profession.
- I continue hosting weekly meetings with Frederick County and the City of Winchester EDAs. Also part of the group is Christine Kriz with Lord Fairfax Small Business Development Center and Cynthia Snyder with the Top of Virginia Chamber.
- I want to personally thank Winchester, Frederick, and Shenandoah County for taking the lead on a new "talent website." I am currently updating information for Clarke County to this new site. This site provides an overview of our area and the quality of life that we offer.
- I continue to push the Small Business Resiliency Team regional program as part of the GOVirginia this is in partnership with Lord Fairfax Small Business Development Center. This program assists small businesses with access to free marketing, financial guidance, creation of an e-commerce website, and accounting software.

#### **Tourism**

- Being aware of the disconnect between what is going on at the fairgrounds and what our local businesses know – and do not know – we have developed new relationships. I have joined the Ruritans to help bridge this gap. Lucketts Market is committed to two events this year – one in May and one in October.
  - Watermelon Pickers has already signed on.
  - HamFest is signed on.
  - Blandy Farm will host its Mother's Day Gardening Show again this year.
  - We have a two-day toy show that will be there in March.
  - We can provide the links to "Places to Stay" and "Things to Do" while their vendors and attendees are here – and share any specials or discounts local businesses would like to offer.
  - We are looking at additional signage opportunities at the fairgrounds to remind attendees of our Main Street and what else Clarke County has to offer.
  - In the process of developing a "Welcome" piece for the Ruritans to hand out to organizations who are renting/leasing fairground space.
     This handout will provide my contact information and give ideas on ways that I can assist them in not only promoting their event but

- making introductions to local businesses who can be of assistance to them.
- I am promoting the fairgrounds as a place that can be rented for outdoor/indoor events to the Northern Virginia area to help promote this space – especially with COVID restrictions. I have also made the state Tourism Corporation aware of this space.
- I continue to write blogs for state, regional, and local use.
- Our upcoming Agritourism meeting here in Clarke County on February 25th will also allow us to help our farmers learn of new opportunities to promote themselves via social media and how we can better partner to promote them regionally.
- We continue to post on the Tourism Facebook page highlighting upcoming events, places to visit, and things to do.
- Clarke County hosted space at the Virginia Welcome Center in Clear Brook,
   VA, for the month of December. In addition to the Clarke County
   marketing, numerous non-profits also had displays. This marketing allows
   Clarke County to get in front of over 40,000 visitors.
- We have expanded blog opportunities listings with the Shenandoah Valley Tourism Partnership (SVTP) and the Shenandoah Valley Travel Association (SVTA) and are sharing these with the Virginia Tourism Corporation (VTC).
- I met last week with representatives from Blandy and the Blue Ridge
   Wildlife about promoting "Take a Hike" in Clarke County. This would be a play off the existing flyer produced by the Clarke County Conservation group.
  - Supervisor Lawrences suggested adding skill levels needed for the hiking trails and clarified, with the support of Sheriff Roper, the three boat landings in Clarke County are for boat launching only, and people should not be using those areas for parking. Supervisor McKay added the land along the river in Clarke County is all privately owned.
- Distribution of the ARPA funds through the Virginia Tourism Corporation is in the works. Discussions about new rack cards, ways to promote/improve the experience at the Clarke County Visitors Center, and additional signage at the fairgrounds are topics of discussion. This is a work in progress while trying to work through VTC's new program.
- We are working closely with local photographers to share their talents/images on our Tourism website and through our social media.

- I would like to (again) acknowledge the new partnership between the Berryville Main Street Program and the Barns of Rose Hill. This partnership provides:
  - An opportunity for Clarke County, Berryville Main Street and the Barns to reach a broader audience to disseminate information in a timelier manner.
  - We already hosted our first quarterly Meet/Greets (two meetings) and had wonderful turnouts at both events.
  - O We will start hosting a quarterly Meet/Greet for new residents of Berryville and Clarke County. Our first event will be on April 11th at the Barns of Rose Hill. This will give us an opportunity to help new residents understand the Town vs. the County and what services are provided by each, introductions to our local non-profits and volunteer opportunities here in Clarke County, handouts from local businesses/organizations, and an opportunity for new residents to ask questions.
  - We have developed a social media calendar with all the national holidays and "national days." This will allow us to plan marketing around specific events. Marketing would include our three entities and local businesses and organizations to allow for an even greater audience reach.
  - We are producing Welcome Bags with information about the Town/County, coupons/ brochures from local businesses, information about local non-profits.
  - We continue the conversation about a mural program here in the Town/County. We could become part of the Appalachian Mural Trail program that would give us an even broader audience.
  - We continue to explore the opportunity to become a WonderLOVE community through the Virginia Tourism Corporation. This statewide program would give us another targeted audience.
  - The Barns just hosted their first "Dinner and a Show" event that was sold out. If an attendee provided a receipt from a local restaurant for dinner, they got a reduced rate to attend the show. We will continue to push social media between the three of us to help get the word out. Additional marketing opportunities are being explored.
  - An opportunity to produce a "Restaurant Week" program for one week during the year. This would allow us to highlight all that Clarke County has to offer, both to locals and outsiders.

- We will be looking at the production of a new rack card incorporating businesses in the Town and the County.
- Berryville Main Street will be producing its own website. This will enable the three organizations to share more information, provide links to each other's sites and provide a more cohesive message to not only our community but to our visitors as well.
- We continue exploring ways to host a "Community Calendar" on Berryville Main Street's website.
- Work is in progress to develop a "Local Love" program/campaign
- Regionally, through our partnership in the Shenandoah Valley Tourism Partnership (SVTP), Clarke County will now be a part of the Fields of Gold trail program. This was a program (mainly in southern Virginia) that our organization has taken now taken on. All farms (accepting visitors), farm markets, wineries, and agritourism businesses will be able to participate free of charge.
  - Vice-Chair Catlett asked how a farmer knows which one to choose. Felicia Hart responded to have them contact her for assistance, adding that both programs are targeted at different audiences. Chair Weiss further explained it is not for a person who doesn't have any of the public on their farm or make direct sales.
- The Farm Bureau has also initiated a new program called the American Farm
   Trail, which is free to all farms/markets that allow visitors.

Supervisor Bass thanked Felicia Hart for presenting. He has worked with Shaine Coleman at the High School to get the kids involved with local businesses.

Michelle Marino of Berryville Main Street presented the following:

#### **Our Mission**

Berryville Main Street is a non-profit organization that strives to create a strong, vibrant, and welcoming area with a unique and historical character. Through a comprehensive downtown revitalization program, we strive to strengthen the economic potential of not only Berryville's downtown Main Street but the entire region of Clarke County as well. We have made a commitment to improving the economy, appearance, and image of our downtown business district.

Berryville Main Street emphasizes the importance of working simultaneously in the following areas:

- DESIGN: Enhancing the physical appearance of our area by revitalizing historic buildings, encouraging clean and attractive storefronts and building facades, and long-term planning of upcoming projects and events that will enhance the aesthetic appearance of the Town and County.

- ORGANIZATION: Creating and managing the consensus and cooperation among the many groups and individuals who have a role in the revitalization process
- PROMOTION: Marketing the traditional commercial district's assets to customers, potential investors, new businesses, local citizens, and visitors through social media posting and collaboration with neighboring organizations/Main Streets/businesses.

#### **Our Successes**

For the past several years, Berryville Main Street has been the key organizer for multiple events throughout the year in Berryville. These events include:

- Spring and Fall Yard Sales
- Music and Dinner in the Park
- Annual Cruise-In
- Berryville Bucks
- Parking Meter Decorating Contest
- Christmas Tree Lighting Ceremony

With a new board and new leadership, Berryville Main Street has taken an even more active role in planning and implementing events this past year (2021). In just the short six months of the new board, we:

- helped organize a successful Cruise-In for August;
- worked extensively with the owner of the Luckett's Fair in coordination with community resources to help ensure the Luckett's Fair success;
- in collaboration with the Clarke County High School, encouraged and organized community and business participation in the Clarke County High School Homecoming Week celebration;
- organized the annual Parking Meter Decorating Contest;

- organized the Berryville Bucks Giveaway;
- orchestrated the annual Christmas Tree Lighting Ceremony in Rose Hill Park, making it one of the most successful and widely attended (approximately 250 people) Tree Lighting Ceremonies in the history of the Town; and
- helped organize and orchestrate the Annual Berryville Christmas Parade, with about 60 entrants and close to +500 people in attendance.

#### **Our New Events**

Building on this success, we have plans in place to host even more events throughout the year in an effort to continue to engage our businesses and community. Such events include:

- a St. Patrick's Day Scavenger Hunt,
- a Spring Clean-Up Day, and Easter Egg Hunt in Rose Hill Park,
- collaboration with Luckett's Fair,
- inaugural start-up of "First Fridays" in Berryville,
- Music and Dinner in the Park concert series,
- a 4<sup>th</sup> of July festival in downtown,

as well as an enhancement of the Holiday activities that we will continue to host. Our hope is to offer more community events to bring people together, engage local businesses and artists, and increase the economic vitality of the area.

In addition, there are certain events that will also attract tourists to the area – thus creating a huge economic boom for the county. More and more, people from the DMV area are seeking to "get away" for the weekend – a chance to come out to the country, away from the hustle and bustle of the city. What better place than Clarke County, with our numerous events like the Luckett's Fair and the annual Cruise-In, but also our small-town charm of community events like the Tree Lighting ceremony and the Christmas parade.

## **Our Initiatives**

In addition to the various events that we will be hosting and promoting throughout the year, we have also prioritized several new initiatives/projects that will revitalize the downtown area and improve our economic and aesthetic appeal.

## New Website

First, we have submitted a grant request to Clarke County for the funding of a cohesive website for Berryville Main Street. Throughout the history of the organization, Berryville Main Street has not had a website. And in an era where social media is THE key platform for marketing and advertising, the importance for a Main Street organization to have a website is even greater. Our website will

help us organize all of the businesses throughout the county in one central location, often seen under heading such as "Where to Shop" or "Where to Eat." We will also include information about upcoming events throughout the county, sponsored not only by Berryville Main Street but by our businesses and artists as well. In addition, we have plans to provide partnering links on our website to the Town of Berryville, Clarke County, and the Barns of Rose Hill, along with the Clarke County Visitors Center.

We have had discussions and implementation plans with a website developer who has helped us conceptualize our vision for a successful and appealing website. Once we have the funds in place, we will begin the production of this website.

# **Hogan's Alley Revitalization**

One of our key projects for the revitalization of the area is the Hogan's Alley project. Named after former Town Manager John Hogan (1985-1997), this project will help turn the alley into usable community space, offering relaxation, gathering, or a location for small, local events. The alley runs from Main Street to the parking lot on Crow Street, between Church and Buckmarsh streets. Plans for the alley include installing planters and iron features at the access on Main Street to make the alley more visible, installing additional planters as well as some benches throughout the length of the alley, a decorative mural of artist's rendering on one of the building walls, a decorative string of lights and a plaque denoting Hogan's service to Berryville.

We are in the process of finalizing our grant request to the Virginia Main Street Community Vitality Grants program. This grant, administered through the DHCD, is designed to assist organizations and communities in achieving their downtown revitalization goals. The DHCD welcomes projects that will create a positive impact on the downtown neighborhood's long-term goals.

# Paint the Town Mural Project

Berryville Main Street is submitting a request for funding from the Virginia Commission of the Arts for our "Paint the Town" Mural Project. We will partner with local artists and building owners to paint artistic murals on the sides of key buildings throughout town. These buildings have been identified, and plans are in place to contact and work with the building owners on the specifics of the proposed project. Public murals have the potential to make a big and lasting impression on a community. Vibrant and engaging public art can transform listless or ho-hum community spaces into thriving public destinations. Every exposed, blank wall found on the buildings and public spaces offers an opportunity to unveil an artistic creation, tell a story, shine a light on local culture, or beautify a

neighborhood with brilliant displays of art. Public art marks respect for the humanity and individuality of its community members by offering something beautiful or thought-provoking that has a non-commercial purpose. In addition, we have also identified key structures throughout the County that are in need of beautification that has been vandalized with spray paint and graffiti, and that might serve as an ideal place to display a mural.

#### Virginia's LOVEworks Program

Berryville Main Street is in the process of applying for and conceptualizing an idea for the creation of a state-funded LOVE sign to be used for a tourist attraction in the County. The LOVEworks program is a state-wide branding initiative designed to promote travel in Virginia and strengthen awareness of the "Virginia is for Lovers" message.

In an effort to extend the brand message – and after seeing the popularity of the LOVE signs created at Welcome Centers around the Commonwealth – Virginia Tourism established the LOVEwork Reimbursement program in 2013. The program was a success, with 16 LOVEworks created in the first year and travelers of all ages interacting with the structures every day. A second LOVEwork Reimbursement fund was opened in 2014 and has remained open since – and, now, more than 275 LOVEworks have been built around the Commonwealth. This Reimbursement fund will reimburse \$1500 to an entity once they create the LOVE sign.

The LOVEworks have become special places, not only for local communities but also for travelers. People are drawn to the LOVE letters and often choose them as backdrops for special occasions such as engagements, family photos, memorable road trips, and more. It is a great way for local communities to leverage the brand strength of Virginia is for Lovers to promote their own messages and unique destinations.

# Main Street Revitalization

As we mentioned earlier, we are planning a Main Street Clean Up day. Occurring early Spring (Spring Clean up theme), we will partner with businesses, building owners, volunteers from the community, and homeowners to clean and beautify Main Street. Included in this day of beautification is the spring planting and maintenance of planters along Main Street, litter and clutter clean up, storefront cleaning and decorating, and street refreshing.

#### **Fundraising**

As you may be aware, Berryville Main Street has faced a few financial hardships over the past several years. In an effort to overcome these hardships and

continue to build our financial base, we are going to increase our fundraising efforts throughout the year so that we can continue to offer more of the same types of events as described above and complete more projects that will increase the economic development of the area.

Whereas, the Code of Virginia sets forth in Title 42.1. Libraries Chapter 7. Virginia Public Records Act. § 42.1-85. Records Management Program; agencies to cooperate; agencies to designate records officer.

C. Each state agency and political subdivision of this Commonwealth shall designate as many as appropriate, but at least one, records officer to serve as a liaison to The Library of Virginia for the purposes of implementing and overseeing a records management program, and coordinating legal disposition, including destruction, of obsolete records. Designation of state agency records officers shall be by the respective agency head. Designation of a records officer for political subdivisions shall be by the governing body or chief administrative official of the political subdivision. Each entity responsible for designating a records officer shall provide The Library of Virginia with the name and contact information of the designated records officer, and shall ensure that such information is updated in a timely manner in the event of any changes.

## Resolution Designating and Publicly Identifying an Additional Freedom of Information Officer for the Clarke County Board of Supervisors

Whereas, the Code of Virginia sets forth in Chapter 37 Freedom of Information Act § 2.2-3704.2. Public bodies to designate FOIA officer:

A. All state public bodies, including state authorities, that are subject to the provisions of this chapter and all local public bodies that are subject to the provisions of this chapter, shall designate and publicly identify one or more Freedom of Information Act officers (FOIA officer) whose responsibility is to serve as a point of contact for members of the public in requesting public records and to coordinate the public body's compliance with the provisions of this chapter.

C. For such local public bodies, the name and contact information of the public body's FOIA officer to whom members of the public may direct requests for public records and who will oversee the public body's compliance with the provisions of this chapter shall be made available in a way reasonably calculated to provide notice to the public, including posting at the public body's place of business, posting on its official public government website, or including such information in its publications.

E. Any such FOIA officer shall possess specific knowledge of the provisions of this chapter and be trained at least annually by legal counsel for the public body or the Virginia Freedom of Information Advisory Council (the Council) or through an online course offered by the Council. Any such training shall document that the training required by this subsection has been fulfilled.

F. The name and contact information of a FOIA officer trained by legal counsel of a public body shall be (i) submitted to the Council by July 1 of each year on a form developed by the Council for that purpose and (ii) updated in a timely manner in the event of any changes to such information.

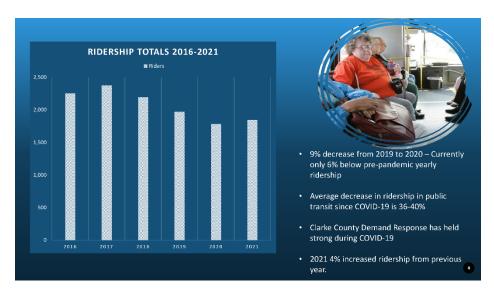


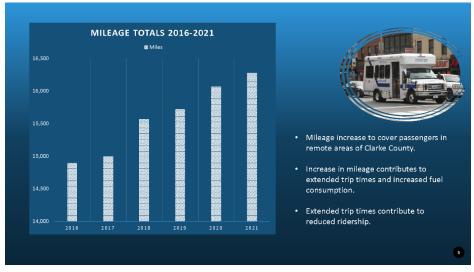

11) Joint Administrative Services Board Update

Brenda Bennett explained the following:

- The Joint Administrative Services Board met on January 24, 2022
- The 2022 meeting calendar was set.
- There was a discussion regarding the health insurance RFP, which was due back on January 25.

- Dr. Bishop, Chris Boies, and Brenda Bennett met with the health insurance consultant to review proposals adding they are currently in negotiation.
- Discussion on audit company with a decision made to retain Robinson Farmer
   Cox Associates for another year.
- Presented the Joint Administrative Services budget proposal for FY23.

Supervisor Bass asked the reason for another RFP for health insurance. Chris Boies responded the county was in a place to be able to renew automatically or request new proposals. The decision to request new RFPs was from a pricing standpoint and the quality of service, adding the option for self-service and bought plans are on the table.

# 12) Government Projects Update

Chris Boies provided the monthly project update:

- Kohn Property-Mrs. Catlett and I toured the Kohn property last week. The PATC has done a wonderful job renovating the cabin. They are now working on controlling invasive vegetation on the property. The cabin rentals start next week, and early reservation activity shows this will be a popular destination.
- Jack Enders Blvd.-Joey and his crew have been working on the punch list items for the completion of the last phase of Jack Enders Blvd. This section has not yet been brought into the town system. We are cleaning out stormwater ditches, inspecting underground culverts, and the area will receive a final coat of asphalt this spring. Upon final inspection by the town, this section of roadway will become part of the town system.
  - Chair Weiss asked if it required curb and gutter? Chris Boies clarified there is curb and gutter already in most places; one commercial entrance needs to be put in, not an extensive amount of curb and gutter work.
- We have received a draft operating agreement with Frederick Water. Brandon Stidham has reviewed the document, and we will meet soon to look over the agreement and then forward it to Bob Mitchell with hopes of getting it to the Board in March.
- Mr. Mitchell has completed a draft of the revised noise ordinance. Staff still need to review the document, and we may be able to present it to the Board at the March work session.
- We discussed with the Fire-EMS Commission last week doing a rewrite of our Emergency Operations Plan. It was decided that we would have a small

workgroup to rewrite the plan and provide periodic updates to the Commission. This is probably a year-long project.

- We also discussed with the Commission the Director of Fire, EMS, and Emergency Management job description. I am working on scheduling meetings with the employees of the department to get their input on what characteristics they are looking for in a new director and am also working with the fire chiefs on some structural changes to our governance process. I want to complete both of these tasks before we advertise the position. Don Jackson is doing a great job in the interim, so there is no immediate rush to advertise the position.
- We had a positive meeting with the Commonwealth, regional commission, and All Points Broadband on the regional broadband project. There will be a project agreement between the regional commission and All Points Broadband, an agreement between the eight counties and the regional commission, and a grant agreement between the regional commission and the Commonwealth. In the Northern Neck project, the localities all signed the same agreement. I would expect to see a draft agreement in the next month and will probably have something for the Board to approve by the April meeting. The Commonwealth requires the regional commission and All Points to develop a communications plan which I hope will assist us in getting information out to citizens about the project.
  - Chair Weiss pointed out All Points Broadband has to rely on the electric company for the middle mile.
  - Chris Boies added there is a call scheduled with All Points Broadband on February 17 to go over budget expectations. The Board has to appropriate the funds pointing out the County does not want to hold multiple Public Hearings to add supplemental funding or over budget and not deliver.
  - Supervisor Lawrence added the recent call was the first time the time frame of 48-months was discussed. Chris Boies said he hopes that includes 36-months for construction but 48-months to complete paperwork but needs to confirm that.

#### **PUBLIC HEARING**

 <u>TA-21-03</u>, Short-Term Residential Rental, Home Occupation Bed and Breakfast, and Country Inn

# TA-21-03, Short-Term Residential Rental, Home Occupation Bed and Breakfast, and Country Inn

- Amend Zoning Ordinance §5.2B (Residential Uses) and §5.2C (Business Uses).
- Purpose:
  - To establish a new "short-term residential rental" use in the AOC and FOC Districts
  - To amend use regulations for home occupation bed and breakfast uses and country inns for consistency purposes across rental uses

# **Update**

- Board of Supervisors held Public Hearing at the December 21, 2021 meeting.
- Board deferred action for one month in response to concerns raised by speakers.
- One concern was in regards to proposed maximum cap of 10 persons per lot during rental periods – includes transient renters and residents of the lot.
- Speaker was concerned with adverse impacts to property owners with multiple dwellings on lot that are occupied by permanent residents – may be restricted or precluded entirely from operating a short-term residential rental.

# Update (cont.)

- Staff presented an alternate approach at the January 18, 2022 meeting:
  - Maximum of two dwellings on a lot may be used for short-term residential rental activities.
  - Dwellings can be the main single-family dwelling and an accessory dwelling (tenant house, minor dwelling) OR two accessory dwellings.
  - · 10 person cap would be eliminated.
  - Maximum occupancy would not be allowed to exceed the capacity of the onsite sewage disposal system for each dwelling or the maximum occupancy as allowed by the building code for each dwelling.
  - Applicants must identify the specific dwellings that will be used for short-term residential rental activities.
- Revised draft also includes description of "customer" in definition and modifications to restrict "other gatherings" only to dwellings used for rental activities.
- Proposed changes require a new public hearing.

# **Background**

- Text amendment was developed in response to concerns about the absence of regulations for short-term residential rental activities via websites such as AirBNB and VRBO.
- Issues identified:
  - Addressing potential adverse impacts of unregulated short-term residential rental activities on onsite sewage disposal systems and groundwater quality.
  - Ensuring compliance with the Virginia Uniform Statewide Building Code.
  - Creating regulations that establish a "level playing field" for all commercial lodging establishments.
  - Developing new regulations within the existing ordinance framework.

## **Background -- Rental Uses Currently**

- "Short-term residential rental" -- Rental of a portion of a dwelling (one or more rooms) or rental of an entire dwelling to a customer for a period of less than 30 days
  - A "customer" can be one person or more than one person renting together as a group.
  - Not currently regulated by the Zoning Ordinance and no zoning approval is required.
- "Home occupation bed and breakfast" Home occupation where lodging and meals are provided for compensation for up to five (5) transient guests and maximum of three (3) guestrooms.
  - Allows rentals to more than one customer up to the maximum occupancy limitation.
  - Owner-occupancy is required as it is a home occupation.
  - Requires approval of a home occupation zoning permit.

# **Background -- Rental Uses Currently (cont.)**

- "Country Inn" Business offering for compensation to the public guestrooms for transitory lodging or sleeping accommodations for a period not to exceed 14 consecutive days. Maximum of 15 guestrooms. Meal service and public assembly activities are allowed as accessory uses subject to regulations.
  - A country inn is a business use that requires approval of a special use permit (SUP) and a site development plan by the Board of Supervisors following review by the Planning Commission and required public hearings.
  - Rental uses in the AOC and FOC Districts that exceed the scope of a short-term residential rental and home occupation bed and breakfast would require country inn approval.

## **Proposed Short-Term Residential Rental Use**

- A new "short-term residential rental" use would be created in the Zoning Ordinance with a definition and use regulations.
- Use would be regulated "by-right" subject to administrative approval by the Zoning Administrator.
- Short-term residential rentals would only be allowed on lots in the AOC and FOC zoning districts – prohibited in RR District.
- Rental activities in the RR District would be permissible as a home occupation bed and breakfast use – owner-occupancy during rental periods is required.

#### Proposed Short-Term Residential Rental Use (cont.)

- Rental activities may be conducted in a maximum of two (2) dwellings on a lot – single-family dwelling, minor dwelling, or tenant house.
- Rental is limited to a maximum of one (1) customer per lot.
- A "customer" may be one person or multiple people renting together under the same rental agreement.
- Limitation applies regardless of whether two dwellings on the lot are used for rentals.
- Maximum occupancy includes transient guests and residents of the dwelling used for rental activities, subject to compliance with onsite sewage disposal system and building code requirements.
- No requirement that the property owner remain onsite during rental periods.

# Proposed Short-Term Residential Rental Use (cont.)

- A <u>zoning permit</u> issued by the Zoning Administrator would be required in order to conduct a short-term residential rental use. Prerequisites to zoning permit approval would include:
  - Confirmation from the <u>Virginia Department of Health (VDH)</u> that the existing onsite sewage disposal system will support the proposed maximum occupancy (transient guests and residents of the lot).
  - Confirmation from the <u>Clarke County Building Department</u> that the use will comply with building code requirements.
  - Issuance of a business license by the <u>Clarke County Commissioner</u> of the Revenue.

# **Review Process Summary**

- Applicant files short-term residential rental zoning permit application including:
  - Identification of the proposed dwelling or dwellings on the lot to be used for rental activities.
  - Proposed maximum occupancy for each dwelling to be used including transient guests and residents.
  - Information on the onsite sewage disposal system(s), if available.
- Zoning Administrator reviews application for compliance with short-term residential rental regulations.

#### **Review Process Summary (cont.)**

- Zoning Administrator forwards the application to the Virginia Department of Health (VDH):
  - VDH staff reviews the proposed maximum occupancy against information on file for the onsite sewage disposal system.
  - VDH staff confirms whether information is available to determine conformance to the approved maximum capacity of the system.
  - If information is not available or shows the proposed maximum occupancy will not conform to the approved system capacity, the Zoning Administrator will not approve the zoning permit.
  - Applicant will need to work directly with VDH to identify system capacity – may need to upgrade system capacity or reduce proposed maximum occupancy to a level that can be confirmed by VDH.

## **Review Process Summary (cont.)**

- Zoning Administrator forwards the application to the County Building Department for building code compliance review.
- Confirmation from both VDH and the Building Department are required in order for a zoning permit to be issued.
- Issuance of a business license from the Commissioner of the Revenue Office is also required.
- For the life of the rental use the applicant is required to:
  - Maintain the onsite sewage disposal system in accordance with VDH regulations.
  - Maintain the business license in good standing.
  - Notify the Zoning Administrator of any future changes to the rental use, maximum occupancy, or approved accessory activities.

#### **Prohibited Activities**

- Prohibited activities at a short-term residential rental use would include:
  - Provision of meals to transient renters (may be allowable as a home occupation bed and breakfast).
  - Commercial public assembly activities such as special events, live music, weddings, meetings, conferences, and reunions (may be allowable with approval of a <u>special use permit and site</u> <u>development plan</u> for a minor commercial public assembly use, <u>zoning permit</u> for agritourism activity, or <u>special event permit</u>).
  - Other gatherings of persons that are not transient renters or residents of the single-family dwelling, minor dwelling, or tenant house being used for rental activities – necessary to ensure compliance with maximum occupancy limits during rental periods.

## **Changes to Home Occupation Bed and Breakfast Use**

- Maximum occupancy would be increased from three (3) guest rooms and five (5) transient guests to five (5) bedrooms and ten (10) occupants including transient guests and residents of the lot.
- Home occupation bed and breakfast uses are approved by zoning permit with the following changes to the prerequisites:
  - Confirmation from the Virginia Department of Health (VDH) that the
    existing onsite sewage disposal system will support the proposed
    maximum occupancy (transient guests and residents of the lot).
  - Confirmation from the Clarke County Building Department that the use will comply with building code requirements.
  - Issuance of a business license by the Clarke County Commissioner of the Revenue.
- Maximum occupancy may be further limited by onsite sewage disposal system capacity or building code requirements.
- Rentals are permitted in a single-family dwelling, minor dwelling, or tenant house on the lot.

# **Changes to Country Inn Use**

- Maximum occupancy period would be increased from 14 consecutive days to less than 30 consecutive days.
- Maximum occupancy would remain unchanged at 15 rooms but may be further limited by:
  - The onsite sewage disposal permit issued by VDH
  - Maximum occupancy as permitted by building code requirements

## **Application and Enforcement**

- Proposed short-term residential rental regulations can be applied to existing operators who:
  - · Do not have written zoning approval, or
  - Have an approved business license application noting "no zoning approval required" or similar language written by Planning Department staff
- The proposed regulations if adopted would be applied to existing operators subject to the Department's complaint-basis enforcement process.
- To encourage voluntary compliance, Staff recommends the Board direct Staff to <u>delay enforcement for a period of six months</u> to establish a "grace period."
- The delay would allow Staff to work with existing operators without having to consider them to be in a state of noncompliance at the onset of the regulations.
- As a further incentive, Staff recommends that the Board allow the \$100 zoning permit fee to be waived for operators that apply for zoning permits during the six-month grace period.

# **Staff Recommendation**

- Staff has no outstanding concerns with the adoption of this text amendment.
- Staff supports the concept of delaying enforcement for six months to provide a "grace period" for existing operators to comply.
- Staff also recommends waiving the \$100 zoning permit fee during the "grace period."

Chair Weiss opened the Public Hearing at 6:47 pm.

The following person appeared to address the Board:

- Ruth Almeter of White Post, VA

- o Has been operating a short-term rental for just over one year.
- Feels it is good for the local economy because she sends her guests to the local businesses.
- Estimates her short-term rental has 5-8 guests per month in her three bed, two bath cottage and advertises it as eight beds.
- o The biggest concern was the septic fields and overcrowding of houses.
- In the year she has been open, she has only had one group stay, which was at her maximum advertised occupancy.
- Fully booked 200-days a year; offered the opinion a family living there
   365-days a year will put more stress on the septic system than her maximum days booked each year.
- Opined there were too many regulations and doesn't want to see Clarke County turn into Loudoun County.
- Would like to see Clarke County stay a low regulation county.

Chair Weiss closed the public hearing at 6:52 pm.

#### **Supervisor Matthew Bass**

- Thanked Staff and the Planning Commission for all their hard work on this project.
- Noted the Board had previously brought up the concern of over-regulation and agrees, in general, it is not a good principle of community management.
- With that said, the Planning Commission, in collaboration with Staff, fleshed out legitimate issues with regard to the health and safety of our community.
- Feels the regulations as proposed are appropriate and think they are necessary.

#### Vice-Chair Terri Catlett

- Asked when the discussion first began? Brandon Stidham stated the Planning Commission began working on this in 2019, adding there had been previous discussion on the topic.
- Thanked Staff for all the work, adding that Staff has been working on this for a long time and exploring all the different options.

#### Supervisor Doug Lawrence

 Opined if we are taking money from people visiting Clarke County, it is our responsibility to ensure it is as safe as possible. This does that without being too intrusive.

#### Supervisor Bev McKay

- In the past, the Board has had no regulation. One of the big reasons is what it is, is there have always been reasonable regulations, reasonable sewage disposal regulations, reasonable well regulations and feels this is along the same line as a reasonable amount of regulation.
- Having a septic system that functions and not overpopulating a house is a reasonable regulation.

#### **Chairman David Weiss**

 Believes this is a reasonable compromise, makes everyone have to be in compliance with the drain fields, and is comfortable moving ahead.

Supervisor Bass moved to adopt proposed text amendment TA-21-03 (Short-Term Residential Rental, Home Occupation Bed and Breakfast, and Country Inn) as presented by Staff in the report dated February 15, 2022. This motion includes direction to Planning Staff to create a "grace period" for existing operators to work with Staff to comply with the new regulations. The "grace period" would be for a period of six months to conclude on August 15, 2022, and would consist of 1.) Delayed enforcement of the new regulations and 2.) Waiver of the \$100 zoning permit fee for all applications filed during the grace period. The motion carried by the following vote:

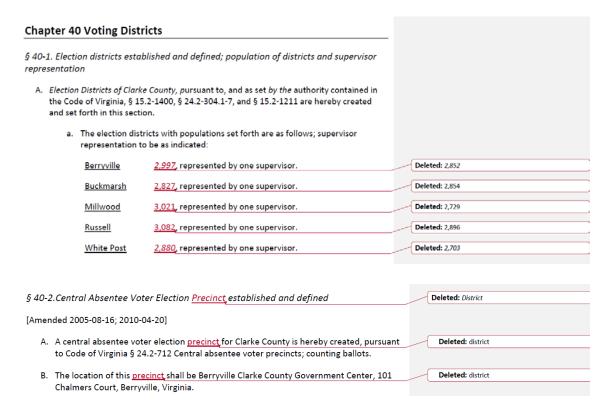
19) PH2022-04 Code of Clarke Chapter 40 Voting Districts Text Amendments

Chris Boies presented the following changes to Chapter 40 Voting Districts, Code of Clarke County.

The Board was presented information at their January 11th work session,
 which showed that no changes to the current election districts were required

due to the 2020 Census population update. The Board decided not to change the election district boundaries based on that information. The Board authorized a public hearing at their January 18th meeting on required code changes to Chapter 40 of the Code of Clarke. The public hearing has been set for February 15th at 6:30, or as soon thereafter as the matter can be heard.

There are two sections of Chapter 40, Voting Districts, proposed to change. The first amendment is to §40-1, which contains the populations for each district. Gordon Russell provided this data using Census block data. The second change is a technical correction to §40-2, which is currently incorrectly labeled a "voter election district" and is being changed to the correct description of a "voter election precinct." Code of Virginia §24.2-712 allows the governing body to establish one or more central absentee voter precincts for the purpose of receiving, counting, and recording absentee ballots cast in the county. The proposed changes are highlighted in the attached document.
