#### 3) Citizens Comment Period

<u>Bruce Anderson</u> read the following letter, addressed to the Virginia Department of Transportation:

The purpose of this letter is to request that VDOT revisit current speed limits along Highway 723 (Millwood Road) from the intersection with Highway 50 to Millwood Town, install signs warning drivers of equestrian activities and possibly take other actions to assure the health and safety of residents, horses and others for the following reasons.

After purchasing a small horse farm on the corner of Tilthammer Mill Road and Millwood Road approximately three years ago, my wife and I have been impressed with the efforts made by VDOT to preserve the health and safety of residents and livestock, and to establish and maintain safe driving conditions in virtually all the small towns in Clarke County, including Millwood, Boyce, Berryville, and other nearby townships. Presumably, conservative speed limits have also been established in recognition of the importance of maintaining the rural character and intrinsic historic value of these towns along with obvious need to protect the health and safety of residents and others. Millwood Road is a historic and registered scenic road.

Millwood Road was historically a major roadway—perhaps the only good road—for travelers heading East and West across the Shenandoah River through Ashby Gap before Highway 50 was constructed. Highway 50 was presumably constructed to adjacent to Millwood Road to accommodate the growing population in Winchester and the surrounding towns. In my view, Highway 50 is well-designed and maintained thanks for your diligent efforts. Highway 340 intersects Highway 50 at Waterloo and is also well-maintained that safely accommodates vehicles that travel at speeds up to 55 mph in many places. Speed limits on both highways are reasonable given the driving conditions. Unfortunately, Millwood Road now serves as a "shortcut" for many commuting to and from Boyce or Berryville eastward. Indeed, only a very small percentage (<10 percent) of the traffic on Millwood Road is being used by local residents and patrons of local businesses. Alternatives, such as Highways 50 and 340, exist for those simply wanting to get from one destination to another as quickly as possible.

The traffic has increased dramatically along Millwood Road in recent years but most of the activities, including equestrian activities, in the area remain the same. This creates conflicts and dangerous situation that needs to be resolved. In other historic places in Clarke County, particularly those with intensive equine activities, speed limits have been dramatically reduced in recognition of the often unpredictable and difficult nature of horses. A number of active equine facilities are located along Millwood Road between Highway 50 and Millwood Town. These include Sandstone, which hosts riding lessons for young riders on a daily basis and equestrian events, and Fairview, a well-known dressage training and boarding facility. Although wide grassy shoulders currently exist between the pavement on Millwood Road and fences of most neighboring properties, most riders find speeding cars an unacceptable life threatening risk. Unfortunately, many drivers are unaware of the hazards posed by equestrian activities and are inattentive despite living in the heart of "horse country".

Numerous incidents have occurred even since we moved to our farm on Millwood Road putting the lives of riders and their horses in grave danger. Virtually everyone who has ridden along Millwood Road can recount situations where their horses were startled, reared, bolted and or otherwise reacted badly to speeding vehicles. Currently, the speed limit along most this stretch of Millwood Road is posted at 45 mph. As most know, vehicles then often drive at speeds up to 55 mph without worrying about being pulled over by an officer and being ticketed. Most roadways in and on either side of small rural towns in Clarke County have speed limits of 35 mph or less and many do not have the active equestrian activities found along Millwood Road today.

It bears mentioning that, in addition to horses, other animals including deer and other animals that live in the forested areas along Millwood Road are also often hit by vehicles. Although the road is reasonably straight, hills, trees and other physical features make it difficult to see deer and other animals until it is too late. As you know, these collisions can be serious even fatal for occupants in the vehicle and, of course, for the animals that are struck.

In view of the situation described above, it is recommended that VDOT:

- 1. Undertake a study to determine the speed that drivers are travelling on Millwood Road from Highway 50 to Millwood Town.
- Based on the results of the speed study on Millwood Road, re-evaluate traffic patterns and consider reducing speed limits from Highway 50 to Millwood Town recognizing that drivers often exceed posted limits by at least 10 mph.
- 3. Post permanent signs from Highway 50 to Millwood Town to warn drivers of equestrian activities;
- 4. Install a radar system at least temporarily to inform drivers of their current speed and to warn drivers if they exceed posted limits, similar to what exists along Highway 17 (near Paris); and

5. Consider taking other traffic calming measures to assure that residents, visitors, riders and other safe not at unreasonable risk from motorists travelling on Millwood Road.

Thank you in advance for your consideration of this request.

#### 4) VDOT Update

On behalf of VDOT Residency Administrator Edwin Carter, Wayne Tapscott provided the following update on maintenance activities:

- Began mowing operations and will complete the first round this month.
- Made shoulder repairs on Raven Rocks Rd, will continue making shoulder repairs on Routes 7, 50, and 340.
- Completed ditching operations on Clifton, Allen, and Lewisville Rd, will begin Wickliffe Rd this month.
- Started asphalt patching and leveling on Crums Church Rd and will complete this month, will be paved next year from Longmarsh to Old Charles Town Rd.
- Contractor completed asphalt patching on Route 50 and Mt Carmel Rd, and surface treatment on Kimble, Stringtown, Allen, and Old Charles Town roads.
- A concrete contractor completed gutter pan repairs on Route 7 Mountain from Ebenezer Rd eastbound.
- Contractor will complete tree trimming on Pine Grove Rd.
- Will be pipe cleaning on various routes, the pipe flushers will be coming back.

### Supervisor McKay

- Observed that the asphalt patching on Route 50 was done well, the patches are visible but cannot be felt.
  - Wayne Tapscott replied that they will be lining the roads when repairs are completed. They are also trying to complete ditch work and other repairs to the berms before the asphalting is completed.

#### Vice Chair Catlett

 Requested that the citizen comments regarding speeds on Millwood Road be shared with Ed Carter.

# Supervisor Lawrence

- Advised that there are two "no center line" signs still up in the 1500 block of Old Charles Town Road, even though center lines are now present.
- Further advised that there some areas of shoulder erosion to be addressed on Route 611.
- Asked what the bridge on Pierce Road will look like when completed.
  - Wayne Tapscott replied that it will be beautiful and he is fairly sure the bridge will be two lanes.

 Suggested that the large walnut tree right next to the road on the northwest corner, it may become a hazard if the bridge becomes two-lane, it may be a good idea to remove the tree while the road is closed.

 Wayne Tapscott responded that he would follow-up with the bridge crew about it.

### Chairman Weiss

- Requested that Ed Carter provide the following to the Board: (1) information about the cost of speed studies and how they are funded (2) a timeline for lengthening the deceleration lanes on the mountain.

# **WEBSITE**

In 2018, Clarke County contracted with Granicus to develop a new, user-friendly website, and the PIO took the lead on the project with support from the county's technology department. The site launched Feb. 3, 2020, and the PIO manages most content: creating new pages as needed, uploading documents, updating content, maintaining the web calendar, posting weather-related closures when necessary, etc.

On March 3, 2020, the PIO added a "COVID-19 News in Clarke County" page that was updated every day for two years. As of April 4, 2022, the page is updated each Monday.

On July 15, 2020, the PIO added a COVID-19 "Resources for Individuals & Businesses" page. This page is updated as new resources are offered or are expired.

The PIO serves as primary administrator of the **Clarke** County, Virginia Facebook page that has 8,072 followers as of June 20, 2022.

Weekly content includes "Pet of the Week," "Throwback Thursday," "VDOT Alert," "Coming Up in Clarke County," and (new in 2022) "Friday Featured Job." Posts also include news, public hearing notices, emergency notices and weather-related closings, beautiful photos of the county, and special notices as needed for Berryville, Boyce, and Berryville Police Department.

PIO is an admin for all official Clarke County Facebook pages (see list at right); however, primary page admins manage their own pages. PIO provides content or support when asked.

PIO monitors other Clarke-related community Facebook pages for potential news as well as issues of concern.

PIO is content creator for the "Clarke County, Virginia" YouTube channel (238 subscribers as of June 20).

PIO manages the county's ArchiveSocial account and, in 2018, developed the county's Social Media Policy for employees.



#### RESOLUTION HONORING MARY "VIOLA" ROBERTS LAMPKIN BROWN 2022-08R


WHEREAS, it is with deep sadness the Clarke County community notes the passing of Mary Viola Roberts Lampkin Brown; and

WHEREAS, Mary Viola Roberts, who was always known as Viola, was born on Oct. 4, 1911, in Hume, Virginia, and moved to Clarke County with her parents in 1918 to work as laborers and domestic service workers at Springfield Farm in Webbtown; and

WHEREAS; Viola married John Lampkin in 1936, and they built their home in Josephine City south of Berryville where they raised their family; and

WHEREAS, Viola continued to work as a cook at grand homes in Clarke County throughout most of her life; and

WHEREAS; after John Lampkin's death in 1982, in 1988 Viola married The Rev. Paul Brown, who died ten years later; and



WHEREAS, throughout her remarkably long and healthy life she maintained a daily routine that included spiritual reflection and focused her love and attention on others, including her ever-growing family; and

WHEREAS, as a Clarke County resident for most of her 110 years, Viola Brown witnessed profound cultural and civic changes throughout the county, across the nation, and around the world; and

WHEREAS, Viola Roberts Lampkin Brown died May 21, 2022, in her Josephine Street home where she lived for 86 years and is buried in Milton Valley Cemetery not far from her home,

NOW, THEREFORE the Clarke County Board of Supervisors does hereby honor the memory of MARY "VIOLA" ROBERTS LAMPKIN BROWN for the extraordinary and exemplary life she led that is forever part of Clarke County's history.

2022-06-13 Summary: At 9:58 am, Chairman Weiss called the meeting to order.

A. Rt. 7/Rt. 601 Discussion: Adam Campbell, Staunton District Planner for VDOT, provided the Board an update on the options being considered to improve safety at the intersection of Route 7 and Route 601. VDOT received public comment on the improvement alternatives at a public information meeting on May 10 and during the two-week public comment period after. Based on feedback received from citizens and the Board, VDOT developed a proposed interim alternative, which was presented to the Board in the following presentation. No action was taken.









- Held the evening of May 10th at Blue Ridge Volunteer Fire Station
- Well attended with approximately 50 participants
- VDOT Staunton, VDOT NOVA, Clarke County and Loudoun County staff were in attendance
- Meeting format was a 30 minute presentation followed by question and answer



- · Speeding is the primary issue
- Increase in traffic related to newer land uses significantly compounded the intersection issues
- · Corridor issue (need is larger than the study intersection)
- Proposed U-turn movements are a significant concern due to the steep grades
- · Concerns about heavy vehicle access
- Several attendees indicated they already use downstream U-turns during congested times



#### **Public Comment Summary**

- 16 individuals submitted comments by email during the public comment period
- 75% of respondents confirmed the identified intersection needs with 56% specifically mentioning speeding
- 25% of respondents indicated concerns with all proposed alternatives and associated U-turn movements
- Concerns over heavy vehicle movements, the need to evaluate the entire corridor, and drivers already making downstream U-turns were meeting topics re-enforced by the submitted comments



#### **Public Comment Summary**

Of the three alternatives, 19% indicated the Alt 1: RCUT and 19% indicated the Alt 3: Hybrid Option as their preference


- Loudoun County Transportation staff indicated that the Alt 1: RCUT with bulb-outs and acceleration lanes for both U-turns is their preferred alternative
- · Other improvement ideas submitted in comments:
  - · speed feedback signs
  - · roadway lighting
  - · increased enforcement
  - downstream signals to create gaps in Route 7 traffic
  - · no passing zone at top of mountain
  - improve deceleration lanes along Route 7
  - designated northbound Route 601 right turn lane




#### Alt 1: RCUT Interim Concept

- Based on public feedback, VDOT considered a new interim alternative that could set up a future RCUT intersection
- Interim concept would maintain full access at primary intersection, but make voluntary U-turn movements more attractive and safer during congested periods
- Interim concept would provide a new Route 601 northbound right turn lane and improve downstream Route 7 left turn / U-turn lanes to provide storage and deceleration length
- Signage for "Alternative Route" could be considered to further encourage U-turn movements during congested periods
- The Route 601 northbound right turn lane would serve the dominate approach movement (72% AM, 55% PM, 76% Weakend)

- Will reduce Route 601 NB queue lengths and improve delay for right turning vehicles, but minimal delay improvement for left turns without voluntary diversion
- Will have a minimal impact on intersection safety based on Crash Modification Factors and no reduction of conflict points without voluntary diversion
- Will result in less Smart Scale scoring potential (safety), but also result in a lower Smart Scale request (planning level estimate = \$1.5 to \$2.0 million)
- Should Park and Ride elements be considered in Smart Scale application? Route 7 right turn lane extensions?

B. Request from the Town of Berryville for a Resolution of Support for SMART Scale funding for improvements to East Main Street: Christy Dunkle, Community Development Director for the Town of Berryville, presented the Town's proposed improvements to East Main Street between the Norfolk Southern Railroad tracks and Jack Enders Boulevard and between Jack Enders Boulevard and Battletown Drive: constructing curb, gutter, and storm sewer, with minor lane widening on both sides, constructing a sidewalk along the north side, and milling and overlaying the existing pavement. With

support from the Board, the Town previously submitted a SMART Scale application for this project in 2018, which was not funded. The Town is submitting a new SMART Scale application for this project and requests that the Board execute a Resolution of Support. The application deadline is August 1, 2022. The Board asked questions and decided to move the Resolution of Support forward to the June 21<sup>st</sup> meeting.

At 10:57 am, Chairman Weiss adjourned the meeting.

- The application deadline is August 1, so the Board needs to vote on a Resolution of Support at the July meeting.
- Staff has reached out to Loudoun County, who advised that they have recommended three other changes to the proposed plan. VDOT had not included these changes because they would hurt the SMART Scale application scoring.
- Loudoun County's proposed changes include additional acceleration lanes and extra lanes at the U-turn sites to make merging easier.
- Clarke Staff has suggested that Loudoun County use the \$500k that has already been set aside towards this project, which would help the application's scoring. Staff from Loudoun County should respond within a week or so.
- Staff can draft a Resolution of Support for the SMART Scale application, but advises that the Resolution should specify the alternatives that the Board supports.

#### Vice Chair Catlett

- Requested clarification about the additional lanes and application scoring.
  - Supervisor Lawrence explained that Loudoun suggests adding acceleration lanes for the merge onto Route 7 from Route 601, and for each of the U-turn areas.
  - Chris Boies added that including more acceleration lanes, per Loudoun County's recommendation, does not produce an increased safety factor that justifies the cost, according to VDOT's models.

#### Chairman Weiss

 Advised that the Board needs to determine if it supports any of the suggested alternatives.

#### Supervisor Bass

Opined that Loudoun County's suggestions seem reasonable.

#### Vice Chair Catlett

Stated that Loudon's suggestions seem to address the grade issues.

 Chris Boies clarified that Loudoun County Staff favored the new alternative with the inclusion of their suggestions.

## **Supervisor Bass**

- Asked if the timeframe would allow VDOT to consider Loudoun's suggestions as another alternative.
  - O Chris Boies responded that the Board can ask for Loudoun's suggestions to be added to the plan, but cannot predict how that would affect the SMART Scale scoring. However, adding local money would help the score, so Loudoun appears to have some advantage there.

#### Chairman Weiss

 Observed that Ed Carter has indicated VDOT has spent a lot of money on this issue already and cannot continue to look at alternatives forever, but that seems to be a flawed message because it is a complicated issue and it is their job to solve it.

#### **Supervisor Lawrence**

 Concurred and added that changing the traffic patterns without adding proper acceleration lanes could result in greater issues in the future.

#### **Chairman Weiss**

- Summarized that the most recent alternative seems to make the most sense, but that the Board would agree with Loudoun County staff that acceleration lanes are critical to the overall functionality.
  - Chris Boies advised that staff will coordinate with Loudoun County and VDOT to add those components. The Board will discuss the matter at the July work session and vote on it at the July 19 regular meeting.

#### Chris Boies continued the 2022-06-13 Summary:

 The Town of Berryville is requesting a Resolution of Support from the County for the Town's own SMART Scale applications for improvements to East Main Street.

## **Supervisor Bass**

 Read the following statement, since edited lightly for grammar and syntax, into the record:

"One of the perks of being on the Clarke County Board of Supervisors is that we often get to recognize achievements throughout our community. The Board's recognition of our two State Champions this year, in Girls Cross Country and Boys Soccer, inspired me to write an open letter – read into the Board's record during its public hearing on June 21 – addressed not only to those two remarkable teams, but to the echoes of Eagles past, the glory of Eagles present, and the dreams of Eagles future. It goes something like this:

To this day, I vividly remember my friends and I pretending to be the great Eagles basketball players of the early 1990s on playgrounds and backyard courts across the county. In those days, a District Championship was huge — much less a State Championship — which made those deep playoff runs through Regionals and into States by our childhood idols that much more special. Later that decade, the Clarke County Boys Soccer program produced an iconic group that went on to win the State title. Witnessing that season from the jam-packed stands was an indelible experience.

Several years later, I was lucky enough to be part of Eagles baseball teams that made deep pushes into the State tournament. And while we ultimately fell short of the grand prize, the memory of widespread community support – embodied in hundreds upon hundreds turning out for epic rivalry games against arch nemesis Strasburg in the District and Regional tournaments— is something I'll never forget.

There are few phenomena that unite a community's voice like support for our youth. Over the last couple decades, our youth sports programs have flourished, producing unparalleled results, even as school and district sizes and classifications have changed more rapidly than in years past. In many ways, however, Clarke County is still the little engine that could. Comparatively small, with fewer high-level competition opportunities than more densely populated areas, this little community has that intangible quality that can propel its people to great heights – that quality is Heart.

The cliches abound, but not without good reason. It's not the size of the dog in the fight, but the size of the fight in the dog. Growing up here has taught me that this county is uncommonly chalk full of it. That's why it warms my heart and inspires my Eagles spirit when I see our young people succeed at such a high level.

On that note, I understand that this year has been particularly special for Clarke County Athletics. In addition to the state championships

for Girls Cross Country and Boys Soccer that the Board recognized, the Football team won the District Championship in the fall, as did the Girls Soccer team this spring. All contributed to Clarke winning the Battle of the Bull Run, which is a points competition based on how well varsity teams do throughout the year. Athletic Director Casey Childs believes Clarke may have set a record for total points scored in the competition. He called it a "tremendous year" for the athletic program.

To me, this success is a reflection on the community as whole. It reflects on the parents who sacrifice to make sure our kids get to practice on time; the kids working hard at those practices; our Parks & Recreation staff who maintain fields of play; those who participate in coaching; those who fill the sidelines; and (especially) those who bring the snacks and drinks. And it's the families who come out to vigorously support their Clarke County Eagles wherever they play, just as they've done for decades — so that the next generation of Eagles has those same role models to look up to, just as I did some thirty years ago.

To our Eagles student-athletes, I say this:

Somewhere out there is a child pretending to score that game winning goal or cross that finish line first, and they might just be saying your name as they do it. Remember that as you take your next steps in life, whether you've just graduated or are coming back next season. Continue to exemplify the best Clarke County has to offer, just as you've done this season. Never forget that you are part of the little engine that could. That mentality will set you apart in larger crowds moving forward, just as it did in this season of your lives that you will never forget. The Board wishes each of you the best of luck. Congratulations — and enjoy your Summer!"

### 19) 2 for 2 Foundation Presentation

Lynda Tyler, Chair of the 2For2 Foundation, presented the following via a prerecorded video:

- The foundation is trying to raise money to build two different facilities in the area, a swimming facility worthy of all types of competition, and an icehockey/ice-skating facility.
- This is not just another pool or sheet of ice; the foundation places heavy emphasis on swim literacy, education, and what the community can come together to do inside these facilities.
- The foundation is an all-volunteer group, is registered with the State, and complies with all IRS regulations as a 501(c)(3) organization.
- The 2For2 Foundation has researched many different types of models to find workable frameworks that benefit all: the first is all-public, where one or more governments use tax revenues to build the facilities on their own. This

is not palatable, nor does it fit the mission. Another model is all-private, which unfortunately carries an obligation to the investors and places emphasis on profit. This is not what the Foundation wants, as it excludes the under-served and differently abled citizens. Fees are typically higher than they would need to be if run in the public sector and the programming would not be as broad. Another option is public sector ownership with private management. This would also increase taxes, could cut revenues to governments and can lead to exclusive programming policies.

 A model that the Foundation likes and thinks fits best for all involved is the Private/Public Partnership. This involves private funding, matched with public programming including localities in the Northern Shenandoah Valley area.
 This fits models best, by serving the most residents in the most cost-effective manner.



# **Three Major Components of Cost**





### Land



- Proposal: Use existing land owned by or available to the concerned governments
- One developer is "interested and excited" to pursue the possible donation of 17 acres near Middletown
- · But the process must move forward now to make this a reality

# **Operating Costs**



- Includes facility cost, personnel, maintenance, and required capital maintenance
- Costs are reduced by Joint Pool-Rink facility due to common use of hot water, personnel, etc.
- Initial design should focus on lower operating costs and potential revenue-producing activities
- Operating Revenue exceeds Operating Costs in similar facilities across the country
- Specific proposal and feasibility study will address Operating Costs in detail

## **Initial Building Costs**



- · Actual All-in Cost of Joint Facility will depend on many factors unknowable at this moment
- Based on similar facilities, anticipated cost is \$50 to \$70 Million
- Question: Can This Be Raised Privately, With No Net Cost to Government?
- Answer: YES! This can clearly be raised over the life of the facility, with 30% raised initially - if we start now.

# How Will the Private Money be Raised?



- · Community Outpouring of small donations
  - Kids, Parents, Older Citizens have all shown great willingness to support
  - "Ice Cream Cone" and "Ice Cream Sandwich" world records slated to raise over \$1,000,000
  - · Reflects strong community support
- · Community Business Support
  - · Existing Pledges show strong support
  - · In-kind contribution can help all along the process
    - · E.g., Donation of needed Land or ALL concrete required for the facility
- · Naming Rights and internal advertising bring in significant amounts
  - One business is discussing overall facility naming rights for 10% of the facility costs

# How Will the Private Money be Raised? (cont.)

- · Federal & State Grants can be significant
  - · At this time, many programs have money looking for worthy uses
  - · 2FOR2 can help identify and apply for likely grants
  - · Appears likely that a \$3 million federal grant may become reality
- · Many larger donors are ready to contribute if the project can become reality
  - We have statements of commitment from donors in the \$2,000 to \$20,000 range
  - We have indications of commitment for donors of \$1,000,000 or more
- · If the facility actually moves forward with government support, initial contributions thru 2FOR2 will likely exceed 30% of the building costs

#### **How to Proceed?**



- · Statement of governmental interest in moving forward
  - · Shared vision among municipalities
  - · Permitting municipal organizations/staff to work together and with 2For2
- · Determine best way to coordinate among municipalities
  - Perhaps use existing inter-governmental structures, such as Lord Fairfax Community College as a funding aggregator
- Willingness to consider issuing government bonds to cover the initial building costs while fund raising catches up to outlays
- Your participation unlocks the private funds that will make this a reality!

#### Chairman Weiss

- Asked how large the Foundation Board is and how long they have been working on this project.
  - Ken Kempson responded that there are 5 members now and they are expecting to have 9 members by the end of December; they have been working on the project for less than a year.

#### Supervisor Lawrence

- Asked what kind of working group the Frederick County Board of Supervisors set up for this project.
  - Ken Kempson and Diana Hackney, the Foundations pro-bono consultant, answered that the Frederick County Board of Supervisors have so far permitted the Foundation to talk with their County Administrator as well as with individual departments.

#### Vice Chair Catlett

- Inquired if the Foundation would work on building both an ice-skating rink and pool at the same time.
  - Ken Kempson answered yes, subject to the feasibility study, the concept is to build a joint facility. This is efficient, as heat generated from the ice rink is used for heating the pool.

#### Supervisor Bass

 Thanked the Foundation for the presentation and advised he would be curious if there were other potential locations, other than Middletown.

#### Supervisor McKay

- Inquired what counties the Foundation envisions participating in this project.
  - Ken Kempson replied that is part of the feasibility study aspect. Frederick County, Clarke County, and the City of Winchester would be a good start, with the potential to maybe include Warren and/or Shenandoah counties as well.

#### Vice Chair Catlett

Observed that the community is so small that the only way for the County to pursue this type of endeavor would be in a partnership and added that she is interested in hearing the results of a feasibility study.

#### Supervisor Lawrence

 Advised that he is in favor of the regional approach and that the project carries a lot of benefits.

#### Chairman Weiss

 Agreed that it is a worthy goal and a good model, with the caveat that staff's time is valuable and limited; Board would like to be kept informed of the time staff spends on the project.

By consensus, the Board agreed to permit staff to work with the Foundation to determine the feasibility of the project.

  Units (CFUs) per 100 ml of water sample.

### Why Monitor Water Quality?

ONE OF THE FIRST, AND MOST IMPORTANT STEPS TO UNDERSTANDING THE THREATS TO CLEAN WATER IS TO MONITOR THE STREAM WATER QUALITY TO IDENTIFY TRENDS BEFORE THEY CAN HAVE AN ENVIRONMENTAL IMPACT.

- ≻Fill data gaps
- >Assess health of local streams
- Documents changes in stream health over time
- > Prioritize sites for restoration efforts
- Document success and challenges of restoration efforts
- Discover and document acute pollution problems



### Why Do We Test for Nutrients?

#### POSITIVE

- All living organisms require nutrients

## Why Do We Test for E. coli Bacteria?

Finding E. coli bacteria in the water indicates recent fecal contamination and possible presence of other disease-causing microorganisms or pathogens


As the level of E. coli increases, potential health risk from exposure to pathogenic organisms also increases

➤ Possible health effects:

- Gastrointestinal illnesses
- Urinary tract infections
- Respiratory infections
- Conjunctivitis (pink eye)
- Exposure to open wounds can cause wound infection

  Exposure to open wounds can cause wound infection

  In rare causes, type of kidney failure called hemolytic uremic syndrome








#### FOSR's Water Quality Data for Sites FC01 and FC08



Sites FC01 and FC08 are included in FOSR's Summer E. coli Testing Program at Public Access and recreational Sites





### Clarke County Board of Supervisors June 21, 2022 Meeting

#### **PUBLIC HEARINGS**

- <u>TA-22-01</u>, Unpaid Taxes and Charges
- <u>TA-22-02</u>, Mergers and Dwelling Unit Right (DUR) Accounting

#### TA-22-01, Unpaid Taxes and Charges

- Add a new Subsection E to Section 2.3 (Issuance of Permits and Approvals) of the Zoning Ordinance (Code of Clarke County Chapter 200, Article I)
- Purpose is to require payment of all delinquent real estate taxes, nuisance charges, and any other charges that constitute a lien on a subject property prior to acceptance of an application associated with that subject property.

#### TA-22-01, Unpaid Taxes and Charges (cont.)

- Currently no mechanism exists to authorize County staff to refuse to accept and process land development applications for a property from an applicant that has unpaid debts owed to the County and related to that property.
- Denying access to County services can be an effective tool to collect unpaid debts.

#### TA-22-01, Unpaid Taxes and Charges (cont.)

- Code of Virginia 15.2-2286(B) allows zoning ordinances to require applicants to prove that there are no unpaid debts owned to the locality that would constitute a lien on the property as a prerequisite to filing certain applications for the same property.
- · Examples of debts include:
  - · Delinquent real estate taxes
  - · Nuisance charges
  - · Other unpaid charges that constitute a lien on the subject property
- 15.2-2286(B) also contains enabling language that would extend authority to land disturbance and building permit applications – governed by other sections of the Code of Clarke County.

#### TA-22-01, Unpaid Taxes and Charges (cont.)

- · Proposed text amendment follows the language of 15.2-2286(B)
- · Would apply to:
  - All applications and review processes in Zoning Ordinance Section 6
  - Land disturbance permits issued in conjunction with County Code Chapter 148
  - Building permits issued in conjunction with County Code Chapter
     71
- The unpaid tax or charge must apply to the property for which the application is being filed – cannot be applied to other properties owned by the applicant.

#### **Planning Commission Recommendation**

- Following a duly advertised public hearing on May 6, 2022, the Commission voted to recommend adoption of the proposed text amendment.
- · There were no speakers at the public hearing.

#### Staff Recommendation

 Staff has no outstanding concerns with the adoption of this text amendment.

22) PH2022-14: TA22-02 Mergers and Dwelling Unit Rights Accounting

Brandon Stidham presented the following:

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting

- Amend Section 3.8 (Vacation or Merger of Lots in the AOC and FOC Districts) of the Zoning Ordinance (Code of Clarke County Chapter 200, Article I).
- Purpose is to clarify that, following reallocation pursuant to Zoning Ordinance Section 3.2 (Allocations), no lot resulting from a merger of lots shall have more dwelling unit rights (DURs) than the total number of dwelling unit rights that were assigned to the lots at the time of merger plat application filing per Section 4.2.3 (Merger) of the Subdivision Ordinance (Code of Clarke County Chapter 200, Article II).

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting (cont.)

- Zoning Ordinance Section 3.8 When lots are merged or vacated, the DUR accounting for the merged or vacated lot shall be based on the DUR allocation table in Section 3.2 and <u>not</u> the total number of DURs that were assigned to the merged or vacated lots.
- A merger of lots can result in the <u>loss or gain</u> of DURs through compliance with the allocation table.

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting (cont.)

- · Example of loss -- merger of two lots:
  - Lot A 100 acres, 4 DURs
  - Lot B 100 acres, 4 DURs
  - · Total -- 200 acres, 8 DURs
- DUR allocation for 200 acre lot per Section 3.2 -- 6 DURs
- Property owner would <u>lose</u> 2 DURs if Lots A and B were merged.
- Merger review process was added in 2012 to advise property owners of potential DUR loss before lots are merged.

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting (cont.)

- · Example of gain -- merger of two lots:
  - Lot A 100 acres, 4 DURs
  - · Lot B 100 acres, 1 DURs
  - · Total -- 200 acres, 5 DURs
- · DUR allocation for 200 acre lot Section 3.2 -- 6 DURs
- · Property owner would gain 1 DUR if Lots A and B were merged.

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting (cont.)

- · Gain of DURs through merger is problematic.
- Original 1980 DUR allocation created a fixed number of DURs countywide – no mechanism exists to create new DURs.
- In the gain example, the additional DUR would be a new DUR in excess of the original 1980 allocation.

# TA-22-02, Mergers and Dwelling Unit Right (DUR) Accounting (cont.)

- Proposed text amendment would add new language to Section 3.8.
- No lot resulting from a merger shall have more DURs than the total number of DURs that are assigned to the lots at the time of merger plat application.
- Would be clear that no new DURs can result from the mathematical outcome of complying with the allocation chart.
- No changes are proposed to address the issue of loss of DURs through merger.

#### **Planning Commission Recommendation**

- Following a duly advertised public hearing on May 6, 2022, the Commission voted to recommend adoption of the proposed text amendment.
- · There were no speakers at the public hearing.

#### Staff Recommendation

 Staff has no outstanding concerns with the adoption of this text amendment.

#### Karen Anderson

- Asked what the advantage of merging plots of land is.
  - Brandon Stidham responded that people do it for various reasons: sometimes mergers as a part of estate planning or so that they only receive a single tax bill.

Chairman Weiss opened the public hearing at 7:32 pm.

No persons appeared to address the Board.

Chairman Weiss closed the public hearing at 7:32 pm.

Vice Chair Catlett moved to approve TA22-02, a text amendment adding language to Section 3.8 of the Zoning Ordinance to clarify that no lot resulting from a merger of lots shall have more dwelling unit rights than the total number of dwelling unit rights that were assigned to the lots at the time of merger plat application, as presented. The motion carried by the following vote:
